SECTION I - THE SCHEDULE

RFQ NUMBER S- RFQPR4476365

PRICE

The Contractor shall complete all work, including furnishing all labor, material, equipment and services required under this purchase order for the following firm fixed price and within the time specified. This price shall include all labor, materials, all insurances, overhead and profit.

Total Price (including all labor, materials, overhead and profit)

VALUE ADDED TAX

VALUE ADDED TAX (VAT). The Government will not reimburse the Contractor for VAT under this contract. The Contractor shall not include a line for VAT on Invoices as the U.S. Embassy has a tax exemption certificate with the host government.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is for procurement 5 T-Walls with delivery and installation at Kabul Despechary Gate. In accordance with the Statement of work (Attachment A).
- B. The contract will be for a six - months period from the date of the contract award, with **option of extension up to one-year.**

C. STATEMENT OF WORK

C.1 SCOPE OF WORK

C.1.1 Contractor will provide and install approximately (50 meters {40 T-Walls}) of (8 feet tall x 4 feet in length) 4000PSI T-Walls to KGU related Kabul Despechari Gate. Contractor will securely install at least a 2" thick steel cable at the top and bottom of all of the T-Walls to ensure they are secure and fall resistant.

C.1.2 Contractor will plaster all gaps and/or seams and paint the T-Walls to match surrounding structures.

C.1.3 Contractor will be required to provide the appropriate size cranes for the variety of tasks throughout the duration of this project. It is the contractor's responsibility to provide the appropriate size crane for the job required on the day of the lifts. The crane must be available every day from job commencement until completion.

C.1.4 Considering the heavy traffic on the road adjacent to the gate, the contractor will be required to bring trucks capable of movements that can also make sharp turns. 18 wheel style flatbed trucks will not be allowed. Contractor should be able to determine what size crane and trucks are needed for the job after the walk through and surveying the job site.

C.1.5 Contractor will be responsible for the delivery and manufacturing of one (1) (20') steel I-beam with a minimal 20mm reinforced rebar loop attached to the I-beam per every three T-Walls and/or at each corner.

C.1.6 Contractor will be responsible for installing the steel I-beams 5 feet below and adjacent to the concrete pad that the T-Walls will sit on. The I-beam will be secured in 2' x 2' x 5' poured concrete mixture. The contractor will be responsible for connecting steel cables from the I-beams to the top row steel cabling securing the T-Walls.

C.1.7 All materials installed on this project shall be new. Installation of used materials is prohibited.

Contractor shall provide in writing a one year warranty on all T-Walls, parts, labor and services.

C.2. General Requirements

C.2.1 The Contractor shall provide all equipment, material, tools, personnel and supervision to complete this project according to the requirements outlined in the Statement of Work.

C.2.2 The work shall be executed in a diligent manner in accordance with the negotiated firm fixed price and performance period. The period of performance from notice to proceed to completing final punch list items is 60 calendar days.

C.2.3 The Contractor shall perform all work during normal business hours.

C.2.4 If any of the Contractor performed services do not conform to the contract requirements, the Contracting Officer will require the Contractor to perform the services again until the final product conforms to the contract requirements.

C.2.5 Contractors interested in bidding on this project are strongly encouraged to attend the sites to examine the elements required by this Statement of Work as well as that of other two similar projects sites previously implemented at Pol e Charkhi and Arghandi Gates for better implementation.

C.2.6 Questions related to this Statement of Work shall be directed to the Contracting Officer, in writing.

C.2.7 The contractor shall obtain Defense Base Act insurance from a U.S. Department of Labor authorized DBA insurance carrier list at <http://www.dol.gov/owcp/dlhwc/lscarrier.htm>.

C.3. Location

C.3.1 KGU Despechari Gate, Kabul - Deh Sabz Road, East of Kabul City.

C.4. Responsibilities of the contractor

C.4.1 The Contractor will be responsible for the security of his/her tools, materials and equipment left on site overnight, on weekends, or on holidays.

C.4.2 The Contractor is responsible for job site safety throughout the duration of this project. Appropriate measure shall be implemented to protect both the Kabul Gate Unit and Contractor personnel from accidents. The Contractor must provide his/her employees with the proper personal protective equipment (PPE) to minimize accidents. Typical PPE includes hard-hats, safety glasses, full-body harnesses for fall protection, welding face shields, and any other PPE that may be appropriate. The Contractor shall promptly report all lost time accidents to the Contracting Officers or his Representative, including disabling or fatal injuries.

C.4.3 Contractor's employees and its subcontractor's employees shall abide by Kabul Gate Unit security regulations and procedures. Security personnel are authorized to search vehicles, lunch boxes, toolboxes, and persons without prior notification.

C.4.4 The contractor shall admit no one to the work location, except those individuals covered by a valid DBA insurance policy.

C.4.5 Construction activities resulting in overtime which is necessary to protect or complete the work will be to contractor's expense.

C.4.6 The Contracting Officer has the authority to issue a temporary stop work order during the execution of this project. The Contractor shall be compensated with a time extensions only if a stop work order is issued, and only for the hours that the Contractor was forced to stop work.

C.4.7 The Contractor shall keep the work site free of accumulation of waste material and other debris at all times. Disposal of excess material, waste material and other debris shall be the sole responsibility of the Contractor. Upon completing construction, the Contractor shall remove all temporary facilities, construction barriers, excess material and rubbish, and shall thoroughly clean the construction areas.

C.4.8 The Contractor shall be responsible for the professional quality, technical accuracy, and coordination of all construction activities and/or other services furnished under this contract. Omitting any part of this statement of work from the contractor's proposal will result with the contractor incurring all extra costs in order to complete this statement of work as it is written. The Contractor shall, without additional compensation from the U.S. Embassy, correct any errors or deficiencies in its construction and/or other provided services. The Contractor shall make these corrections within 72 hours after being notified of such errors or deficiencies.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. **STANDARD.** *The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.*

3. **PROCEDURES.**

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

D. INSPECTION AND ACCEPTANCE

The COR, or his/her authorized representatives, will inspect from time to time the services being performed and the supplies furnished to determine whether work is being performed in a satisfactory manner, and that all T-walls are acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

E. SUBSTANTIAL COMPLETION

"Substantial Completion" means the stage in the progress of the work as determined and certified by the Contracting Officer in writing to the Contractor, on which the work (or a portion designated by the Government) is sufficiently complete and satisfactory. Substantial completion means that the property may be occupied or used for the purpose for which it is intended, and only minor items such as touch-up, adjustments, and minor replacements or installations remain to be completed or corrected which:

- (1) do not interfere with the intended occupancy or utilization of the work, and
(2) can be completed or corrected within the time period required for final completion.
(b) The "date of substantial completion" means the date determined by the Contracting Officer or authorized Government representative as of which substantial completion of the work has been achieved.

Use and Possession upon Substantial Completion - The Government shall have the right to take possession of and use the work upon substantial completion. Upon notice by the Contractor that the work is substantially complete (a Request for Substantial Completion) and an inspection by the Contracting Officer or an authorized Government representative (including any required tests), the Contracting Officer shall furnish the Contractor a Certificate of Substantial Completion. The certificate will be accompanied by a Schedule of Defects listing items of work remaining to be performed, completed or corrected before final completion and acceptance. Failure of the Contracting Officer to list any item of work shall not relieve the Contractor of responsibility for complying with the terms of the contract. The Government's possession or use upon substantial completion shall not be deemed an acceptance of any work under the contract.

F. FINAL COMPLETION AND ACCEPTANCE

"Final completion and acceptance" means the stage in the progress of the work as determined by the Contracting Officer and confirmed in writing to the Contractor, at which all work required under the contract has been completed in a satisfactory manner, subject to the discovery of defects after final completion, and except for items specifically excluded in the notice of final acceptance.

The "date of final completion and acceptance" means the date determined by the Contracting Officer when final completion of the work has been achieved, as indicated by written notice to the Contractor.

F1.2 FINAL INSPECTION AND TESTS

The Contractor shall give the Contracting Officer at least five (5) days advance written notice of the date when the work will be fully completed and ready for final inspection and tests. Final inspection and tests will be started not later than the date specified in the notice unless the Contracting Officer determines that the work is not ready for final inspection and so informs the Contractor.

F.1.3 FINAL ACCEPTANCE

If the Contracting Officer is satisfied that the work under the contract is complete (with the exception of continuing obligations), the Contracting Officer shall issue to the Contractor a notice of final acceptance and make final payment upon:

- Satisfactory completion of all required tests,
- A final inspection that all items by the Contracting Officer listed in the Schedule of Defects have been completed or corrected and that the work is finally complete (subject to the discovery of defects after final completion), and

iii Submittal by the Contractor of all documents and other items required upon completion of the work, including a final request for payment (Request for Final Acceptance).

G. DELIVERIES OR PERFORMANCE

G.1.1 COMMENCEMENT, PROSECUTION, AND COMPLETION OF WORK

The Contractor shall be required to:

- (a) commence work under this contract within 10 calendar days after the date the Contractor receives the notice to proceed,
 - (b) prosecute the work diligently, and,
 - (c) Complete the entire work ready for use not later than 60 working days after the NTP issued.
- The time stated for completion shall include final cleanup of the premises.

G1.2 LIQUIDATED DAMAGES - CONSTRUCTION (SEPT 2000)

- (a) If the Contractor fails to complete the work within the time specified in the contract, or any extension, the Contractor shall pay liquidated damages to the Government in the amount of [Note to Contracting Officer: insert amount] for each calendar day of delay until the work is completed or accepted.
- (b) If the Government terminates the Contractor's right to proceed, liquidated damages will continue to accrue until the work is completed. These liquidated damages are in addition to excess costs of repurchase under the Default clause.

(4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing letter of credit which contains any condition or requirement against doing business with the State of Israel.

(b) Under Section 8(a), the following types of activities are not forbidden "compliance with the boycott", and are therefore exempted from Section 8(a)'s prohibitions listed in paragraphs (a)(1) through (6) above:

(2) Complying or agreeing to comply with import and shipping document requirements with respect to the country of origin, the name of the carrier and route of shipment, the name of the supplier of the shipment or the name of the provider of other services, except that no information knowingly furnished or conveyed in response to such requirements may be stated in negative, blacklisting, or similar exclusionary terms, other than with respect to carriers or route of shipments as may be permitted by such regulations in order to comply with precautionary requirements protecting against war risks and confiscation;

(3) Complying or agreeing to comply in the normal course of business with the unilateral and specific selection by a boycotting country, or national or resident thereof, of

carriers, insurance, suppliers of services to be performed within the boycotting country or specific goods which, in the normal course of business, are identifiable by source when imported into the boycotting country;

(4) Complying or agreeing to comply with the export requirements of the boycotting country relating to shipments or transshipments of exports to Israel, to any business concern of or organized under the laws of Israel, or to any national or resident of Israel;
