- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

Sensitive technology—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

- (1) Means a small business concern—
 - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
 - (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.
- (2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it

“Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127),” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

1.0 Location of Work

The work associated with this Statement of work is to be performed on the United States Embassy compound located at Rilindja Ridge Compound, Tirana, Albania.

2.0 General Requirements

The work involves removing of the old carpet and installing of the new one.

3.0 Contracting officer's Representative (COR)

The COR is delegated the authority to act for the Contracting Officer in matters concerning technical clarifications, inspections, acceptance of Contractor's performance, oversight, and emergency requests. This includes certification of work in progress or completed authorization to process payments. The COR on this contract is Mr. Arben Mane, Facility Management Supervisor of the United States Embassy in Tirana, Albania.

4.0 Security

Upon notification of being the successful bidder, the Contractor shall submit to the Contracting Officer, or to the Contracting officer's Representative (COR), the names of all of the Contractor's employees who may be working on this project. All employees will be required to submit to the routine background investigation done by the Embassy's Regional Security Officer (RSO) prior to working on this project. No employee will be admitted to the work site without first being cleared by the RSO.

4.1 All contractor employees will be screened each time they enter or leave the RR compound. This search will include persons, vehicles, toolboxes, and materials.

4.2 All tools and materials should be returned to the designated storage area at the end of each work day.

4.3 At no time the contractor will leave their tools and materials unattended during the working day. This requirement means that the Contractor employees will need to stagger their lunch breaks and any other breaks during the workday.

5.0 Safety

The Contractor should maintain a safe working environment for the Contractor's employees, United States Government employees, all visitors to the compound and the general public.

6.0 Liability

If, during the course of this project, it is determined that the employees of the Contractor were negligent, and United States Government property and/or personal property of United States Government employees is damaged as a result of such negligence, the Contractor will be responsible for the repair or replacement of damaged property.

7.0 Materials

The Contractor is responsible for providing all materials associated with this contract.

7.1 All materials should be new at the start of this project. No material shall be used which has been deemed obsolete by current industry standards.

7.2 The COR shall approve all materials before commencement of work.

7.3 The Contractor is responsible for measuring and confirming the quantities of materials required.

7.4 The Contractor shall be responsible for transportation, and transportation costs, related to the delivery of materials. This shall include, but not be limited to, freight carrier fees, road tolls, border crossing fees, fuel cost, and the movement of tools, material, and labor to and from the project site.

7.5 The Contractor shall be responsible for any cost incurred in the removal and disposal of debris generated by this project.

12.0 Time Table

The contractor will have 10 calendar days to complete each residence.

13.0 Personnel

The Contractor should provide both skilled and unskilled labor, as determined by the Contractor, to complete this project. At no time the unskilled laborers will be left on this project unsupervised.

14.0 Clean-up

The Contractor will be required to maintain a clean work area at all times. Items for installation and accumulated debris shall not be left in an area where it may become a tripping or other safety hazard. Upon completion of the job and prior to submitting the final invoice, the Contractor shall remove all excess material, tools, and debris, and shall restore the mobilization/storage area back to its original condition.

15.0 Quality Assurance.
