I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price contract is to provide workers compensation insurance coverage to all locally employed employees and volunteers to the U.S. Embassy Canberra, ACT, the U.S. Consulate General in Perth, Western Australia in accordance with the specifications and terms and conditions set forth herein for the period 1 July, 2014 to 30 June, 2015.
- B. The contract period of performance shall be for one-year period.
- C. The prices listed below shall include all labor, materials, overhead, profit, and transportation necessary to deliver the required services to the U.S. Embassy and Consulates General.
- D. All prices/premiums shall be firm fixed priced in accordance with the applicable currency stated in Paragraph F. below. Pricing is based on salary wages.
- E. The U.S. Mission in Australia promotes a safe and healthy workplace for employees and contractors by establishing a Safety, Health and Environmental Management (SHEM) program and participating in the Return to Work Policy.
- F. Offers and Payment in U.S. Dollars. U.S. firms are eligible to be paid in U.S. dollars. U.S. firms desiring to be paid in U.S. dollars should submit their offers in U.S. dollars. A U.S. firm is defined as a company which operates as a corporation incorporated under the laws of a state within the United States.
- Foreign Firms. Any firm, which is not a U.S. firm, is a foreign firm. Any firm that does not meet the above definition of U.S. firm shall submit its prices and receive payment in local currency.

PERFORMANCE WORK STATEMENT

I.
A. Workers Compensation Insurance Coverage

The Contractor shall provide workers compensation insurance designed to cover the cost of medical treatment and rehabilitation in an effort to return injured workers back to the workplace as soon as practicable. The workers compensation insurance shall provide workers who have suffered a work related injury with:

- Weekly compensation payments based on their pre-injury earnings;
- Medical and hospital expenses;
- Rehabilitation treatment;
- Certain personal items (e.g. clothing and spectacles if they were lost or damaged in a work related accident); and
- Lump sum payments for permanent injuries.

Insurance coverage is provided to all locally employed staff and volunteers (work experience students, etc.) at the U.S. Embassy Canberra, and at the U.S. Consulate General Perth. This includes employees with an intermittent, seasonal, or WAE (when actually employed) schedule. Insurance coverage will continue for these eligible participants when on temporary duty assignments away from their employment location. Temporary duty assignments may be inside or outside of Australia.

B. Regulation of Worker's Compensation Insurance.

Contractor shall be licensed by or act on behalf of, the Australian State or Territory workers' compensation authority and provide worker's compensation coverage as required in:

ACT: Workers' Compensation Act 1951

WA: Workers' Compensation and Rehabilitation Act 1981; Workers' Compensation Reform Act 2004

II. CONTRACT ADMINISTRATION DATA

A. DOSAR 652.242-70 Contracting Officer's Representative (COR) (AUG 1999)

A.1 The Contracting Officer may designate in writing one Government employee, by name or position title, to take action for the Contracting Officer under this contract. This designee shall be identified as a Contracting Officer's Representative (COR). Such designation shall specify the scope and limitations of the authority so delegated - provided, that the designee shall not change the terms or conditions of the contract, unless the COR is a warranted Contracting Officer and this authority is delegated in the designation.

A.2 The COR for this contract is the Senior Human Resources Advisor at the U.S. Embassy Canberra.

B. COR Duties

B.1 The COR is responsible for inspection and acceptance of services. These duties include review of Contractor invoices, including the supporting documentation required by the contract. The COR may provide technical advice, substantive guidance, inspections, invoice approval, and other purposes as deemed necessary under the contract.

B.2 In addition, the COR shall maintain an updated list of employees and volunteers insured. The COR will report updated total number of employees and volunteers to the insurer without prejudice to the ineligibility clause.

B.3 The COR may not change the terms and conditions of the contract.

C. Payment

Offers and Payment in U.S. Dollars. U.S. firms are eligible to be paid in U.S. dollars. U.S. firms desiring to be paid in U.S. dollars should submit their offers in U.S. dollars. A U.S. firm is defined as a company which operates as a corporation incorporated under the laws of a state within the United States.

Foreign Firms. Any firm, which is not a U.S. firm, is a foreign firm. Any firm that does not meet the above definition of U.S. firm shall submit its prices and receive payment in local currency.

C.1 Submission of Invoices and Payment

C.1.1.1. Frequency of Payments. Semi-Annually

C.2. Refunds to the Government.

If the Government becomes eligible for a refund of payment because of erroneous overpayment or other cause, the Contractor shall refund the amounts or use them to offset future payments owed by the Government, whichever the Government prefers. If the Contracting Officer requests a refund, the contractor shall make that refund to the Government within ten calendar days of receipt of the request.

III. SPECIAL CONTRACT REQUIREMENTS

A. Determination of Premium.

A.1. Upon award of the contract, the Government will confirm the salary total for U.S. Embassy Canberra and the US Consulate General in Perth WA. The Government's premium will be determined based on the fixed premium prices proposed in Section 1 Part II, Pricing, according to the appropriate salary range. Any revisions to the estimated annual wages (i.e. salaries) set forth in Attachment 1, will be done through issuance of contract modification(s).

A.2. The Government will update the salary total every six months and the Government's premium should be adjusted as necessary based on the fixed premium prices proposed in Section 1 Part II, Pricing, according to the appropriate salary range. Any revisions to the estimated annual wages (i.e. salaries) set forth in Attachment 1, will be done through issuance of contract modification(s).

A.3. The Government's premium will be determined based on the fixed premium prices proposed in Section 1 Part II, Pricing, according to the appropriate salary range for the year. Any revisions to the estimated annual wages (i.e. salaries) set forth in Attachment 1, will be done through issuance of contract modification(s).

B. Contractor Responsibility in Claims and Reimbursement to Claimants

B.1. General.

The Contractor shall be responsible for all planning, estimating, programming, project management, scheduling, dispatching, supervision, and inspection of work. The Contractor shall maintain his own reference library of technical reference works and local laws and regulations, including current tariffs and registries. The Contractor shall treat the information provided by the Embassy concerning employee' personal data, medical information, and salaries as highly sensitive and not divulge any employee information to unauthorized persons. The Contractor shall establish procedures for handling medical insurance claims as follows:

B.1.1 Administrative Records.

(1) The Contractor shall maintain medical insurance files for each covered employee including requests for claim reimbursements, receipts and proof of paid claims, and accounting of paid benefits with balances of amounts remaining in the annual per-person reimbursement ceiling.

(2) The Contractor shall provide the COR with the necessary claim forms for each type of benefit that can be claimed under the contract. These forms shall specify a list of documents required to be appended to each claim and otherwise provide instructions for claim filing.

(3) The Contractor shall send employee claim reimbursement checks to employees not later than two weeks after a claim is submitted.

B.1.2 Insurance Claims.

Settlement of insurance shall be completed as follows:

(1) All medical claims shall be submitted directly to the COR. The COR will submit all claims to the Contractor within two business days of receipt.

(2) The Contractor shall date stamp and screen all claims submitted on the day of receipt. If there are any missing documents or information thereby disallowing said claim to be payable, the Contractor shall notify the employee within two business days, with a copy to the COR (if notification is written).

(3) The Contractor shall settle the claims no later than two weeks from the date the claim is submitted to the Contractor.

(4) Settlement shall be by issuance of checks in the name of the employee for each claim submitted. Each check shall be accompanied by a form providing details of the amount reimbursed with an explanation of deductions, if any.

(5) The Contractor shall accept the medical specialist's choice of hospital for surgery. The Contractor will pay the expenses directly to the hospitals.

B.1.3. Report Requirements. The Contractor shall provide the following report twice per year. The first report must be received by the COR no later than April 10, 2015 and shall cover the activities of the first nine months of the contract period. The second report must be received by the COR no later than July 10, 2015 and shall provide cumulative data for the entire contract year.

Employee Claims Report. The report will list all claims paid by the Contractor to a claimant, including the name of the claimant, date claim is received by the Contractor, and the amount claimed. This report shall also include all outstanding claims and a brief description of why a claim has not been paid.

B.1.4. Miscellaneous Contractor Requirements.

(1) General.

The Contractor shall take all such steps as are necessary, and obtain and pay for all permits, taxes and fees as are required by the Australian government to establish and/or operate a commercial venture locally. A contract with the U.S. Government conveys no special privileges or immunities to the Contractor. The Contractor is an independent commercial concern and not a part of the U.S. Mission. The Contractor's employees are not U.S. Government employees. Registration of this contract with the Australian government, if required by law, will be the sole responsibility of the Contractor, and any fees, taxes, or other duties shall be payable by the Contractor without recourse to the Government of the amounts thereof.

(2) Licenses and Local Laws.

The Contractor shall possess all permits, licenses, and any other appointments required for the prosecution of work under this contract, all at no additional cost to the Government. The Contractor shall perform this contract in accordance with local laws.

(3) Brochure Requirement.

The Contractor shall provide a document (brochure/pamphlet/other written document) in English that sets forth a complete listing of the workers compensation insurance benefits to be provided under this contract. This brochure shall be provided in sufficient quantities so that each covered employee receives a copy. The Contractor shall furnish all copies of the brochures to the COR no later than thirty days after date of contract award.

The Contractor assumes full responsibility for ensuring that the document described above accurately reflects the requirements of the contract. Should the COR discover that the brochure contains inaccuracies, the Contractor will be notified in writing; however, failure on the part of the Government to notice any inaccuracies shall in no way limit, revise or otherwise affect the requirement under this contract for the Contractor to fully comply with all contract terms.

B.1.5. Injury Management Program.

In the event of a workplace injury, the insurer must establish and maintain an Injury Management Program in accordance with applicable laws in respective jurisdictions. This program is a coordinated and integrated set of policies and procedures addressing all aspects of injury management from time of injury, including:

- Treatment;
- Medical management practices;
- Employment;
- Rehabilitation;
- Retraining; and
- Claims management systems

B.1.6. Insurer Response

In the event of a workplace injury, the insurer must take action under the insurer's injury management program within three (3) business days after receiving the injury notice from the employer. The insurer must contact the employee, the employer and the injured worker's nominated treating doctor. From time to time an occupational rehabilitation provider (professional occupational therapist) may be appointed by the Workers Compensation Insurance Company to assist in the return to work process. However, unless the COR raises valid objections, the Mission will be guided by the recommendation of the Insurer in appointing an appropriately qualified occupational rehabilitation provider.

IV. DEFINITIONS

COR Contracting Officer's Representative (Senior Human Resources Advisor at U.S. Embassy Canberra).

Employee Local individuals employed by the U.S. Government. For the purposes of this contract also includes local volunteers (work experience students, etc.)

Employer The United States Government.

V. DELIVERY LOCATION

VI. PERIODS OF PERFORMANCE

The base period of this contract starts on July 1, 2014 through June 30, 2015. In addition, the contractor is required to provide the annual report as required in B.1.3., no later than 10 days after the end of the period of performance, which is July 10, 2015.

VII. LOCATION OF EMPLOYMENT

Eligible participants must be employed or volunteering within the geographic boundaries of Australia for the agencies listed below:

Department of State, Department of Defense, Foreign Commercial Service, Foreign Agricultural Service, Department of Justice, Department of Homeland Security, and Internal Revenue Service.

Insurance coverage will continue for these eligible participants when on temporary duty assignments away from their employment location. Temporary duty assignments may be inside or outside of Australia.

VIII. INSPECTION AND ACCEPTANCE

The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

A. Surveillance

The Contracting Officer's Representative (COR) will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

B. Standard

The performance standard is that the Government receives no more than two (2) customer complaints per quarter. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

C. Procedures

C.1. If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.

C.2. The COR will require written documentation to record the complaint.

C.3. If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

C.4. If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

C.5. The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

C.6. If the Contractor disagrees with the complaint and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

C.7. The COR will consider complaints as resolved unless notified otherwise by the complainant.

C.8. Repeat customer complaints are not acceptable for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

652.225-71 SECTION 8(A) OF THE EXPORT ADMINISTRATION ACT OF 1979, AS AMENDED (AUG 1999)

(3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person; (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

(b) Under Section 8(a), the following types of activities are not forbidden "compliance with the boycott," and are therefore exempted from Section 8(a)'s prohibitions listed in paragraphs (a)(1)-(6) above:
