

**U.S. Embassy Bahrain**  
**Demonstration Notice 26 - March 8, 2012**

Spontaneous demonstrations take place in Bahrain from time to time in response to world events or local developments. United States citizens should keep current with media coverage of local events and be aware of their surroundings at all times. If you encounter a large public gathering or demonstration, depart the vicinity immediately.

**- On Thursday, March 8 at 1600 hours, a demonstration is planned in the vicinity of Abusaiba Village.**

**- On Thursday, March 8 at 2000 hours, a march is planned from Shakhoora village roundabout to Mugsha village.**

**- On Friday afternoon, March 9 at 1500 hours, a large-scale demonstration/march is scheduled to occur along Budaiya Highway from the Al Osra / Saar Roundabout to Mugsha Village / Burgerland Roundabout. RSO anticipates that traffic will be severely impacted on Friday afternoon as a result.**

**- On Friday afternoon, March 9 at 1530, a march is planned from Kanoo Mosque in Muharraq to Sh. Isa Bin Salman Bridge in Muharraq.**

**- On Friday afternoon, March 9 at 1630 hours, a sit-in is planned Fatima Kanoo Hall on Sh. Isa Bin Salman Highway facing the U.S. Embassy..**

**Some demonstrators have engaged in clashes with the police and continue to employ tactics such as placing debris and oil on roadways, throwing steel spikes and Molotov cocktails. These actions often result in adverse driving conditions, an increased police presence, official checkpoints and significant traffic delays. The Embassy expects these tactics to continue. Please use caution as you drive and plan additional time to arrive at your destination.**

We remind U.S. citizens that even demonstrations intended to be peaceful can turn confrontational and possibly escalate into violence. U.S. citizens are therefore urged to avoid the areas of demonstrations if possible, and to exercise caution if within the vicinity of any demonstrations.
