

**U.S. Embassy Bahrain**  
**Demonstration Notice 29 - March 15, 2012**

Spontaneous demonstrations take place in Bahrain from time to time in response to world events or local developments. United States citizens should keep current with media coverage of local events and be aware of their surroundings at all times. If you encounter a large public gathering or demonstration, depart the vicinity immediately.

**- On Thursday, 15 March, unauthorized rallies are being called for in Sitrah, Al-Akr, Al-Ma'amir, Al-Nuwaydrat, and Al-Nabiyah Salih.**

**- On Friday, 16 March at approximately 1500 hours, a sit-in is planned in the vicinity of Al Fateh Grand Mosque.**

**- On Friday, 16 March at 1600 hours, a demonstration is planned in the area between Mahooz and Adliya.**


**Some demonstrators have engaged in clashes with the police and continue to employ tactics such as placing debris and oil on roadways, throwing steel spikes and Molotov cocktails. These actions often result in adverse driving conditions, an increased police presence, official checkpoints and significant traffic delays. The Embassy expects these tactics to continue. Please use caution as you drive and plan additional time to arrive at your destination.**

We remind U.S. citizens that even demonstrations intended to be peaceful can turn confrontational and possibly escalate into violence. U.S. citizens are therefore urged to avoid the areas of demonstrations if possible, and to exercise caution if within the vicinity of any demonstrations.
