



U.S. Visa Interview Waiver Program

Qualification for U.S. Visa Interview Waiver Program based on age:

- Children under 14 years of age, and applicants age 80 or older, if they have not been previously found ineligible for a U.S. visa.

Qualification for U.S. Visa Interview Waiver Program based on past U.S. Travel:

To determine whether you may be eligible to renew your non-immigrant visa without appearing for an interview, look at your previous visa and answer yes to all the statements below:

- One photograph with a white background, 2 x 2 inches.
- Copy of I-20/DS-2019 for principal F, M, J
- Copy of dependent's I-20/DS-2019
- Copy of your CDC book/employment contract

Important: Please note that eligibility for interview waiver does not guarantee a visa issuance nor does it guarantee that the interview will be waived. Although your interview may be waived, you may still be required to appear for finger scanning. Any necessary notification will be made via the email address listed in your DS 160 online application.
