

1.0 DESCRIPTION

The U.S. Embassy Dhaka requires services to maintain UPS in safe, reliable and efficient operating condition. The contract type is a firm fixed price contract for routine maintenance services paid at the quarterly rate below. These rates include all costs associated with providing UPS maintenance services, overhead, profit and VAT (if applicable). The contract will be for a one-year period, with two one-year optional periods of performance.

2.0 PRICING

2.1 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period.

1.0 SCOPE OF WORK: UNINTERRUPTIBLE POWER SUPPLY (UPS) PREVENTIVE MAINTENANCE ,
U.S. EMBASSY DHAKA

INTRODUCTION

The United States Embassy, Dhaka has two existing UPS systems located in different facilities feeding separate loads. The two units are identified below, and both require an annual service support. The Scope of Work applies to both the units.

2.0 SCOPE OF WORK. The purpose of this SOW is to contract labor required for successful completion of the following work at the U.S. Embassy in Dhaka. This SOW is for a quarterly service visit.

1. Coordinate a system outage with site personnel and place the load on maintenance bypass.
2. Perform an annual preventive maintenance service on both the UPS. Follow proper lock-out and tag-out procedures to isolate the unit. Remove all access covers, clean both interior and exterior of the offline unit. Inspect all connections, components, and internal wiring for signs of overheating or damage. Spot-check all power connections for proper torque.
3. Repair and correct any faulty, damaged, discolored, or worn components using onsite government spares. Provide Facility Engineer a complete list of any required or suggested material replacements not presently onsite, along with the item's part number, unit price, and availability.
4. Clean or replace air filters.
5. Reenergize and perform online function tests. Verify system output voltage adjustments, and calibrate unit. Check all logic adjustments, meter parameters and settings. Test all UPS alarms and remote alarm panels.
6. Restore the UPS to its online condition with output breaker closed and supporting the critical load. If any discrepancies remain, which prohibit the unit from supporting the load, the contractors technician must notify the COR and/or the post Facility Engineer of these discrepancies and the unit's bypass

- condition immediately. Ensure proper UPS operation and acceptance prior to leaving site.
7. Perform battery maintenance. This shall include cell voltage readings and an overview inspection of the battery strings condition. If there are any noticeable discrepancies, such as a corroded connection or a loose wire, this shall be brought to the immediate attention of site maintenance personnel and the Facility Engineer.
 8. Provide a narrative summary of all findings, repairs, conditions, and readings. Provide a one-line drawing, which encompasses the main switchgear, generators, voltage regulators, UPS and primary critical power distribution panels that are located in unclassified locations. Include panel names and locations for the UPS feed and first tier output panel.
 9. Provide a complete list of all UPS spare parts available onsite.
 10. Provide UPS/Battery operation and maintenance training to designated site personnel, not to exceed 4 hours.
-
- 2.1 **WORK STANDARDS.** The contractors performing technician must be trained and experienced on MGE UPS Power Systems. The contractor is responsible for providing the service technician the proper tools and test equipment to accomplish each segment of this work statement.
 - 2.2 **MISCELLANEOUS ON-SITE WORK.** None.
 - 2.3 **COMMENCEMENT OF WORK.** The contractor shall under no circumstances incur any travel or other costs, or begins the travel to the site or work at site until a signed purchase order is issued. The contractor will be asked to furnish the COR the details of the technicians who will be working with the servicing work.
 - 2.4 **SERVICE INTERRUPTIONS.** The contractor shall plan, coordinate, and schedule all UPS site work with the Embassy Facilities Engineer. The contractor must schedule work to maintain flexibility since interruptions may not be granted on the date(s) requested. Electrical shutdowns and operation of electrical breakers, to include UPS bypass transfer, shall be accomplished only by qualified personnel and upon advance approval of the Embassy Facilities Manager. Where fire protection, detection, or evacuation alarms are affected, advance written approval of the Embassy Facilities Manager shall be obtained. The implementation plan should be focused on minimizing any interruptions. Proper lock out/tag out procedures should be followed to maximize safety; the contractor shall supply lock out/tag out materials. Power shall be maintained to all operational loads during normal working hours and maintained to all critical loads at all times except for planned and approved short duration switchovers or outages.
 - 2.5 **DEFECTIVE EQUIPMENT.** Contractor shall replace any failing or faulty component using onsite government furnished spares at no extra charge.
 - 2.6 **CLEANING OF THE UPS.** As noted in step two of the scope of work.
 - 2.7 **SITE RESTORATION.** The contractor shall ensure that all facilities receiving this work shall be left in a condition acceptable to the Embassy Facilities Engineer upon completion.
 - 2.8 **DISPOSAL OF MATERIALS REMOVED.** The Embassy shall be responsible for the disposal of removed materials, used rags and common trash. The contractor shall transport all materials to be disposed of from the point of removal to the designated disposal storage site, and shall ensure that all items removed through this work are disposed of properly.
 - 2.9 **SAFETY.** Safety is the highest priority on this. The contractor shall direct all of those under his charge

to work safely. A safety meeting shall be held among on-site contractor personnel before each site visit, and safety concerns shall be brought to the attention of the Post Safety and Health Officer (OSHA) and the COR.

3.0 **REQUIREMENTS AND DELIVERABLES.** The contractor shall provide two (2) copies of a typed summary report within 30 days of site visit completion. The report must be written in the English language. The report can be either hard copy, or delivered electronically. At a minimum the report shall include the following information:

1. Narrative summary of all findings, problems, and corrective action pertaining to the existing UPS and critical power distribution system. Include Output Load readings (KVA), Input and Output Voltage and Amperage readings. Include all UPS & Battery nameplate data.

4.0 **SECURITY REQUIREMENTS.** No security clearance is required to perform this scope of work. The contractor will be escorted whenever necessary.

5.0 **ALLOWANCE FOR MISCELLANEOUS TIME REQUIREMENTS.** The contractor's price proposal must allow for time delays that may be encountered in coordination of a planned UPS outage. Including but not limited to delayed access to certain building spaces, meetings and report writing. No additional funds will be provided to compensate for additional time requirements or delays that could have been reasonably anticipated. No additional labor funds will be provided if repairs exceed the contractor's work plan timeframe.

6.0 **POINTS OF CONTACT**

6.1 Point of contact for this work is the US Embassy Procurement Department.

6.2 **EMBASSY CONTACT.** Post point of contact information provided upon contract award is Facility Manager or his Authorized Representative.

INSURANCE REQUIREMENTS

Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract

The Contractor's assumption of absolute liability is independent of any insurance policies.

Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, whatever insurance is legally necessary. The Contractor shall carry the following minimum insurance:

Comprehensive General Liability

Bodily Injury	* per occurrence
Property Damage	* per occurrence

Workers' Compensation and Employer's Liability

Workers' Compensation and Occupational Disease * per occurrence
Statutory, as required by host country law

Employer's Liability * per occurrence

Worker's Compensation Insurance. The Contractor agrees to provide all employees with worker's compensation benefits as required by the laws of either the country in which the employees are working or the employee's native country, whichever offers greater benefits, following FAR 52.228-4 "Worker's Compensation and War-Hazard Insurance Overseas".

PERMITS

The Contractor shall maintain in full force and affect all permits, licenses, and appointments required for the prosecution of work under this contract at no additional cost to the Government. The Contractor shall obtain these permits, licenses, and appointments in compliance with host country laws.

LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to insure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the contract shall be payable by the Contractor without Government reimbursement.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

Procedures.

If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

The COR will complete appropriate documentation to record the complaint.

If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

The COR will consider complaints as resolved unless notified otherwise by the complainant.

Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
