The U. S. Embassy in Bangui is seeking four (4) individuals for the position of **Chauffeurs**. **These positions are located in Bangui, Central African Republic.**

**Work Hours:** Full time; 40 hours/week

## **BASIC FUNCTION OF POSITION**

Serves as general chauffeur under work guidance of the Motor Pool Dispatcher. Ensures vehicles are in good condition at beginning of shift and reports any problems to Dispatcher at end of shift. Responsible for daily checks of radiator, battery and tires and for filling fuel tank. Must maintain daily usage logs and submit to Dispatcher at end of each shift. Overall supervision provided by the General Service Assistant.

## **QUALIFICATIONS REQUIRED**

**Note:** All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.

- 1. Education:** Completion of elementary minimum of 6 years is required.
- 2. Experience:** One year experience as a paid chauffeur is required.
- 3. Language:** English level II, French level II.
- 4. Job Knowledge:** Must know Bangui and surroundings area and be familiar with all local traffic laws and basic mechanical operation of motor vehicles.
- 5. Skills/Abilities:** Must have a valid C.A.R driver's license appropriate to the type of vehicle driven is required.

## **ADDITIONAL SELECTION CRITERIA**

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy
2. Current employees serving a probationary period are not eligible to apply.
3. Current Ordinarily Resident employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. The candidate must be able to obtain and hold a Locally Employed Staff security clearance.

Interested candidates for this position must submit the following for consideration of the application:

1. Universal Application for Employment (DS-174) available online or at the Embassy; or
2. A current resume or curriculum vitae that provides the same information found on the UAE (see Appendix B); or
3. A combination of both; i.e. Sections 1 -24 of the UAE along with a listing of the applicant's work experience attached as a separate sheet; plus
4. Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application. Candidates who claim conditional U.S. Veterans preference must submit documentation confirming eligibility for a conditional preference in hiring with their application.
5. Any other documentation (e.g., essays, certificates, awards) that addresses the qualification requirements of the position as listed above.
