The Contractor shall perform Pool and Fountain maintenance work, including furnishing all labor, material, equipment and services, for the U.S. Embassy Bridgetown. The price listed shall include all labor, maintenance, insurance, overhead, and profit. The Government will pay the Contractor a firm fixed price per month for standard services that have been satisfactorily performed. This service will be required for 2 (two) swimming pool and 1 (one) Fountain, located at 2 Residence.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date of (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

I. PERFORMANCE WORK STATEMENT

- A. The contract will be for a one-year period from the date of the contract award, with [four (4) one-year options.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** *The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.*
  
2. **STANDARD.** *The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.*
  
3. **PROCEDURES.**
  - (a) *If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.*
  - (b) *The COR will complete appropriate documentation to record the complaint.*
  - (c) *If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.*
  - (d) *If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.*
  - (e) *The COR shall, as a minimum, orally notify the Contractor of any valid complaints.*
  - (f) *If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.*
  - (g) *The COR will consider complaints as resolved unless notified otherwise by the complainant.*
  - (h) *Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.*

If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

## **DCM's residence, Graeme Court, Graeme Hall, Christ Church**

### A. Swimming Pool – Twice Weekly Visit

1. A complete brush of the surface area, tiles and walls. Removing all oils and material build up.
2. A complete vacuum of the surface area and bottom of the pool.
3. Removal of collected debris from the pump basket and skimmer baskets.
4. Netting of the surface removing leaves, insects and other foreign objects and debris.
5. Checking and washing of the cartridge filter as and when required.
6. Full water chemistry test, balancing and treatment as required using appropriate chemicals. All chemicals to be supplied by the contractor.
7. A complete inspection of all material and electrical system, time clock, starter, filters and pressure gauge.
8. Electronic bi-weekly report(s) on status of pool components and equipment.

## **SECURITY**

After award of the contract, the Contractor shall provide the following list of data on each employee and back up employees, who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will take 30 days. For each individual the list shall include:

Full Name

Place & Date of Birth

Current Address

National Registration Number

The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the

property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S. operated facilities to any individual.

## **INSURANCE**

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims. The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

## **CERTIFICATE OF INSURANCE**

The Contractor shall furnish to the Contracting Officer a current certificate of insurance as evidence of the insurance required. In addition, the Contractor shall furnish evidence of a commitment by the insurance carrier to notify the

Contracting Officer in writing of any material change, expiration or cancellation of any of the insurance policies required not less than thirty (30) days before such change, expiration or cancellation is effective. If Contractor is self-insured then the Contractor shall not change or decrease the coverage without the Contracting Officer's approval.
