I. Furnish and delivery of maintenance and repair services (both scheduled and unscheduled) for all FORD-made official U.S. Embassy Brussels fleet vehicles using original parts and products.

II. Minimum/Maximum Quantities

For each effective year of the purchase order, the U.S. Government guarantees a minimum order of € 3,000.00 under this purchase order. The maximum amount ordered under each year of the purchase order will not exceed € 25,000.00.

Orders may be issued orally by the Contracting Officer, but will be confirmed in writing within three business days of the date the order is placed.

III. Scope of Services

The contractor agrees:

1. To perform the periodic maintenance;
2. To perform all repairs, including the replacement of parts, for all breakdowns not caused by traffic accidents. These services include, but are not limited to, the replacement of oil, spark plugs, joints, filters, and all original spare parts (such as windshield wipers, brake pads, battery,...) etc;
3. To provide a replacement vehicle at no additional cost for the US Government (equivalent brand/type of the vehicles maintained) if the maintenance and/or repair services exceed the agreed timeframe needed for the repair.
4. To provide warranty on parts, repairs and services for 12 months at no extra cost to the US Government.

IV. Task orders and completion dates under task orders

All supplies or services to be furnished under this contract shall be ordered by the issuance of written task orders by the Government. Task orders may be issued from the effective date of the contract until the end of the "Period of Performance" applicable to this contract. All task orders are subject to the terms and conditions of this contract, which shall take precedence in the event of conflict with any order.

Urgent task orders may be issued orally by the Ordering Officer, but will be confirmed in writing the same day.

The Ordering Officer's task orders shall include: date of order, contract number, information on the vehicle, an overview of the services rendered, and the point of contact for questions.

After execution of each maintenance/report visit, the contractor will make a report that contains a full description of the parts used and of the services performed. The report should be attached to the invoice. Payment might be refused in case the contractor fails to forward these reports.

The contractor is requested to notify the US Government immediately if additional services, repairs or parts, beyond the repairs requested are needed. An estimate to cover these extra expenses shall be prepared and forwarded to the COR for approval. Only after his/her approval, the contractor may proceed with the repairs.

(1) Are, are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any Federal agency;
