The Centers for Disease Control and Prevention (CDC/BOTSWANA) in Gaborone is seeking an individual for the position of Medical Officer under the TB Program.

BASIC FUNCTION OF POSITION:

Serves as a Medical Officer for the BOTUSA Project based in Gaborone by assisting in the implementation of one or more tuberculosis research studies; evaluates potential patients for inclusion in or exclusion from studies according to study protocols; conducts physical assessment and obtain clinical specimens as outlined in study protocols;

maintains complete and accurate records using developed data collection instruments; assists in the development or modification of study protocols and procedures; performs appropriate clinical assessments and decisions during the process of providing medical care to study patients; assists in data analysis and dissemination of results; establishes and maintains good working relationships with counterparts and peers; provides advice and guidance to study nurses regarding study protocols and procedures

QUALIFICATIONS REQUIRED:

- Medical degree and a license to practice medicine in the country is required.
- Three years of work experience with tuberculosis and HIV related disease is required.
- Level IV English (fluency speaking, writing) is required.
- Must have knowledge of tuberculosis and HIV/AIDS and principles of health; research techniques and methods.
- Must have basic computer and data management skills

SELECTION PROCESS

When fully qualified, U.S. Citizen Eligible Family Members (USEFMs) and U.S. Veterans are given preference. Therefore, it is essential that the candidate specifically address the required qualifications above in the application.

ADDITIONAL SELECTION CRITERIA

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
3. Current Ordinarily Resident employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. Currently employed US Citizen EFMs who hold a Family Member Appointment (FMA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
5. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment unless currently hired into a position with a When Actually Employed (WAE) work schedule.

TO APPLY

Candidates interested in applying for this position must follow the application instructions by submitting an application which contains all of the required information

4. Candidates who claim US Veterans preference must provide a copy of their Form DD-214 with their application. Candidates who claim conditional US Veterans preference must submit documentation confirming eligibility for a conditional preference in hiring with their application.
5. Any other documentation (e.g., essays, certificates, awards) that addresses the qualification requirements of the position as listed above.
