1.1 The Contractor shall provide Technology Skill Training Services for approximately 20 students per training for five distinct courses mentioned below the American Embassy Yangon. The Contractor shall provide one course per month for 12 months (i.e Marker Space Training, per month cost \$... x 12 months = total \$... for a year) to be given at a firm fixed price per cause of \$_____ for combination of 5 causes. Causes shall be two hours in length and once per month.

Classes will not be held on scheduled Embassy Holidays. A copy of the Embassy Holiday calendar will be provided to the contractor in advance.

If the U.S. Embassy needs to cancel the class for any reason, the Embassy will inform the contractor at least 3 days in advance. If 3 days notice (or more) is provided, the contractor will not charge the Embassy for the cancelled class.

If the contract-provided teacher becomes ill or encounters a personal emergency and must take leave during the scheduled class, the contractor will provide a pre-approved, equally qualified substitute teacher at least 85% of the time. On the rare occasion when no teacher is available, then fees will be reduced from the quarterly payment accordingly. The contract-provided teacher should make every effort to not schedule personal leave during the hours of the course. If the teacher must schedule leave, the leave should be limited to 2 days per trimester, the US Embassy should be notified at least two weeks in advance and a substitute teacher must be arranged in advance. Since personal leave is scheduled with advanced notice, a substitute teachers should be provided 100% of the time in instances of personal leave.

1.2 PAYMENT

Payment will be made on Monthly basis after submission invoice at the end of each month.

The Contractor shall not submit an invoice for payment until all requirements identified in this contract have been completed and delivery to the COR is complete.

Electronic Fund Transfer (EFT) payment method for all services contractor provides. Account established by contractor where contractor payments to be sent. EFT is the only acceptable payment method under this contract.

1.3 DEFINITIONS

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

2. STATEMENT OF WORK TECHNOLOGY SKILLS TRAINING

2.1 Objectives

The contractor will provide technology skills training to staff and patrons of the U.S. Embassy's American Center in Rangoon, to introduce key concepts and improve skills in computing and internet usage so that our audiences can more fully utilize technological tools to improve their lives and their communities. Training activities for youth and adults in the community will deliver computer basics, internet basics, social media basics, and internet security basics; "MakerSpace" training will use tech tools to spark innovation and creativity; and digital art training will harness creative thinking. Information Resource Center (IRC) staff will be trained separately in all of these fields so that they will gain a degree of overall tech expertise and can themselves train other patrons in the future.

2.2 Scope including inline assumptions and deliverables

The contractor shall provide technology training in the form of five distinct courses, each delivered once per month: 1) MakerSpace Training, 2) Digital Art Training, 3) Computer/Internet Skills for Adults, 4) Computer/Internet Skills for Youth (including safe use of social media), and 5) Technology Skills Training for Information Resource Center Staff.

2.3 MakerSpace Training: Training will focus on using technological tools to spark innovation and creativity. The U.S. Embassy will provide technology and materials to be used in these trainings, including 3Doodler (and filament), Snap Circuits, Drawdio, 3D printing and Lego Mindstorm materials. Other ideas from the contractor will be considered. Materials needed for each course must be identified two months prior to their date of expected use so that they may be reviewed, approved, and procured by the U.S. Embassy. Training will be conducted in Myanmar language. Lesson plans for each monthly course must be submitted to the U.S. Embassy one month before the training will take place. Handouts, reference guides, or other course takeaways will be prepared for each lesson and provided to all students by the contractor.

2.4 Digital Art Training: training shall include basics of digital drawing, animation, photography, or other creative expression using digital tools. Contractor shall introduce free, open-source software such as GIMP, INKSCAPE, and Ubuntu, to encourage further exploration of these topics by trainees without the need for costly software. The U.S. Embassy will furnish

laptop computers and an internet connection for each lesson. Training will be conducted in Myanmar language. Lesson plans for each monthly course must be submitted to the U.S. Embassy one month before the training will take place. Handouts, reference guides, or other course takeaways will be prepared for each lesson and provided to all students by the contractor.

2.5 Computer/Internet Skills for Adults: training shall include lessons on: 1) basic computing principles, 2) basic PC maintenance, 3) mobile phone basics, 4) typing skills, 5) email basics, 6) social network basics, 7) using the internet responsibly, 8) internet security/passwords/account recovery, 9) free online resources and research tools (dictionaries, encyclopedias, etc.), 10) free online education courses (edx, coursera, etc.), 11) Microsoft Office product basics, 12) online job searching and employment skills, 13) creating a blog. Participants will be over age 35 and lessons will assume minimal prior knowledge of computing. The U.S. Embassy will furnish laptop computers and an internet connection for each lesson. Training will be conducted in Myanmar language. Lesson plans for each monthly course must be submitted to the U.S. Embassy one month before the training will take place. Handouts, reference guides, or other course takeaways will be prepared for each lesson and provided to all students by the contractor.

2.6 Computer/Internet Skills for Youth: training shall include lessons on: 1) basic computing principles, 2) basic PC maintenance, 3) mobile phone basics, 4) typing skills, 5) email basics, 6) social network basics, 7) using the internet/social media responsibly, 8) internet security/passwords/account recovery, 9) free online resources and research tools (dictionaries, encyclopedias, etc.), 10) free online education courses (edx, coursera, etc.), 11) Microsoft Office product (Word, Excel, PowerPoint) basics, 12) online job searching and employment skills, 13) creating a blog. Participants will be age 16 to 35 and lessons will assume minimal prior knowledge of computing. The U.S. Embassy will furnish laptop computers and an internet connection for each lesson. Training will be conducted in Myanmar language. Lesson plans for each monthly course must be submitted to the U.S. Embassy one month before the training will take place. Handouts, reference guides, or other course takeaways will be prepared for each lesson and provided to all students by the contractor.

2.7 Technology Skills Training for Information Resource Center Staff: IRC staff will be trained in all of the above topics, so that they gain the same proficiency that the library patrons will gain. IRC staff training will be provided as a “training of trainers” so that IRC staff are able to guide other library patrons in these lessons and activities on their own in the future. The U.S. Embassy will furnish laptop computers and an internet connection for each lesson. Training will be conducted in Myanmar language. Lesson plans for each monthly course must be submitted to the U.S. Embassy one month before the training will take place. Handouts, reference guides, or other course takeaways will be prepared for each lesson and provided to all students by the contractor.

2.8 Lesson plans: Lesson plans for all courses must be furnished to the U.S. Embassy points of contact at least one month prior to the scheduled date of the training. Lesson plans shall include an overview of the class objectives, activities, and materials to be used. The U.S. Embassy reserves the right to request clarification or modification of any lesson plan not meeting the objectives outlined in this document.

2.9 Location: All lessons will be delivered at the American Center in Rangoon, #14 Taw Win Road, Yangon. Meeting room space will be arranged by the U.S. Embassy and may change from month to month depending on space availability.

2.10 Security: All contractors engaged in training at the American Center must be identified at least one week in advance of the training date and approved by U.S. Embassy personnel. Contractors who are not identified in advance will not be approved to enter the American Center. The U.S. Embassy will furnish laptop computers, an internet connection, and other materials (MakerSpace materials) identified in this document. Contractor and participants will not be allowed to bring other electronics into the American Center (including cell phones, USB drives, cables, computers, etc.) without prior approval. Requests to bring electronics into the American Center must be made at least one week prior to the scheduled training date. As noted above, some lessons may require downloading free software. Any software being downloaded to computers furnished by the U.S. Embassy must be identified and approved by the U.S. Embassy at least one week in advance of the training date. Nothing may be downloaded to computers furnished by the U.S. Embassy without prior approval. Contractor will be notified of any additional security guidelines imposed by the U.S. Embassy in the future.

2.11 Recruiting participants: The U.S. Embassy will be responsible for recruiting participants for each training. Participants will be accepted on a first come, first served basis. Participants must register in advance for each training. Participants must be American Center members.

2.12 Class size: Classes will be limited to a maximum of 20 students per training. Any class that has zero participants registered by the day before the training is to take place may be rescheduled for another date.

2.13 Class duration: Each training session will be scheduled for two hours at a time, delivered once per month. With five different training areas (MakerSpace, Digital Art, Computer Skills for Adults, Computer Skills for Youth, Tech Training for IRC Staff) each delivered once per month, contractor will be expected to provide 10 hours of training per month.

2.14 Schedule: Contractor and the U.S. Embassy will develop a mutually agreeable training schedule, based on classroom availability and other considerations noted above. In a given month, contractor will be expected to deliver five (5) trainings (MakerSpace, Digital Art, Computer Skills for Adults, Computer Skills for Youth, Tech Training for IRC Staff) for two hours each, for a total of 10 hours of training per month. The contract will cover a period of 12 consecutive months.

2.15 Required Qualifications: All trainers must have two years of experience providing training on these topics to public audiences with a range of skill levels.

52.217-5 EVALUATION OF OPTIONS (JUL 1990)

The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
