Re: Report on Responsible Investment in Burma

To Whom It May Concern:

Western Union Financial Services, Inc., hereby submits the enclosed Report on Responsible Investment in Burma, pursuant to the U.S. Department of the Treasury, Office of Foreign Assets Control Burmese Sanctions Regulations General License No. 17 and the U.S. Department of State's "Reporting Requirements on Responsible Investment in Burma" issued on May 23, 2013. Western Union's operations in Burma include the payment of commissions to our Burmese agents for money transfers into Burma. We do not believe that these payments constitute a "new investment" in Burma as defined by 31 C.F.R. 537.311. However, Western Union is submitting this report out of an abundance of caution that the State Department might consider these payments to constitute a "new investment." The aggregate payment of commissions to our Burmese agents exceeds \$500,000.

Western Union's money transfer services are provided in Burma in accordance with the U.S. Department of the Treasury, Office of Foreign Assets Control Burmese Sanctions Regulations General License No. 16.

4. Overview of Operations in Burma

a. Name(s) of companies, including all subsidiaries, operating in Burma covered by this report.

Western Union provides its financial products and services through a network of agents or authorized delegates in Burma. Western Union has a contractual relationship with the agent entities to offer its services but does not own any companies or subsidiaries in Burma. In addition to those entities listed in the report filed by Western Union on January 21, 2014, the following entities are now Western Union's Authorized Delegates in Burma:

Myanmar Livestock and Fisheries Development Bank Limited
Yoma Bank Limited

b. Nature of business in Burma:

There have been no changes to the nature of Western Union's business conducted in Burma since its January, 2014 report.

Western Union is a leader in the global money transfer — or remittance — industry. The Company provides consumers with fast, reliable and convenient ways to send

and receive money through more than 520,000 locations in over 200 countries and territories. Western Union promotes global economic opportunity and growth by bridging gaps in the financial services sector. By deploying powerful new ways to send and receive funds – even in areas lacking traditional financial infrastructure – we foster financial inclusion and growth, helping to improve lives and livelihoods.

Western Union is a money services business (MSB) with three primary characteristics that distinguish it from other types of financial services providers: (1) transactions are usually conducted in cash; (2) services are provided through a broad network of Authorized Delegates; and (3) consumers generally do not have “accounts” with Western Union as that term is traditionally understood in the banking industry, but rather use Western Union services on a one-time or per-transaction basis.

Western Union is based in the United States and has operations or subsidiaries located throughout the world. The company and its U.S. Authorized Delegates are subject to regulation under U.S. federal anti-money laundering laws – most prominently the Bank Secrecy Act – and state-specific laws. Outside of the U.S., Western Union Authorized Delegates are generally licensed entities and are subject to direct laws and regulations by local authorities.

5. Human Rights, Worker Rights, Anti-Corruption, and Environmental Policies and Procedures

a. Due diligence policies and procedures that address operational impacts on human rights, worker rights, and/or the environment in Burma.

In order to minimize reputational and other risks such as anti-money laundering and terrorist financing, Western Union must engage reputable Agents that will adhere to ethical business standards and comply with applicable legal requirements. Prior to entering into a relationship with new Agents, as well as upon contract renewal and other triggering events (e.g., a change of ownership as it is reported by the Agent,) Western Union conducts due diligence against its own set of fit and proper criteria, including ownership structure and type and nature of the business of the Agent, and will perform research to confirm that information provided by the potential agent is consistent with that in the public domain. All potential agents are checked against the U.S. Department of Treasury's Office of Foreign Assets Control (OFAC) Specially Designated Nationals and Blocked Persons List and other appropriate government sanctions lists, as well as screened for Politically Exposed Person (PEP) status. Western Union conducts Agent oversight through periodic compliance program reviews that determine whether an Agent is compliant with applicable regulatory requirements and Western Union policy.

b. Policies and procedures that address anti-corruption in Burma.

Western Union maintains a comprehensive anti-corruption policy that governs its international operations. The policy requires Western Union, its employees and business partners to comply with the requirements of the Foreign Corrupt Practices Act, the UK Bribery Act, and similar laws in all the countries in which Western Union operates.

Not applicable. Burmese agents or Authorized Delegates are not WU subsidiaries. WU has a contractual relationship with these entities to offer its products and services and consequently, has no control over their employee grievance procedures. Employees of the Burmese agents are not WU's employees. WU does not currently have an office or employees in Burma.

Human Rights

Human Rights and Employment

At Western Union, our commitment to human rights is consistent with our emphasis on promoting respect for one another and for the consumers and communities we serve. We reflect these enduring values in our corporate policies and in our Code of Conduct.

We respect universal human rights, which benefits both our employees and the communities in which we operate. We condemn the use of forced labor and exploitative child labor. We do not use forced or involuntary labor of any type. We comply with applicable local, state and national laws regarding the employment of minors.

Human Rights in Our Supply Chain

Human rights is an important, complex and evolving topic. We make a point of staying abreast of developments in this area, referencing the United Nations Guiding Principles on Business and Human Rights, attending sessions on the topic at major global gatherings such as the Clinton Global Initiative and Business for Social

Responsibility (BSR), and engaging in ongoing dialogue with a variety of internal and external stakeholders.

As these issues and our business evolve, we plan to continue our efforts to seek appropriate and effective methods to integrate respect for, and promotion of, human rights across our business operations. While we do not currently integrate explicit additional human rights clauses into all Company contracts or significant agreements, we do require counterparties to agree to comply with applicable law.

Anti-Corruption

Western Union provides Consumer-to-Consumer, Consumer-to-Business, and Business-to-Business services. The Company manages reputational risk across all three segments.

We believe that corruption has a corrosive effect globally on economies and societies and locally on communities and individuals. As a U.S.-based company that operates in more than 200 countries/ territories around the world, Western Union is subject to the U.S. Foreign Corrupt Practices Act and as well as the anti-corruption regulations of other nations, including the UK's Bribery Act.

The risk of corruption is measured and addressed by the Company in a number of ways, including:

- Using risk indicators from organizations like Transparency International in our global and country-specific risk assessments
- Addressing corruption risk in our Enterprise Risk Management and Ethics Committee discussions,
- Training all employees on anti-corruption and anti-bribery principles and policies annually.

Through this process 100% of our business units are analyzed for risks related to corruption.

Western Union has shared values and a commitment to a culture of ethics and integrity. The Western Union Code of Conduct provides guidance to all employees in fulfilling their responsibility for compliance with Company policy and the laws and regulations that apply to our business around the world. Every employee receives Code of Conduct training and every employee is required to certify each year that

s/he has read, and agrees to comply with, the Code, which has been translated into nine languages. Western Union sponsors multiple programs and resources for employee compliance education as well as established channels to ask questions or raise concerns. The annual performance evaluation of each employee includes a rating on the Culture of Compliance performance objective.

We strive to create a company culture that rejects corruption, including any form of bribery, and we comply with anti-bribery laws in all the countries where we work. We forbid Western Union employees from making, offering, or promising anything of value, including the provision of any service, gift or entertainment, to government personnel or officials for the purpose of improperly obtaining or retaining business, or for any other improper business advantage. Our Anti-Corruption Policy and Code of Conduct explicitly outline our commitments to these principles. Our Anti-Corruption Policy includes advice and guidance on gifts, and we encourage all Western Union employees to check with the General Counsel's office where gifts fall outside the guidelines, or at other times, for example, where there is concern about the timing of the gift.

We also forbid making improper payment through third parties. We require that all business units keep accurate books and records so that payments are recorded honestly and that funds are not used for an illegal purpose. This financial documentation is audited annually when we release our financial statements publicly.

Training for Ethics and Compliance

To maintain a global culture of compliance, each Western Union employee must complete a series of annual training courses based on their positions in the Company and their respective areas of responsibility. Each year, employees participate in stand-alone training sessions, each of which covers one or more of the following critical topics: Anti-Money Laundering Risks, Security Awareness, Preventing Workplace Harassment, Insider Trading, Fair Competition, Privacy and Information Management, Anti-Bribery and Corruption, as well as training on the Code of Conduct and Ethical Decision Making.

All global employees are required to participate in the Global AML Compliance Employee Training Program. Since this training is required for all employees, we strive to make it as accessible as possible. The training is delivered in five languages and is available via our intranet and/or through in-person trainings,

depending on the location. In 2012, we introduced a four-course curriculum, and achieved a 100 percent completion rate.

Western Union employs a two-phase online training program that complements the Code of Conduct. In year one, employees receive training on a basic Code of Conduct introduction, and in year two they are trained on ethics-related issues such as Speaking Up, Conflicts of Interest, and Gift Giving and Receiving. This phased approach is repeated throughout each employee's tenure with the company. In 2011 and 2012, 100% and 91% of employees completed this training, respectively.

In addition, members of the Ethics Office have been conducting face-to-face training in many of the offices, re-emphasizing the above mentioned issues, and encouraging employees to speak up in the event that they have concerns about potential wrong-doing.

All employees worldwide are required to complete a Code of Conduct certification every year. The trainings and Code emphasize a number of important issues, including the Company's commitment to not retaliate against employees for concerns raised in good faith. This stance is reinforced by Western Union senior leadership, who actively encourage open and transparent communication. Our CEO repeatedly invites questions and comments from employees at all levels, holds small-group and town-hall meetings and urges employees to engage in "skip-level" dialogue to ensure all voices are heard.

Sustainability and Environmental Conservation

At Western Union, we recognize that environmental stewardship is part of a progressive journey, and an important part of our Company's broad responsibility commitment. We have shaped an initial strategy, which will help us make progress on our programs and reporting. Over time, our goal is to drive environmental excellence throughout our Company, and to assess the ways we might have a positive secondary impact by engaging with our suppliers, business partners and employees in this area.

In 2011 and 2012, we generated \$5.5 billion and \$5.7 billion in revenue, respectively, and had a brand presence in 200 countries and territories. Yet, because of the nature of our operations, we have a lighter environmental footprint than many other corporations of a similar size. As of January 2013, our workforce numbered fewer than 9,000 employees, a relatively modest number. We own only five facilities, and like others in the financial services sector, our business is in many

ways “virtual,” with a growing focus on digital channels. Much of our work – ranging from consumer money transfers to web-based small business services – is conducted via computer networks. Like most companies in the financial services sector, data centers and the energy required to power them represent one of our greatest environmental impacts.

We are committed to reducing our environmental footprint by adopting commonly-accepted principles and practices. We began with a simple but impactful framework: reduce, recycle, and reuse.

When implementing environmental efforts against this framework, we have focused most on the areas in which Western Union has direct control. These include our owned facilities, our information technology network, our business activities and our engagement with employees.
