1. SCOPE OF SERVICES

1.1 The Contractor shall perform painting and related services for real properties owned or managed by the U.S. Government located at the following addresses:

Chief of Mission Residence (CMR) - 500 Lisgar Road, Rockcliffe Park, Ottawa
Deputy Chief Residence (DCR) – 46 Rockcliffe, Rockcliffe Park, Ottawa

1.2 This is a firm-fixed price type of contract.

2. CONTRACT PRICE - GENERAL

2.1 The Contractor shall complete all work, including furnishing all labor, material, equipment and services, required under this contract, for painting services. The price listed below shall include all labor, materials, overhead (including cost of Workers' Compensation and War-Hazard Insurance, which shall not be a direct reimbursement) and profit.

2.2 All prices are in Canadian dollars and the Government will make payment in Canadian dollars.

2.3 VALUE ADDED TAX

VALUE ADDED TAX (VAT). The Contractor shall include VAT as a separate charge on the Invoice and as a separate line item in Section B.

3. PRICE

The Contractor shall provide painting services required under this contract for the following firm fixed price and within the time specified. This price shall include all labor, materials, overhead and profit.

3.1 CMR Metal Fence Painting (See Technical Specifications for Painting Work under Section 4.2)

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, and employees, or any other person, arising from and incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising therefrom, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

7.2 Government as Additional Insured

The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

7.3 Insurance-Related Disputes

Failure to agree to any adjustment contemplated under this contract regarding insurance shall be a dispute within the meaning of FAR 52.233-1, Alternate I, "Disputes". Nothing in this clause shall excuse the Contractor from proceeding with the work, including the repair and/or replacement as herein above provided.

7.3 Time for Submission of Evidence of Insurance

The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. Failure to timely submit this evidence, in a form acceptable to the Contracting Officer, may result in rescinding or termination of the contract by the Government.

8. LANGUAGE PROFICIENCY

The project manager assigned by the Contractor to superintend the work on-site, as required by 52.236-6, "Superintendence by the Contractor", shall be fluent in written and spoken English.

9. LAWS AND REGULATIONS

9.1 Compliance Required

The Contractor shall, without additional expense to the Government, be responsible for complying with all host country laws, codes, ordinances, and regulations applicable to the performance of the work, and with the lawful orders of any governmental authority having jurisdiction. Host country authorities may not enter the construction site without the permission of the Contracting Officer. Unless directed by the Contracting Officer, the contractor shall comply with the more stringent of:

- (a) the requirements of such laws, regulations and orders; or
- (b) the contract.

If a conflict among the contract and such laws, regulations and orders, the Contractor shall promptly advise the Contracting Officer of the conflict and recommend a proposed course of action for resolution by the Contracting Officer.

9.2 Labor, Health and Safety Laws and Customs

The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

9.3 Evidence of Compliance

The Contractor shall submit proper documentation and evidence satisfactory to the Contracting Officer of compliance with this clause.

10. SAFETY – ACCIDENT PREVENTION

- 10.1 General. The Contractor shall provide and maintain work environments and procedures that will:
- (1) safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to contractor operations and activities;
 - (2) avoid interruptions of Government operations and delays in project completion dates; and
 - (3) control costs in the performance of this contract.

For these purposes, the Contractor shall:

- (a) Provide appropriate safety barricades, signs and signal lights;
- (b) Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and
- (c) Take any additional measures the Contracting Officer determines to be reasonably necessary for this purpose.

10.2 Records. The Contractor shall maintain an accurate record of exposure data on all accidents incident to work performed under this contract resulting in:

- (1) death,

- (2) traumatic injury,
 - (3) occupational disease, or
 - (4) damage to or theft or loss of property, materials, supplies, or equipment.
- The Contractor shall report this data as directed by the Contracting Officer.

10.3 Subcontracts. The Contractor shall be responsible for its subcontractors' compliance with this clause.

10.4 Written Program. Before starting the work, the Contractor shall:

- (1) Submit a written proposal for implementing this clause; and
- (2) Meet with the Contracting Officer to discuss and develop a mutual understanding of the overall safety program.

10.5 The Contracting Officer shall notify the Contractor of any non-compliance with these requirements and the corrective actions required. The Contractor shall immediately take corrective action after receiving the notice. If the Contractor fails or refuses to promptly take corrective action, the Contracting Officer may issue an order suspending all or part of the work until satisfactory corrective action has been taken. The Contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule for any suspension of work issued under this clause.

11. CONSTRUCTION PERSONNEL

11.1 Removal of Personnel

The Contractor shall:

- (1) maintain discipline at the site and at all times;
- (2) take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or amongst those employed at the site; and
- (3) take all reasonable precautions for the preservation of peace and protection of persons and property in the neighborhood of the project against unlawful, riotous, or disorderly conduct.

The Contracting Officer may require, in writing, that the Contractor remove from the work any employee that the Contracting Officer determines:

- (1) incompetent,
- (2) careless,
- (3) insubordinate or
- (4) otherwise objectionable, or
- (5) whose continued employment on the project is deemed by the Contracting Officer to be contrary to the Government's interests.

11.2 Construction Personnel Security

After award, the Contractor has ten (10) calendar days to submit to the Contracting Officer the following requirements for the Government to conduct all necessary security checks: (1) list of workers and supervisors assigned to this project, and (2) completed Authority for Release Information of each personnel. The Contractor shall use the form provided under Section I, Attachment 5.

Failure to provide any of the above information may be considered grounds for rejections and/or resubmittal of the application. Once the Government has completed the security screening and approved the applicants a badge will be provided to the individual for access to the site. This badge may be revoked

at any time due to the falsification of data, or misconduct on site. These passes must be displayed visibly by all Contractor personnel working on site. The Contractor shall inform its employees to be used under this contract that they may be subject to search by the Government when entering or leaving work. The Contractor shall return all passes upon conclusion of the contract.

12. MATERIALS AND EQUIPMENT

12.1 General. The Contractor shall provide all necessary painting supplies and equipment, including brushes, rollers, buckets, mixers, space heaters, drop cloths, scrapers, sanding gear, electric sprayers, and texture sprayers if necessary to perform the work. No materials will be furnished by the Government.

12.2 Selection and Approval of Materials

1. Standard of quality. All materials and equipment incorporated into the work shall be new and for the purpose intended, unless otherwise specified, and all workmanship shall be of good quality and performed in a skillful manner as determined by the Contracting Officer.

2. Selection by Contractor. Where the contract permits the Contractor to select products, materials or equipment to be incorporated into the work, or where specific approval is otherwise required by the contract, the Contractor shall give the Contracting Officer, for approval:

- (a) the names of the manufacturer;
- (b) model number;
- (c) source of procurement of each such product, material or equipment; and
- (d) other pertinent information concerning the:
 - (i) nature,
 - (ii) appearance,
 - (iii) dimensions,
 - (iv) performance,
 - (v) capacity, and
 - (vi) rating,unless otherwise required by the Contracting Officer.

3. The Contractor shall provide this information in a timely manner to permit the Government to evaluate the information against the requirements of the contract.

The Contractor shall provide a submittal register ten (10) days after contract award showing when shop drawings, samples, or submittals shall be made. The Contractor shall submit samples for approval at the Contractor's expense, with all shipping charges prepaid, when directed to do so by the Contracting Officer or COR. Installation or use of any products, materials or equipment without the required approval shall be at the risk of rejection.

12.3 Custody of Materials

The Contractor shall be responsible for the custody of all materials received for incorporation into the project, including Government furnished materials, upon delivery to the Contractor or to any person for whom it is responsible, including subcontractors. The Contractor shall deliver all such items to the site as soon as practicable. If required by the Contracting Officer, the Contractor shall clearly mark in a manner directed by the Contracting Officer all items of which the Contractor has custody but which have not been delivered or secured at the site, clearly indicating the use of such items for this U.S. Government project.

13. WARRANTIES

Under FAR 52.212-4, Contract Terms and Conditions-Commercial Items, the Contractor warrants items and services provided. The Contractor shall obtain and furnish to the Government all information that is required in order to make any subcontractors, manufacturers, or supplier's guarantee or warranty legally binding and effective. The Contractor shall submit both information and the guarantee or warranty to the Government in sufficient time to permit the Government to meet any time limit requirements specified in the guarantee or warranty, but not later than completion and acceptance of all work under this contract.

14. PAYMENT SCHEDULE AND INVOICE SUBMISSION (FIXED-PRICE)

(a) General. The Government shall pay the Contractor as full compensation for all work required, performed, and accepted under this contract the firm fixed-price stated in this contract.

(b) Invoice Submission. The Contractor shall submit invoices in an original copy to the U.S. Embassy/Ottawa, Financial Management Center: P.O. Box 866, Station B, Ottawa, ON, Canada, K1P 5T1. To constitute a proper invoice, the invoice shall include all the items required by FAR 32.905(e).

The contractor shall show VAT as separate charge on invoices submitted.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. APPLICABLE PAINTING STANDARDS/PAINT SPECIFICATIONS

Painting and preparatory work shall follow technical specifications described under Section 4.

2. UTILITIES

The Government cannot ensure that utilities will be available at all properties at all times. The Contractor shall have an alternate source of power (generator) available if needed to ensure that paint will be applied following the manufacturer's specifications. The Contractor shall not adjust the heating or air conditioning controls in properties with utilities turned on to maintain temperature. The Contractor shall have its own source of water available for clean up if water has been turned off in the property for winterization of the plumbing system.

3. EQUIPMENT

The Contractor shall provide all necessary painting supplies and equipment, including brushes, rollers, buckets, mixers, space heaters, drop cloths, scrapers, sanding gear, electric sprayers, and texture sprayers if necessary to perform the work. The Government will not furnish any materials.

4. TECHNICAL SPECIFICATIONS FOR PAINTING WORK

4.1 General Requirements

4.1.1 The Contractor shall furnish sufficient personnel with the technical knowledge and experience necessary to complete the work. The Contractor shall obtain, maintain and pay for all national, provincial and local insurance's, licenses, permits, and certificates needed /required to perform the work prior to commencement and for the duration of the work.

4.1.2. Access Provisions: The Contractor shall provide all tools and materials required to perform the work and facilitate its inspection during installation.

4.1.3 All work shall be accomplished according to all national, provincial and local building, fire, environmental, health and safety codes. Detailed product specifications, material samples and MSDS, shall be submitted upon request from the CO.

4.1.4 Project time schedule shall be prepared in coordination with the Contracting Officer's Representative who will coordinate with the occupant of the residence.

4.1.5 Contractor shall sand and prime all rusted and peeling area prior to paint the fence.

4.2 CMR Metal Fence Painting

The contractor shall furnish all labour, materials and equipment to perform the following work requirements:

4.2.1 **Painting specifications:** All exposed metal shall be primed whit red oxide primer (or an equivalent) with a finish of two coats of paint on primed area and one coat on the remaining of the fence of high quality exterior paint. A finished sample will be provided for the Contracting Officer or COTR's approval prior to painting the fence.

4.2.2 Approximately 620 meters of fence shall be given to the contractor that will receive this painting project:

Fence on wall:	120 meters
Fence 8" spaces:	420 meters
Fence 4" spaces:	80 meters
Gates:	3 gates

4.3 DCR Exterior Wood Cladding Painting

The contractor shall furnish all labour, materials and equipment to perform the following work requirements:

4.3.1 **Painting specifications:** All exposed wood shall be primed with an exterior primer and with a finish of two (2) coats of paint on primed area. A minimum of one (1) coat on the remaining of the wood surfaces shall be applied with a good quality exterior paint. A finished sample will be provided for the Contracting Officer or COR's approval prior of painting the remaining of the wood.

4.3.2 All surfaces specified to be painted shall be dry and cleaned free of all dirt, grit, grease, mold, mildew, foreign substances and all loose, peeling, blistering, chalking or scaling paint.

4.3.3 Each coat of paint shall be evenly worked out and allowed to dry according to the manufacturer's recommendations before subsequent coats are applied.

4.3.4 Finish coat or coats of paint shall be of the exact shade or shades, texture and consistency as approved by the COR. The Contractor shall not change the color of any paint that has already been approved by the COR unless authorized to do so in writing.

4.3.5 The finished work shall be free from runs, sags, defective brushing or stippling, and clogging of lines and angles of the trim.

4.3.6 It shall be distinctly understood that the number of coats of material recommended by the Manufacturer specifies a minimum. Even with a material of specified quality, mere applications of the stated number of coats will not assure acceptance, unless a sample of the quality of the workmanship and the hiding qualities of the work is approved by the COR.

4.3.7 The thinning of good material for additional coverage, the use of poor materials and the adulteration with inferior substitute materials is not be permitted. A full-bodied finish of the paint surface is required under this contract regardless of the number of coats necessary to accomplish the result.

4.3.8 All products are to be delivered to the site with the manufacturer's label affixed to the original unopened container.

4.3.9 Painting and finishing products for use in the work shall be the standard best or top brands produced for each particular kind of material required herein. The products shall also comply with the applicable federal specifications and shall be equal to the product of one of the following manufacturers:

4.3.10 FILLING

All holes, cracks and marks should be repaired with fillers, sealant, putties or grouting cements as appropriate for the finishing system and substrate, and treat to achieve the required finish in accordance with industry standards before painting. Tint the filler to match substrate if the finish is transparent.

4.4 Contractor Responsibility

4.4.1 Provide a written two-year warranty on materials and workmanship, from the date of project's completion and acceptance.

4.4.2 Provide manufacturer's warranty on materials.

4.4.3 All repairs shall be approved, inspected and brought to total satisfaction of the Contracting Officer or Contracting Officer's Technical Representative.

4.4.4 Before any kind of work including painting, the Contractor shall protect stonewall, patio and any other surface from damage or spoilage. The Contractor shall be responsible for any damage caused by a lack of protection or negligence to the residence and or surrounding property.

4.4.5 The Contractor shall be responsible to maintain safe passage free of any debris or hazardous materials around the working area for all occupants and visitors to the residence to prevent any accident.

4.4.6 The Contractor shall be responsible for replacing any landscaping damaged due to Contractor's work or negligence in connection of the work.

4.4.7 The Contractor shall be responsible for the removal and disposal of all debris from the residence and surrounding yards. Clean up shall be conducted at the end of each workday and at the completion of the project.

4.4.8 The Contractor shall store any material for the project in an area designated by the COTR. The Contractor shall park all vehicles only in areas designated by the occupants or Contracting Officer's Representative.

4.4.9 The Contractor shall schedule all work during the weekdays, Monday through Friday, between the hours of 8am and 5pm. Any changes in the work schedule must be approved by the CO or COTR.

4.4.10 Any changes to this Scope of Work shall have the approval, in writing, from the U.S. Government's Contracting Officer (CO) or the Contracting Officer's Representative (COR).

4.4.11 Provide warranty, in writing, on materials and workmanship, from the date of project completion.

4.4.12 Provide manufacturer's warranty on materials.

5. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP).

5.1 This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

7.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

7.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

7.4. Procedures

7.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

7.4.2 The COR will complete appropriate documentation to record the complaint.

7.4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

7.4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

7.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

7.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

7.4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

7.4.8 Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
