1. PERFORMANCE WORK STATEMENT

1.1 The purpose of this firm-fixed price contract is for the contractor to provide Media Monitoring Services for U.S. Embassy Public Affairs Section in accordance with Attachment 1, Description/Specifications/Work Statement described under this contract.

1.2 The contract will be for a one-year period from the date of contract award, with four (4) one-year options to renew.

1.3 The prices listed below shall include all labor, materials, overhead, profit, transportation and administration necessary to perform the required services described under Section I.A.

1.4 All prices are in Canadian dollars.

1.5 Temporary Additional Services are services related to broadcast media monitoring services and copyright fees for downloading clips in accordance with the terms of CBC Broadcast Monitoring, Canadian Broadcast Rights Agency (CBRA) and Cable Public Affairs Channel (CPAC).

Because Temporary/Additional Services are based on indefinite delivery/indefinite quantity the minimum and maximum amounts are defined below:

Minimum: The Government shall place orders totaling a minimum amount CAD\$10.00. This reflects the contract minimum for the base year and option period.

Maximum: The amount of all orders shall not exceed CAD\$5,000.00. This reflects the contract maximum for the base year and each option period for temporary additional services.

**ATTACHMENT 1
SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20
DESCRIPTION/SPECIFICATIONS/WORK STATEMENT**

1. Scope and Description of Services

The U.S. Embassy Ottawa, Public Affairs Section, located at 490 Sussex Drive, Ottawa, Ontario, has a requirement for Broadcast Media Monitoring Services to include broadcast monitoring of TV and radio for 2-10 direct users, access to full radio transcripts, radio auto clips and TV video clips on a real-time basis, written transcripts on real-time daily basis and licenses to obtain access to the source of information online.

1.1 Geographic Coverage. Global coverage by Canadian media outlets in English and French.

1.2 Historical Data. Users shall have access to reports on profile's entire history and shall be immediately available. Also, long-range historical data shall be available upon request.

1.3 Users. The initial deployment of the broadcast media monitoring services shall be able to accommodate 2 active users and up to 10 active user base if it is scaled up to additional services.

1.4 Data Manipulation. Users shall be able to manipulate data generated by broadcast media monitoring tool to produce summaries and reports.

1.5 Complimentary Trial. The contractor shall provide complimentary trial for broadcast monitoring for TV & radio for a period two weeks prior to commencement of services under this contract at no additional charge to the Government. The contractor shall provide the point of contact for this trial session.

2. Customer Support and Training

The contractor shall assist with the installation and configuration of the broadcast media monitoring tool. The contractor shall be able to provide hands-on training and other instructional resources for users.

3. Work Hours

Services shall be provided and made available to Public Affairs Section 24 hours a day, 7 days per week. The contractor shall notify the Contracting Officer's Representative (COR) or any authorized representative from Public Affairs Section within 48 hours of any service maintenance that would require the service to be temporarily out of service. The contractor shall be available by phone or e-mail on any technical support as needed.

4. Key Personnel

The Project Manager must be able to converse in English. The Contractor shall assign to this contract the following key person:

5. QUALITY ASSURANCE PLAN (QAP).

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. **STANDARD.** The performance standard is that the Government receives no more than one (1)

customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(B) The IRS has filed a notice of Federal tax lien with respect to an assessed tax liability, and the taxpayer has been issued a notice under I.R.C. §6320 entitling the taxpayer to request a hearing with the IRS Office of Appeals contesting the lien filing, and to further appeal to the Tax Court if the IRS determines to sustain the lien filing. In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. §362 (the Bankruptcy Code).
