2. Work Requirements

2.3 The U.S. Embassy shall be the Contractor's first pick up of the day so that the Contractor's vehicle/truck container is empty on arrival to accommodate security inspection by the Local Guard Force (LGF). The contractor's vehicle/truck shall not be permitted to enter the Chancery Garage. The contractor's vehicle/truck shall be parked on York Street and after satisfactory inspection by LGF shall proceed to the garage apron.

3) The submission due date and time of November 21, 2012, no later than 4:00 P.M. remains the same.
