I. PERFORMANCE WORK STATEMENT

Purpose and Audience

The U.S. Foreign Agricultural Service in Canada (FAS) seeks to develop a website that will provide information on U.S. agricultural products to both consumers and the trade as well as a related Public Relations campaign to raise awareness of the site once it is ready to launch. The website will also function as a portal that links to the website of the approximately 40 U.S. commodity groups that engage in marketing activities in Canada.

Background

A business website will allow FAS Canada to maximize the reach of its marketing activities. The website will be useful and appealing to two distinct groups – consumers and the trade. In addition, it will act as a centralized portal to link to information on the agricultural commodity groups active in Canada and to provide information on U.S. agricultural products. The website will allow for more cohesive messaging as it will provide a single information source to promote.

FAS Canada previously worked with a communications firm to develop the following logo representing the U.S. Food and Beverage Alliance in Canada. Over the last several years, the logo has been used in various retail promotions and other events to promote U.S. food and beverage products. This is the logo that will be used on the site. FAS Canada will be using the site to complement its future activities.



The project will be contracted to a Public Relations firm as they will serve to coordinate all technical and creative aspects of this assignment. In addition, the firm will launch the site to the trade and consumer markets in Canada. FAS Canada will oversee each phase of the project. After the launch, FAS Canada will be responsible for managing the site. WordPress is the preferred Content Management System (CMS) for this site. The chosen contractor will need to provide FAS Canada with all relevant logins and a backup copy on DVD-ROM. It is essential

that the website have a main page that allows for content to be changed and updated. Links to the commodity groups' pages also need to be included. Any final products as a result of this project will be property of FAS Canada.

Description of Work

The contractor shall be responsible for developing, implementing, and launching the *tasteUS!* website within the period of this contract. The contractor shall provide all materials and personnel, except where noted otherwise.

- a. Develop a plan for coordinating the information from all of FAS Canada's cooperator groups on the website to provide for coherent messaging.
- b. Identify a technical partner that is well established in its field to develop the website.
- c. Provide FAS Canada with hosting options that take into account privacy and security concerns. The Government will provide the domain for this project.
- d. Ensure site provides efficiency and ease of use. This will most likely include designing new graphics and/or User Experience layouts. Site must be adaptable and able to interface with other applications. This will include allowing for automatic updates from other sites where applicable.
- e. Utilize WordPress as CMS to allow FAS Canada staff to update content
- f. Include a "Search" function for the entire site
- g. Organize site to maximize Search Engine Optimization. This includes initial set up of a Google Analytics account.
- h. Work with FAS Canada to develop initial content to be posted.
- i. Ensure the web content maximizes brand value messaging and engages visitors with the site. Assure that it is not just a collection of links to the cooperator groups.
- j. Ensure all material on site is used with permission.
- k. Once the website is established appointed public relations firm will be expected to launch site through key trade and consumer channels.
- l. Train FAS Canada to manage website after period of this contract.
- m. Provide for a post-launch follow up and review to ensure website functions properly.
- n. Final approvals to be made by FAS Canada technical evaluation panel.

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Inverted domestic corporation”, as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), *i.e.*, a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at [26 U.S.C. 7874](#).

- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and

(10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (iii) Each service employee who will perform the services under the contract will spend only a small portion of his or her time (a monthly average of less than 20 percent of the available hours on an annualized basis, or less than 20 percent of available hours during the contract period if the contract period is less than a month) servicing the Government contract; and

(iv) The compensation (wage and fringe benefits) plan for all service employees performing work under the contract is the same as that used for these employees and equivalent employees servicing commercial customers.

(d) Notice.

(1) If this solicitation is for supplies and has been set aside, in whole or in part, for small business concerns, then the clause in this solicitation providing notice of the set-aside contains restrictions on the source of the end items to be furnished.
