**DUE DATE FOR PROPOSALS:**

The due date for delivery of proposals is revised to **Friday, March 28th, 2014**. Consequently, the proposal submission instructions are revised as follows:

1. Due Date: The due date for delivery of the proposals is extended to **Friday, March 28th, 2014**. In order to be accepted, proposals must be received by the Embassy no later than 2:00 p.m. local (Bogota, Colombia) time. Any proposal received after the 2:00 p.m. deadline will not be accepted.
2. Questions: Submit any questions you may have concerning the solicitation documents in writing, in English, to John Lopez at [lopezjpx@state.gov](mailto:lopezjpx@state.gov), with copy to [gaspardrc@state.gov](mailto:gaspardrc@state.gov), by **Wednesday March 19, 2014** at 12:00 pm. Responses will be posted on the website with the solicitation.
3. Site Visit: If you intend to submit a proposal, you should thoroughly examine all documents contained in the contract solicitation package. The Embassy intends to conduct a site visit (see L.6, FAR 52.236-27) and hold a pre-proposal conference. All prospective offerors are invited to attend. One conference was held at DIRAN Base in Tulua on **February 6, 2014** at 9:00am and a second conference will be held at DIRAN Base in Necocli on **March 11, 2014** at 8:00 am. If you plan to attend the second conference in Necocli, you must confirm your attendance with John Lopez at [lopezjpx@state.gov](mailto:lopezjpx@state.gov) with your name, cedula number (ID number), cell phone number, email and the name of company you represent before Wednesday **March 05, 2014** at 12:00pm. Please note that site visit attendance is not mandatory in order to submit a proposal and be considered for award.
