The Performance Work Statement has been modified to add the following paragraph:

2.2.4 Driver Training, Testing, and Licensing. Contractor shall perform administrative functions to facilitate the training, testing, and licensing of Contractor and Assistance in Kind (AIK) drivers for USMILGP LOGMIS licenses IAW AR 600-55, The Army Driver and Operator Standardization Program (Selection, Training, Testing, and Licensing), Smith System Driver's Training and local US Embassy and USMILGP directives. The Contractor shall perform the following:

- a. Process requests for initial and/or updated OF 346, and USMILGP Operator Permits Motor Vehicle Operator's Identification Card, from authorized personnel to include military, DA civilian, FSN and contractor-employed personnel.
- b. Process DA Form 348, Equipment Operator's Qualification Record, for authorized personnel IAW AR 600-55.
- c. Annotate on DA Form 348 with the driver training and instruction received by personnel. Verify that training/instruction was provided by a qualified driver training instructor.
- d. Verify requests for appointment of contractor-employed driving instructors to ensure personnel are qualified IAW AR 600-55.
- e. Maintain file copies of appointment orders of personnel designated as driving instructors by USMILGP Commander and/or Chief, LOGMIS.
- f. Maintain files of DA Form 348 for personnel licensed by the USMILGP Motorpool Office.
- g. Conduct a driver safety/orientation class, designated as USMILGP Driver' Course. This class shall be provided at a minimum of one time per month. TASK class shall be provided to all contractor employed and assistance in kind drivers. The contractor master driver will assist the USMILG LOGMIS Master driver provide driver safety classes for US Military, DA civilian personnel, and other tenant and rotational exercise unit personnel, as required. TASK orientation class shall include, but is not limited to the following topics:
 - (1) USMILGP Driving rules and regulations
 - (2) Speed limits
 - (3) Safety awareness items and hazards for driving in Bogota and outside the city.
 - (4) Local driving laws in Colombia
 - (5) Procedures to follow if involved in an accident
 - (6) Provide the **Smith System Driver Improvement and Safety and Accident Avoidance Course** to contractor and AIK drivers. Procure training books for MILGP personnel

h. Provide drivers training for Light Armored Vehicles seating 6-11 passengers twice monthly. The class size is estimated to be 10 personnel per class.
