

The Solicitation is hereby amended as follow:

DUE DATE FOR PROPOSALS:

The due date for delivery of proposals is revised to **Friday, March 21th, 2014**. Consequently, the proposal submission instructions are revised as follows:

1. Due Date: The due date for delivery of the proposals is extended to **Monday, March 21th, 2014**. In order to be accepted, proposals must be received by the Embassy no later than 2:00 p.m. local (Bogota, Colombia) time. Any proposal received after the 2:00 p.m. deadline will not be accepted.
2. Questions: Submit any questions you may have concerning the solicitation documents in writing, in English, to John Lopez at lopezjpx@state.gov, with copy to gaspardrc@state.gov, by **Thursday March 13, 2014** at 10:00am. Responses will be posted on the website with the solicitation.
3. Site Visit: If you intend to submit a proposal, you should thoroughly examine all documents contained in the contract solicitation package. The Embassy intends to conduct a site visit (see L.6, FAR 52.236-27) and hold a pre-proposal conference. All prospective offerors are invited to attend. The conference will be at DIRAN Base in Tulua on **February 6, 2014** at 9:00am and at DIRAN Base in Necocli on **March 5, 2014** at 8:00am. If you plan to attend, you must confirm your attendance with John Lopez at lopezjpx@state.gov with your name, cedula number (ID number), cell phone number, email and the name of company you represent before Tuesday **February 4, 2014** at 2:00pm for Tulua and before Thursday **February 27, 2014** at 2:00pm for Necocli.
