B.1 Review the Office of Overseas Buildings Operations' draft of the Conditional Purchase Agreement and recommend revisions, if necessary, to conform to local law and protect the USG's interests. Acceptability will be determined by assessing the offeror's compliance with the terms of the RFQ.
