## SPECIFICATIONS/REQUIREMENTS

### VIDEO SURVEILLANCE SYSTEM WITH DUAL PAYLOADS FOR CESSNA AIRCRAFT

#### 1.0 SCOPE

1.1 The contractor shall provide all resources necessary to supply a dual video payload surveillance system on a Government supplied Cessna aircraft and provide familiarization training on the system's features and operating system. The system shall consist of a daylight telescope video sensor, a nighttime infrared video payload, the means to control both payloads from on board the aircraft, and a datalink to transmit the video to a ground station. The payloads shall be capable of being externally mounted on all of the following Cessna aircraft models: 182, 206, 208, and 208-B, shall be transportable between each of these aircraft models, and the external mount shall be authorized by and compliant with United States Federal Aviation Administration (FAA) procedures and directives.

1.2 The contractor shall demonstrate the installation process for the camera system in a Colombian-Government provided aircraft at an agreed location once the contract is awarded. The United States Military Group will facilitate with the coordination for this demonstration.

1.3 The contractor shall deliver the video receiving ground station in La Macarena, Meta, (LAMAC) Colombia. The MILGP will designate an area at LAMAC with appropriate space, infrastructure, and facilities to support the operation of the video receiving station, antenna, and communication link.

1.4 The Contractor is responsible for making transportation arrangements to and from LAMAC. The US Military Group can facilitate, if available, this transportation but it is the ultimate responsibility of the contractor to comply with the delivery of the goods. The US Military Group will provide accommodations for the contractors while forward deployed to LAMAC.

1.5 The COLMIL will provide security for contractor personnel while on-site at LAMAC. The COLMIL will provide access to telephone and internet communications for contractor personnel while onsite in LAMAC.

#### 2.0 SUPPLY A VIDEO SURVEILLANCE SYSTEM WITH DUAL PAYLOADS FOR CESSNA AIRCRAFT

2.1 The contractor shall supply and deliver a dual video payload surveillance system on a Government supplied Cessna aircraft.

2.2 The contractor shall supply an externally mounted daylight video payload with the following features and specifications on a Government supplied Cessna aircraft:

- High zoom (telescope) EO daylight imaging
- Gyro-stabilized with coordinate hold mode
- Include Advanced Video System (AVS) Video Processing Board
- Picture-in-picture (PiP)

2.4 The contractor shall supply on a Government supplied Cessna aircraft a Graphic User Interface (GUI) for daylight and nighttime video payload control and an AVS video processing board with the following features and specifications:

- Video Stabilization, Tracking

- Turret Video Auto-Track
- Digital Zoom
- Contrast Equalization
- Edge Enhancement
- Sharpening
- Noise Filtering
- False Colors for B&W Images
- Moving Target Indicator
- Moving Map
- Pass-Through Communication
- Ports & power: RS-232, Ethernet

Description:

The GUI and AVS shall be an in-line video processing board compatible with the video payloads. AVS shall remove jitter and other motion distortion, enhance images to provide persistent, “hands-off” surveillance, even at narrow fields of view, for extended time periods, and indicate moving targets in the image. It shall be of rugged designed to be installed on manned aircraft.

a. Image Stabilization and Tracking

- On board video processor that re-registers successive video frames.
- Eliminates blur due to vibration and residual motion and generates a steady image.
- Video processing able to follow a sub-image within the image.
- Aircraft broadcasts high-quality corrected video.
- Video processing corrections are used for turret Video Auto-Track.
- SCENE mode that uses the video stabilization corrections to drive the turret and eliminates the effect of gyro drifts and attitude error in GPS/Inertial control to provide persistent steady image.
- TRACK Mode that steers the turret towards the designated sub-image and allows for hands-free chase of vehicles
- Video Auto-Track that allows the user to operate hands-free at very narrow Field Of View, even in bumpy conditions.
- Ground Control Station need not include tracking software and video processing hardware.

2.5 The contractor shall supply one (1) tough book or ruggedized notebook computer per specifications stated under Par 2.7.A to host the GUI providing daylight and nighttime video payload control onboard the Government supplied Cessna aircraft. The computer shall be equipped with a hand controller computer game interface to manually control the pan, tilt, and zoom of the daylight and nighttime video payloads.

2.6 The contractor shall supply two (2) ea support pods housing the daylight and nighttime video payloads to attach them externally to the Government supplied Cessna aircraft. The support pods shall have the following features and specifications :

2.7 The contractor shall provide a tough book or ruggedized notebook computer with a Moving Target Indicator (MTI) software (Kestrel MTI or equal) for use on Full Motion Video (FMV), operating in real time with the video collected from the externally mounted daylight and nighttime video payloads.

The MTI shall meet the following minimum technical specifications:

## A. MTI Computer Hardware

- (a) Genuine Windows® 7 Professional, 32-bit, Intel® Core™ 2 Duo P8700 with VT (2.53GHz) UMA graphics with PC Card.
- (b) 2 GB RAM.
- (c) 14.1 inch WXGA LED display with DirectVue Technology.

## B. MTI Computer Software

- (a) Shall be able to assist normal airborne ISR operations, typically at altitudes between 1K and 40K ft and speeds between 0 and 400 kts.
- (b) Shall be able to operate on a baseline tough book computer or ruggedized notebook.
- (c) The imagery used for the baseline MTI will be Standard Definition (SD) video. SD resolution is 704 x 576 (0.4 Megapixels).

- (d) Shall be able to process analog video that is converted into Digital Video format by a Contractor- provided Analog-to-Digital Video Converter (ADVC) Canopus or equal.
- (e) Shall be able to process streaming video with MPEG-2, H.264 and H.262 encoded NTSC or PAL standard definition D1 video streams at 30fps (25 fps for PAL) via UDP Unicast, Broadcast, TCP/IP and UDP/IPV4 Multicast and process the video at 30fps (25fps for PAL). The MTI software must support a wide range of commercial video compression formats with a library of commercial CODECs.
- (f) Shall allow the operator to specify/select, at run-time, the IP address and port number of the desired stream on which to perform VMTI processing
- (g) Shall allow for the detection sensitivity to be adjusted in order to optimize the functionality based on the characteristics of the video in order to improve detections and decrease false alarms.
- (h) Shall be able to detect targets with a speed as low as 1.0 pixel per frame within the envelope specified
- (i) Shall be able to detect targets with a size of 2x2 pixels within the envelope specified and down to sub-pixel sizes under optimal conditions
- (j) The MTI software, while operating on board the baseline notebook computer described in #1 above, must be able to process imagery at a resolution of 704x576.
- (k) If a more capable computer is supplied, the MTI software shall be able to process full HD (1920x1080) imagery at 30 fps on a computer with an i7 processor. Also, with an i7 processor, the MTI software must be able to process 5 Mega Pixel imagery at 8 fps

2.8 The contractor shall provide an IP Adapter Assembly (IPA) and an on-board power supply to support the interconnection of the video payloads, pods, and the tough book or ruggedized notebook computer hosting the GUI and the onboard daylight and nighttime video payloads control.

2.9 The contractor shall supply a datalink operating in S band to downlink video from the Government supplied Cessna aircraft to the ground station at LAMAC.

2.9.1 The datalink system shall use a 10 Watt transmitter on S-band. Using this 10 Watt FM transmitter on S-band (2400 Mhz) with unity gain omni (blade antenna) on the pod on the aircraft and a 4 foot diameter dish (29 db gain) on a tracking pedestal with 2 db LNA at the antenna shall provide a 7 db margin at 70 KM.

2.9.2 The transmitter and receiver shall have 4 banks of channels with a total of 600 memory slots. It shall have the ability to load presets into one bank and install 1 Mhz steps across the entire band in the second memory bank.

2.9.3 The on board transmitter shall have the following specifications and shall reside in one of the externally mounted pods:

2.10 The contractor shall provide one (1) tough book or ruggedized notebook computer per specifications stated under Para 2.7.A where the GUI for the ground station for video reception shall reside and operate. The computer shall be connected to the datalink receiver and the contractor supplied tracking antenna.

2.11 The contractor shall install the video surveillance system on one (1) Government supplied Cessna model 182, 206, 208, or 208-B aircraft in Bogotá, Colombia.

2.12 The contractor shall install the ground station for video reception at a Government supplied room in LAMAC, Colombia. The Government shall supply adequate furniture for the room. The room shall have 110 V AC power and air conditioning.

2.13 The contractor shall verify that the system transmits video from the aircraft to the ground station in LAMAC, Colombia from a maximum distance from the aircraft of 70 Km.

2.14 The contractor shall provide a two (2) week period of familiarization and training in the use and set up of the system both on board the aircraft and at the ground station location in LAMAC.

**CLAUSES INCORPORATED BY FULL TEXT****52.204-99 SYSTEM FOR AWARD MANAGEMENT REGISTRATION (DEVIATION) (AUGUST 2012**

(a) *Definitions.* As used in this clause-

"Central Contractor Registration (CCR) database" means the retired primary Government repository for Contractor information required for the conduct of business with the Government.

"Commercial and Government Entity (CAGE) code" means-

(1) A code assigned by the Defense Logistics Agency (DLA) Logistics Information Service to identify a commercial or Government entity; or

(2) A code assigned by a member of the North Atlantic Treaty Organization that DLA records and maintains in the CAGE master file. This type of code is known as an "NCAGE code."

"Data Universal Numbering System (DUNS) number" means the 9-digit number assigned by Dun and Bradstreet, Inc. (D&B) to identify unique business entities.

"Data Universal Numbering System+4 (DUNS+4) number" means the DUNS number means the number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional SAM records for identifying alternative Electronic Funds Transfer (EFT) accounts (see the FAR at Subpart 32.11) for the same concern.

(a)(1) The Offeror certifies, to the best of its knowledge and belief, that-

(i) The Offeror and/or any of its Principals-

(A) Are ( ) are not ( ) presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any Federal agency;

(B) Have ( ) have not ( ), within a three-year period preceding this offer, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State, or local) contract or subcontract; violation of Federal or State antitrust statutes relating to the submission of offers; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, violating Federal criminal tax laws, or receiving stolen property (if offeror checks "have", the offeror shall also see 52.209-7, if included in this solicitation); and

(iv) In a criminal, civil, or administrative proceeding, a disposition of the matter by consent or compromise with an acknowledgment of fault by the Contractor if the proceeding could have led to any of the outcomes specified in paragraphs (c)(1)(i), (c)(1)(ii), or (c)(1)(iii) of this provision.

(2) If the offeror has been involved in the last five years in any of the occurrences listed in (c)(1) of this provision, whether the offeror has provided the requested information with regard to each occurrence.

(d) The offeror shall post the information in paragraphs (c)(1)(i) through (c)(1)(iv) of this provision in FAPIS as required through maintaining an active registration in the Central Contractor Registration database via <https://www.acquisition.gov> (see 52.204-7).

1. This source selection is conducted in accordance with Federal Acquisition Regulation (FAR) 15.3, Source Selection, as supplemented by the Defense Federal Acquisition Regulation Supplement (DFARS), and the Army Federal Acquisition Regulation Supplement (AFARS). Award will be made to a single offeror who is deemed responsible in accordance with the FAR, whose proposal conforms to the solicitation requirements, and whose proposal, determined by an overall assessment of the evaluation criteria and other considerations specified in this solicitation, represents the Lowest Priced Technically Acceptable offer.

2. The Government contemplates contract award **without discussions** with Offerors, except for clarifications as described in FAR Subpart 15.3. Therefore, the Offeror's initial proposal should contain the Offeror's best terms from a cost or price and technical standpoint. The Government reserves the right to conduct discussions if the Contracting Officer later determines them to be necessary. In the event that discussions are held, a competitive range determination will be made. Non-submission of any of these elements shall render the proposal technically unacceptable and shall not be considered for award. All of the sub-factors shall be clearly addressed in the proposal. The two technical sub-factors are as follows:

a. Sub-factor 1 Offeror's Technical Approach

The offeror's technical approach will be evaluated to determine if the offeror provided adequate and acceptable plans on how he will provide the requirements in the solicitation.

b. Sub-factor 2 Equipment/Parts List and Timeline

The offeror's proposal will be evaluated to determine if the offeror provided a timeline and a list of minimum equipment/parts required to achieve a fully functioning video surveillance system.

3. Factor II – Price

a. Price will not be assigned an adjectival rating. Price will be evaluated to determine if the offeror's proposed price is fair, reasonable, and balanced utilizing price analysis techniques in accordance with the guidelines in FAR 15.404-1(b). The Government will award contracts to offerors whose technically acceptable proposal represents the lowest price to the Government.

(B) The IRS has filed a notice of Federal tax lien with respect to an assessed tax liability, and the taxpayer has been issued a notice under I.R.C.
