La Macarena Defensive Positions

1) Question: The solicitation talks about a built of 160m²(8x20m) with two stories, each one of them with 4 meters, total height 8 meters. The question is if the inside structure covers the entire area 160m² and 2 stories complete area or like in the Exhibit 2 is a tower with those characteristics 2 stories 4m each one and cover with baskets and a fence around the tower cover complete area(8x20) as the same with baskets?

Response: Each defensive position shall have an inside area of 160 square meters. Each defensive position shall be 2 story. Each defensive position shall be constructed using a combination of modular baskets, steel columns, decks, roof structure, and roof panels. Technical Exhibit 2 is a conceptual design and not a final design. Contractor shall modify this design to meet SOW requirements.
