EXHIBIT A**Specifications/Requirements**
Non Armored Pickup Truck

1.0 The contractor shall provide all resources necessary to provide non armored vehicles, provide and install upgrade suspension components, breaking system and driveline (i.e., drive shaft) IAW the specifications/ requirements as described in below.

2.0 The vehicles shall comply with the following U.S. specifications/requirements:

- a. 2013 PICK-UP 4X4 Truck 3.0 Liter DOHC 16-Valve V4 Model Year 2013 (less than 100 miles). Original equipment, light pickup truck similar or equal to a Toyota Hilux. or similar.
- b. 3.0 liter DOHC 16 Valve with Dual Overhead Cam (DOHC) 160 hp @ 3400 rpm; 160 lb.-ft. @ 1,400-3,200 rpm
- c. Auxiliary engine/transmission cooler
- d. Heavy duty automatic transmission 5-speed Electronically Controlled Automatic Transmission (ECT-i) and sequential shift mode
- e. Full time 4WD with Active Traction Control (A-TRAC) and Torsen limited-slip center differential with locking feature
- f. Ignition System – Electronic
- g. Emission Rating – Low Emission Vehicle (LEV-II)
- h. High-capacity air conditioning
- i. Heavy-duty suspension – coil-spring independent double-wishbone front suspension with stabilizer bar; coil-spring 4-link with lateral rod rear suspension with stabilizer bar (upgraded front and rear springs, sway bars, heavy-duty shock absorbers, etc).
- j. Trailer towing package
- k. Power windows and locks, capable of being operated from the driver’s station
- l. Seating Capacity: 5
- m. Fuel Tank Capacity: 21 Gallons minimum
- n. Color: light color (Gray, White, Beige)
- o. US and Metric speedometer (desired measurement units, however not required)
- p. Brakes – Power assisted ventilated front disc brakes; drum rear brakes
- q. Minimum four (4) doors

- r. Tilt steering
- s. AM/FM radio, CD (Colombian frequency)
- t. Set of the OEM standard owner's and repair manuals in English and Spanish

- u. Floor mats for front and rear passenger areas
- v. One ABC type fire extinguisher and mounting bracket shall be provided, with the extinguisher having a minimum 2.5 pound (1 kg) capacity. The fire extinguisher shall be located in the cargo area.
- w. Tool box or storage area with tire changing tools and lifting jack minimum capacity of 50% of the heaviest axle load rating at Gross Vehicle Weight (GVW) shall be provided.

 - (1) 2013 Pickup Truck 4X4 4.0L V4: From 60 mph to full stop in less than 155 feet.
 - (2) Brake system shall accommodate after-armor mass of vehicle and be of such design as to ensure against failure, to include failure at top speed and/or repeated use. Each vehicle type will be tested for the performance criteria stated above without a payload, except for an operator weighing approximately 200 lbs.
 - (3) The contractor shall provide and install all necessary materials, components, accessories and/or mounting hardware for protection package, and each specified optional feature, and make any/all compensatory adjustments to the vehicle, in accordance with the requirements set forth within this contract.

4.1 All vehicles under this agreement shall carry the standard commercial warranty of a minimum three (3) year warranty on parts, labor, and workmanship on ballistic glass and a minimum three (3) year warranty on parts, labor,

and workmanship on opaque armor, from date of acceptance. The contractor shall provide warranty coverage at the vehicle's location (which might be outside of the Bogotá metropolitan area) at no additional cost to the government (i.e., parts, labor, shipment and travel).

Award will be made to the lowest priced technically acceptable proposal.

The following factors shall be used to evaluate proposals:

1. Technical Acceptability. Technical proposal shall consist of and must include:

(a) Definitions. As used in this provision --

“Economically disadvantaged women-owned small business (EDWOSB) Concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service-

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Inverted domestic corporation, as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under 6 U.S.C. 395(b), i.e., a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

Manufactured end product means any end product in Federal Supply Classes (FSC) 1000-9999, except--

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

Sensitive technology--

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically--

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern--

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Subsidiary means an entity in which more than 50 percent of the entity is owned--

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

Veteran-owned small business concern means a small business concern--

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

"Women-owned business concern" means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and whose management and daily business operations are controlled by one or more women.
