**APPOINTMENT PACKAGE - FIANCEE K-VISAs (Packet 4)**

Dear Visa Applicant:

The person(s) listed on the attached appointment letter should appear at the U.S. Embassy Bogota's Consular Section waiting room (located at the corner of Calle 26 and Carrera 50) on the date and time specified in the letter. If any of the person(s) listed on the attached letter cannot come to the appointment, please inform this office as soon as possible. In order to prepare for your interview, please follow the attached instructions.

**FIRST:** Fill-out the visa applications, which are available online at [http://travel.state.gov/visa/forms/forms\\_1342.html](http://travel.state.gov/visa/forms/forms_1342.html):

**1. Nonimmigrant Visa Application (DS-156)**

- Complete **two (2) copies per applicant** (including each of your children)
- Please note that the Immigrant Visa (IV) unit accepts only the computer-generated DS-156 available at [http://travel.state.gov/visa/forms/forms\\_1342.html](http://travel.state.gov/visa/forms/forms_1342.html), and it must include the 3rd page which contains a 3-D barcode. Applicants who come on the day of the interview with the a hand-written DS-156 or without the 3<sup>rd</sup> page will be turned away and will be rescheduled for a later date.

**2. Nonimmigrant Fiancé(e) Visa Application (DS-156K - K1/Fiancé(e) Visa Applicants Only)**

- Complete **(1) copy per family**. We do not require this form for spouses of American citizens or their children.

**Application Instructions**

- **After completing the form online, be sure to click "Continue" at the bottom of the page to print the application, including the barcode on page 3. We cannot process your case if the barcode page is not included.**
- Answer each question. Do not use dashes or abbreviations. If a section does not apply, write 'NOT APPLICABLE'.
- Review all answers, especially if someone helped you fill out an application. Ensure your name, date of birth, and gender is correct. Use your Passport BOOK number, not any other number in your passport.
- **DO NOT SIGN ANY APPLICATIONS.** You will sign them during your interview.

**SECOND:** Undergo certain **medical examinations**. See the attached *Instructions for Medical Examinations*.

**THIRD:** Pay the **one-time** non-refundable K-visa application fee equivalent of **US\$350** in Colombian pesos in cash at Banco Helm prior to the interview. **Fees are subject to change.** Please visit [http://travel.state.gov/visa/temp/types/types\\_1263.html](http://travel.state.gov/visa/temp/types/types_1263.html) for the current K-visa application fee. Legally, a consular officer cannot interview you until these fees have been paid. If you are found ineligible to receive a visa, the application fee will not be reimbursed.

**FOURTH: THE DAY OF YOUR APPOINTMENT**

## ARRIVE ON TIME

- Bring your interview letter to your appointment (if available).
- If you learned your appointment date from our website ([http://bogota.usembassy.gov/immigrant\\_visas.html](http://bogota.usembassy.gov/immigrant_visas.html)) but do not have your interview letter, you should come to the Consular Section waiting room on the day of your scheduled appointment. You will be allowed to enter **only** on your scheduled appointment date.
- It is strongly recommended that K-visa applicants arrive 30 minutes early, before 7:00 am. If you arrive late or do not bring all required documents, your case will be rescheduled.
- The visa interview process may take several hours. Our waiting room is outside, and Bogota can get cold. Please dress accordingly.

## BE PREPARED

- Make sure that everyone listed on the appointment letter brings all required documents to the appointment. Arrange documents in the exact order found on the attached *List of Documents*.
- Police certificates, and the application forms are valid for 12 months. Medical exams are valid for six months.
- Passport biographic information, including name and date of birth, must exactly match applicants' civil documents. Any discrepancies should be corrected by the relevant Colombian authorities prior to your interview.
- If the consular officer requests additional information or documents, you will need to schedule a follow-up appointment through the call center: <http://bogota.usembassy.gov/vic.html>.
- You are legally responsible for all information provided in your application. All information is subject to verification.

## CHILDREN UNDER 14 YEARS OF AGE

- Children under 14 years of age whose names are *listed on a parent's appointment letter* are **not** required to come to their immigrant or K visa interviews.
- If possible, a parent or legal guardian should attend the immigrant or K visa interview for children under 14 years of age. If a parent or legal guardian cannot attend the interview, another adult may bring a **notarized letter** from the parent or legal guardian authorizing him/her to be the parent's representative.

## VISA DELIVERY BY COURIER

Approved K-visas will be delivered by a private courier, DOMESA, approximately 10 calendar days after your interview. You will receive detailed instructions about visa delivery the day of your appointment. **Under no circumstances will applicants be allowed to pick up their visas at the Embassy.** Please see attached *Visa Delivery Service Fees*.

## WAIT UNTIL YOU RECEIVE YOUR VISA TO MAKE TRAVEL PLANS

No assurance can be given in advance that a visa will be issued. Your case will be carefully reviewed by a consular officer to determine your eligibility based on U.S. immigration law. **You are advised not to make any travel arrangements, such as giving up your job, selling property, or buying plane tickets until you have received the approved visa package in hand. You risk significant financial losses if you ignore this advice.** K1 and K2 visas (for fiancé(e)'s and their minor children) are valid for six months and are good for ONE entry into the United States. Fiancee's must legally marry the petitioner within 90 days of entering the United States, or lose their status. K3 and K4 visas (for spouses and their minor children) are valid for 24 months and are good for multiple entries into the United States.

### **WARNING:**

**The Consular Section does not endorse or have a "special relationship" with any individual, attorney, or business that offers advice or assistance with the visa process.** No one can guarantee that your visa will be issued. All U.S. government forms are free. **Beware:** many visa applicants lose money or are permanently barred from the United States as a result of misleading information and fraudulent applications provided by visa consultants or attorneys.


Any document or information presented in connection with your K visa application may be investigated by our Fraud Prevention Unit. **Any attempt to misrepresent a material fact to a consular officer may make you permanently ineligible to obtain a visa.**

**By law, an immigration or K-visa petitioner may be imprisoned for up to five years or fined up to \$250,000, or both, for entering into a marriage contract for the purpose of evading any provision of the immigration laws. In addition, a petitioner may be fined up to \$10,000 and imprisoned for up to five years, or both, for knowingly and willfully falsifying or concealing a material fact or using any false document in submitting a petition.**

If you wish to discontinue the immigrant/fiancée visa petition process, the petitioner must inform us **in writing**. You must include the case number, and the complete name and date of birth of the petitioner and the applicant.

### PHOTOGRAPH INSTRUCTIONS FOR IMMIGRANT/K-VISA APPLICATIONS

- Photos must be 5 cm x 5 cm
- Color photograph
- Both ears must be visible.
- Altered or photo-shopped photos are illegal and will be rejected.
- Photo must be recent (taken no more than six months ago).
- The person must be looking straight ahead (cannot be looking to the left, to the right, up or down), and the face must cover approximately 50% of the area of the photo.
- No head covering
- No earrings
- White background

## LIST OF DOCUMENTS

*Informal English translations are required for civil documents written in a foreign language. We can return most original documents if you also bring notarized photocopies to your interview.*

- **PASSPORT:** The passport must be valid for travel to the United States and have at least six (6) months of validity left from the date the visa is issued. Applicants who have traveled to the United States should also present all previous passports.
  - Bring a copy of the petitioner's U.S. passport.
- **PHOTOGRAPHS:** Six (6) COLOR photographs taken within the past six months for **each** applicant. See attached photograph instructions. Altered or photo-shopped photos will be rejected
- **BIRTH CERTIFICATES:** Each applicant must present an original or a notarized copy of his/her birth certificate. A copy of the Folio is required. The date and place of birth, parents' names, and date the birth was registered must be included. *We do not accept 'short form' birth certificates, as they are not official extracts from government records. Applicants must present the first/original copy of their birth certificate in addition to the replacement version if it replaced an older version. The visa will not be approved until the applicant brings copies of ALL the versions of their birth certificates*
  - **Special note for applicants born before 1939:** You may present a recently issued **baptismal certificate** with marginal notes in lieu of a birth certificate.
- **BAPTISMAL CERTIFICATE:** Recently issued baptism certificate with marginal notes is required for all applicants. Failure to bring a baptism certificate may delay the processing of your visa.
- **MARRIAGE CERTIFICATES (K3/K4 cases):** Married applicants must present a certified copy of their civil marriage certificate. All marriage certificates must include the date and place of the marriage, complete names of the spouses, and name and title of the person who performed the ceremony. *Applicants and petitioners must also present proof of the termination/divorce of any previous marriages.*
  - **Stepchildren (K4) cases:** Marriage certificate of your biological parent and the petitioner. *Your parent and the petitioner must also present proof of the termination/divorce of any previous marriages.*
- **TERMINATION OF PREVIOUS MARRIAGES:** Certified photocopies of final divorce decrees, annulments, or death certificates are required for the petitioner and **ALL** applicants. We cannot accept civil or religious separations or annotations on the back of marriage certificates as proof that a marriage has been terminated. Documents should state "*liquidación de la sociedad conyugal*" and "*cesación de efectos civiles*" when there is no divorce sentence.
- **POLICE CERTIFICATES:** A Colombian police certificate "Certificado Judicial" is required for all applicants who will be over 18 years of age when they travel to the U.S. It may be obtained at any DAS office or online at <http://das.gov.co>. Police certificates are also required from applicants who have lived in another country for more than 6 months since turning 18 years of age (except for the United States, Mexico, and Venezuela). Please visit <http://travel.state.gov/visa/reciprocity/index.htm> for information about obtaining police certificates for other countries.
- **JUDICIAL AND PRISON RECORDS:** Applicants who have been arrested for **any** reason in **any** country (including Colombia or the United States) or who have any judicial/prison record must present copies of ALL documents related to the case, even if the charges were dropped, the applicant was found innocent, or they received an amnesty or other act of clemency. The visa will not be approved until all judicial and prison records are presented to the Consular officer.
- **IMMIGRATION RECORDS:** Applicants who have been denied admission to the United States, requested extensions, changed status, applied for asylum, been deported, or granted voluntary departure from the United States must bring all relevant documents from the Department of Homeland Security or the immigration judge. The visa will not be approved until all judicial and prison records are presented to the Consular officer...
- **DAS CERTIFICATE –** Entries and exits to and from Colombia for the past 10 years for both the petitioner and all visa applicants over age 18. This document may be obtained in Bogotá at the DAS Office located at Calle 100 #11B-27, Edificio Platinum, Bogotá. Failure to bring this document may result in delays in visa processing.

- **EVIDENCE OF FINANCIAL SUPPORT:** A [Form I-134](#) (Affidavit of Support) is required at your final interview. If your spouse or fiancé(e) did not submit the Form I-134 with your petition, he or she should download and complete the Affidavit of Support, and you should bring it your interview. This form may be downloaded at <http://www.uscis.gov/i-134>.
  - **Each** traveling family member requires their own copy of the Form I-134. If you do not bring all required copies of the Form I-134, the visa will not be approved.
  - **Each I-134 must be accompanied by the petitioner's latest income tax forms (Form W2, 1040, and letter from their employer certifying their employment)**
- **EVIDENCE OF A GENUINE FIANCEE RELATIONSHIP:** For fiancée petitions, the visa cannot be approved until the Consular Officer is convinced that the relationship is genuine. An approved petition is not sufficient evidence that the relationship is genuine. Applicants may wish to bring photographs, evidence of communication between them (phone records, emails, post-marked letters, phone cards), evidence of travel together, and financial records or joint accounts with both of their names as evidence of a genuine, ongoing relationship and any other evidence that demonstrates your relationship over time. Your American fiancée is not required to be present at the interview, but the consular officer may recommend that they come to the Embassy for an additional interview at a future date. **If a fiancée relationship is determined by the consular officer to be a sham, the petition will be returned to USCIS for revocation, and the petitioner may face legal penalties.**
- **MEDICAL EXAMINATION:** See attached *Instructions for Medical Examinations*.

### VISA FEE INFORMATION

Prior to the date of your K-visa appointment at the Embassy, you must pay the **one-time** non-refundable visa application fee. The fee is the equivalent of **US\$350** in Colombian pesos. This fee must be paid in cash. **Fees are subject to change.** Please visit [http://travel.state.gov/visa/temp/types/types\\_1263.html](http://travel.state.gov/visa/temp/types/types_1263.html) for the current K-visa application fee

To pay the fee, go personally to any authorized Banco Helm office. See <http://bogota.usembassy.gov/scabco.html> for a list of locations and hours of operation. Make sure to take your two completed DS-156 Forms (Nonimmigrant Visa Applications) to Banco Helm when you pay the fee. The bank will affix a receipt to your passport and will mark the DS-156 Forms with a folio number. Do not remove the other two parts of the receipt from your passport, or you will not be able to apply for a visa. You must bring the same Form DS-156s to your visa interview that you presented to the bank when you paid the visa application fee.

### SPECIAL NOTE FOR K1 VISA APPLICANTS

**Do not marry your petitioner before you have received your visa and traveled to the United States.** The law requires K1 visa applicants to remain legally free to marry throughout the process. If you get married, even to your fiancé(e), your petition will be cancelled and cannot be reinstated. If you get married, your petitioner must file a new petition, and you must start your case from the beginning.

### SPECIAL NOTE FOR K3 VISA APPLICANTS

K3 visas are for spouses of American citizens. K3 visa applicants **MUST** be married to the petitioner.

## INSTRUCTIONS FOR MEDICAL EXAMINATIONS

**LABORATORY EXAMINATION:** Applicants who are 15 years of age or older are required to have blood tests and a chest X-ray done **BEFORE** their general physical examination at the following address:

Applicants who are 15 years of age or older must first select a doctor for the general examination, second complete your laboratory examination, and third complete your general physical examination. These examinations should be completed **prior** to your appointment at the Embassy. **Please do not change doctors once you have selected one, as this will cause delays.** Many applicants are able to complete their laboratory and physical examinations on the same day.

**GENERAL PHYSICAL EXAMINATION:** Each applicant, regardless of age, must have a general physical examination with one of the doctors (also known as panel physicians) listed below. The doctors see patients Monday through Friday. Please call the Doctor's office to make an appointment for your exam. Since the full-body exam requires the patient to undress, you may wish to choose a male or female doctor.

At both examinations, you must show **these instructions and your passport.** You must bring **one photograph** (see photograph instructions) per applicant to **each** examination. If you do not bring your passport, these instructions, or photographs, the examinations will not be performed. Examinations from a laboratory or doctor not included on this list will not be accepted.

As of August 1, 2011, the exams will have a MAXIMUM price of **285.000\*** Colombian pesos per person:

**\$150.000** (Colombian pesos) for the general physical examination;

**\$135.000** (Colombian pesos) for blood tests (Serology and X-rays).

**\*Prices are subject to change.**

Laboratory and medical examination fees must be paid in cash by the applicant. **CHECKS ARE NOT ACCEPTED.** Any additional examinations ordered by the doctor must be paid for by the applicant. You may pick up the results of your exams at the doctor's office. On the day of your visa appointment, please bring the results of your medical examinations to the Embassy in a sealed envelope.

### **PLEASE NOTE**

During your medical examination, you should provide all relevant information concerning your medical history to the examining physician:

- If you are taking any medications, you should know their names and composition.
- If you currently, or have previously suffered from an illness, major surgery or trauma, or physical or mental disease, please bring the medical history from the doctor or medical institution that treated you.
- If you are receiving treatment for any of the above, please bring a copy of your medical history, including treatment and medication.

Failure to provide this information during your medical examination will cause your visa process to be delayed. Please remember that the information provided to the doctor is confidential.

### **IMPORTANT NOTICE TO IMMIGRANT AND K VISA APPLICANTS CONCERNING VACCINATION REQUIREMENTS**

United States immigration law requires immigrant and K visa applicants to obtain certain vaccinations (listed below) prior to the issuance of a visa. Panel physicians who conduct medical examinations are now required to verify that visa applicants have met the new vaccination requirement, or that it is medically inappropriate for the visa applicant to receive one or more of the listed vaccinations:

-- **Acellular pertussis**  
-- **Hepatitis A**  
-- **Hepatitis B**

-- **Influenza**  
-- **Influenza type b (Hib)**  
-- **Measles**  
-- **Meningococcal**

-- **Mumps**  
-- **Pneumococcal**  
-- **Pertussis**  
-- **Polio**  
-- **Rotovirus**  
-- **Tetanus and diphtheria toxoids**  
-- **Varicella**

In order to assist the panel physician, and to avoid processing delays, **all immigrant and K visa applicants** should have their vaccination records available for the panel physician's review at the time of the medical examination. You should consult with your regular health care provider to obtain a copy of your immunization record, if one is available. If you do not have a vaccination record, the panel physician will work with you to determine which vaccinations you may need to meet the requirement. Certain waivers of the vaccination requirement are available upon the recommendation of the panel physician.

**Only a physician can determine which of the listed vaccinations are medically appropriate for you, given your age, medical history and current medical condition.**

### **New Tuberculosis (TB) Testing Requirements By The U.S. Center For Disease Control (CDC) For ALL Immigrant Visa Applicants**

Due to increased rates of TB infection in the U.S., the U.S. Government now requires more stringent testing and treatment of all applicants before they can immigrate to the U.S.

- All applicants 15 years of age and older must undergo a chest X-ray before the medical examination can be completed. This requirement includes pregnant women, who can elect to undergo the chest radiograph while pregnant with double lead shielding over the belly, or they can choose to undergo the chest radiograph after the baby is born.
- **Families with children ages two through fourteen years of age must plan to be available in Bogota for an extra 4 days to determine if the children also need chest X-rays.**
- Tuberculin skin testing (TST) is required for all children aged two through 14 years of age to determine the necessity of chest X-rays. This skin test will be performed at the panel physician's clinic, at a cost of approximately 36,000 Colombian pesos, which is subject to change.
- If the child's X-ray results are suggestive of TB, additional medical testing will be required. The testing phase may take several weeks to complete.
- If the tests are positive for TB, they may require treatment before the applicant is eligible for a visa.
- The Embassy has no control over the testing and treatment of TB. It is the responsibility of the applicant to work with the panel physician to complete all tests and TB treatments.
- Screening young children means that many children with TB can be treated in the very early stages before it makes them sick. This treatment for young children is sometimes available in the United States and is generally given in the U.S., rather than at the time of the immigration examination.
- Addition of sputum cultures for all applicants with chest X-ray findings suggestive of TB.
- Drug susceptibility testing (DST) of positive sputum cultures will be conducted by a laboratory.
- Completion of TB therapy under Directly Observed Therapy (DOT) prior to travel to the United States. Treatment must be performed according to guidelines jointly issued by the American Thoracic Society, CDC, and the Infectious Diseases Society of America (<http://www.cdc.gov/mmwr/preview/mmwrhtml/rr5211a1.htm>)
- The treatment process is costly and time-consuming. The DOT treatment for TB can be completed in Bogota by daily visits to the panel physician for at least six months. Treatment for TB may also be done for free in other parts of the country by Colombian public health clinics, but that treatment will last one year, followed by another medical exam with the Embassy panel physician six months after the year of treatment has been completed.
- Any additional examinations, testing, and treatment for TB must be paid for by the applicant.
- Reduction in the validity of the TB portion of the medical examination:
  - To 3 months for applicants with B1 TB condition, HIV infection, or Class A TB with waiver (rare)
  - to 6 months for all other applicants

**VISA DELIVERY SERVICE FEES**

**All approved immigrant and K visa packages are delivered by DOMESA de Colombia, a private courier service. Unfortunately, we can make no exceptions.**

On the day of their interview, applicants must bring sufficient cash, in Colombia pesos, to pay for delivery of their visa packages. Applicants will receive detailed instructions from a DOMESA agent the morning of their interview. Please note that delivery service is not available for a small number of Colombian cities and towns. Applicants from these locations may pick up their visa packages at a DOMESA office or have their visa packages delivered to a friend or family member.

**Visa package delivery will take about four to six business days. Applicants should not make any travel arrangements before they have physically received their visa package.**
