*** MECHANICAL RESISTANCE:**

For this project and in order to avoid structural damage to the lifting equipment on the roof and side sealed rectangular grid used 12-gauge iron-immunized and painted polyurethane, the van carrying a rectangular frame 3.50 x 2.10 x 2.10, with brackets welded on each corner of the rectangle, the upper hooks are part of the four side tubes. This allows us to ensure that the structure to bend or break to raise it and lower it to the floor. (Much like a container for transportation of goods that can be lifted and anchored to the platform but lighter).

The structure is divided into two parts, the slab mobility platform consisting of 4.50 m long, 2.30 wide, under a sheet of gingerbread, U-beams and bridges in C metal laminate floor and painted gingerbread immunized black, anchor clamps 3 / 4, with aluminum access ladder when it is anchored on the platform of the vehicle and a tool box to 1.00 m high and 1.00 meters wide and long 2.10mts the width body, tops
Module anchor to secure the truck to the platform.

The structure of the van must be monocoque, the carrying capacity per square meter floor is 2000 kg rectangular structural grid is used 14 gauge for the frame of the equipment in welding Mig welding brackets to support the weight to be lifted by helicopter or crane, the sides are fortified with Omega in 14 gauge galvanized sheet and lined out in 18 gauge galvanized sheet, the roof is lined with galvanized sheet cal 18, this plate prevents oxidation and gives us the strength to lift the team. the outside is in galvanized sheet glued with Sikaflex and riveted to the structure. The galvanized sheet is ideal as it prevents oxidation and is more resistant to inclement weather.

The radio station will be anchored to the platform independent

The van must be made through sandwich panels, that its structure comprises a galvanized sheet external insulation to allow the circulation of cooling and air conditioning and sheet of Formica or laminate type wood interior

THERMAL INSULATION:

Manufactured insulation free of thermal bridges that will ensure conservation of the cold chain, increase relaxation cycles of the refrigeration unit, the van should avoid condensation (humidity and pollution that damages the insulating material) inside the walls thereof. All insulated body count in the four side walls and ceiling.

*** SEAL TOTAL:**

Doors manufactured in panel van with a Ferrari branded packaging and packaging perimeter of the doors of soul wire 2 inches wide, this package prevents ingress of water, dust and helps soundproof the cabin work.

*** SECURITY:**

Hinges and latches on forged aluminum galvanized screws to prevent corrosion and deterioration in warm or humid climates, income sheet with key internal and external and weather protection.

*** AESTHETICS:**

The outer surface of the side panels should be completely smooth and shiny thereby allowing the placement of advertising material or a mobile billboard. The external sheets are galvanized sheet with anticorrosive plating, painted with polyurethane and a last layer of transparent varnish, this will give a smooth, clean, easy to maintain and resistant to corrosion.

*** DOORS:**

A back door of 80 cm. wide by 180 cm. high with a handle of two sheets: one for security and unfriendly.

Two panels: one on the rear panel and side panel for access and ventilation to the power plant, with safety gates and locks to prevent their loss.

*** FLOOR:**

Lamina of welded iron and bolted as part of the structure, and lined with anticorrosive vinyl proquinal brand of high resistance.

*** ELECTRICAL SYSTEM:**

Wiring structural plastic shield protected, secured with cable ties and rubber passes to prevent short circuits in contact with the blade.

52.212-2 EVALUATION--COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Lowest price technically acceptable with acceptable past performance.

(b) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

Serialization within the part, lot, or batch number means each item of a particular part, lot, or batch number is assigned a unique serial number within that part, lot, or batch number assignment. (ii) The encoded data elements of the unique item identifier conform to the transfer structure, syntax, and coding of messages and data formats specified for Format Indicators 05, 06, and 12 in ISO/IEC International Standard 15434, Information Technology--Transfer Syntax for High Capacity Automatic Data Capture Media.

(4) Unique item identifier.

(i) The Contractor shall--

(1) Serialize within the enterprise identifier;
