Invoices will be prepared as an R1, or equivalent, with the Embassy's OIB because the U.S. Embassy has a tax exemption certificate from the host government and will seek VAT reimbursement.

Attachment A

STATEMENT OF WORK HVAC WATER TREATMENT

I. GENERAL INFORMATION

- A. The Embassy of the United States of America has a requirement to establish a contract for water treatment systems for the following:
 - 1. Heating, hot water piping (closed loop system)
 - 2. Chilled water piping (closed loop system)
 - 3. Condenser water system (open system)

II. PERFORMANCE REQUIREMENTS

- A. Maintain water quality for HVAC systems that controls corrosion and build-up of scale and biological growth for maximum efficiency of installed equipment without posing a hazard to operating personnel or the environment.
- B. Base chemical treatment performance requirements on quality of water available at Embassy site, HVAC System equipment material characteristics and functional performance characteristics, operating personnel capabilities, and requirements and guidelines of authorities having jurisdiction.
 - 1. Closed System: Maintain system essentially free of scale, corrosion, and fouling.
 - 2. Condenser Water, Cooling Tower system: Maintain system essentially free of scale and total suspended solids to sustain the following water characteristics:
 - a. pH: 6.5 – 8.0.
 - b. Inhibitor: Corrosion rate not to exceed 4 mpy (100µm/year)
 - c. Cycles of concentration: 5 maximum, 2 minimum

III. EQUIPMENT

- A. The contractor will supply and install the necessary equipment for water treatment including:
 - 1. Electronic metering self priming pumps for water treatment chemicals.
 - 2. Programmable conductivity controller connected to and monitored by a remote computer via LAN. Walchem Webmaster 1 or equivalent. NOTE: Computer will be supplied by Embassy.
 - 3. Chemical solution tanks – primary and secondary.

4. Water meter with pulse signal installed on make-up water feed to cooling tower.
5. Any necessary water analysis equipment, test kits, corrosion coupons etc. required for the service.
The contractor shall include model information for all equipment in the proposal.
The contractor is responsible for maintenance and proper functioning of all installed equipment.

IV. SCOPE OF SERVICE

- A. Provide chemicals and service program for maintaining optimum conditions in the circulating water for inhibiting corrosion, scale, and organic growth in the cooling, chilled water piping, heating, hot water piping, condenser water piping and equipment. Service and chemicals shall be provided, including the following:
 1. Initial water analysis and recommendations.
 2. Installation of equipment.
 3. Startup assistance.
 4. Weekly service including:
 - a) On the spot water analysis and necessary adjustments in order to maintain the water quality inside the parameters defined in the “Performance Requirements” article.
 - b) Microbiological activity monitoring using ATP and DIP-SLIDE technology.
 - c) Monitoring of chemical consumption.
 - d) Monitoring and controlling of chemical program effectiveness.
 - e) Corrosion coupon metal loss analysis.
 5. 24 hour emergency assistance.
 6. Monthly submittal of service reports in English by email.

V. QUALITY ASSURANCE

- A. Staff: The contractor shall assign a chemical engineer with at least 3 years of experience in the water treatment field for service visits. The service engineer must be able to write service reports in English and discuss the details with Embassy Facility Manager and Maintenance staff.
- B. Chemicals: The water treatment chemicals must have all licenses and certificates required by local law.
- C. Equipment: All equipment shall be approved by Embassy Facility Manager prior to installation.
- D. Contractor will adhere to quality assurance plan (QAP) in Attachment B.

Attachment B

QUALITY ASSURANCE PLAN (QAP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

- 1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
- 2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
- 3 PROCEDURES.
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
 - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
 - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
 - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
