

I. Scope of Services

The Contractor shall provide vehicle (diesel and petroleum) fuel, to the U.S. Embassy Nicosia, as described in this solicitation. The contract type will be a fixed price with economic price adjustment indefinite quantity/indefinite delivery under which may be placed firm fixed-price Delivery Orders.

The price of the contract will be based on the discount proposed by the contractor on the Average Monthly Price for Fuel issued by the Ministry of Commerce, Industry & Tourism on a monthly basis, less VAT and Custom Duties.

The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, to supply vehicle fuel to the American Embassy. In consideration of satisfactory performance, the Contractor shall be paid a firm fixed-price for each supply. The Contractor shall be compensated monthly upon receipt of a proper invoice for all supplies made under Delivery Orders during the month.

II. CUSTOMS DUTIES AND VALUE ADDED TAX

Custom Duties and Value Added Tax (VAT) are not applicable to this contract and shall not be included in the rates or Invoices as the U.S. Embassy is Customs Duties and VAT exempt from the host government.

SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20
DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. Scope of Work

For each year of the contract, the U.S. Government guarantees a minimum order of 10,000 liters of vehicle (diesel and petroleum) fuel. The maximum amount of fuel ordered under each year of the contract shall not exceed 250,000 liters.

The Contracting Officer may issue oral orders that will be confirmed in writing.

The fuel provided at the various Contractor filling stations will be Unleaded 98, Unleaded 95 Petroleum and Euro Diesel. The Contractor will supply fuel directly from the Contractor's filling stations throughout the Republic of Cyprus. For supply of the fuel, the Contractor shall be paid the fixed price per unit as listed above.

A. Delivery:

The Contractor shall supply vehicle fuel to approximately fifty (50) official vehicles of the U.S. Embassy Nicosia. The Contractor shall make available 24 hours per day, seven days a week all the Contractor's filling stations, throughout the Republic of Cyprus.

B. Price Adjustment:

(a) The unit price per liter may be adjusted based on increases or decreases in the official price of vehicle fuel as submitted to the oil companies by the Government of Cyprus, Ministry of Commerce, Industry and Tourism, on a monthly basis.

(b) To request an adjustment in price, the Contractor must provide written notification of the price change to the Contracting Officer immediately upon notification from the Government of Cyprus, Ministry of Commerce, Industry & Tourism, of the new average market price. This notification must be accompanied by a copy of the official announcement of the price change, showing the average price of the month. The officer or general partner of the Contractor having overall responsibility for the Contractor's affairs shall certify the submission by written signature.

(c) The U.S. Government will make no adjustment to the contract price that relates to any wages, overhead, fixed costs, general and administrative expenses, materials, or profit. Only the amount which is a direct result of an increase or decrease in the price of oil to be delivered under this contract shall be considered by the U.S. Government as the basis for contract price adjustments.

(d) The Contractor may not request an adjustment under this clause after final payment has been made under this contract.

(e) This clause shall only apply to laws enacted by the Government of Cyprus which meet the criteria set forth above. The U.S. Government will make no adjustments in contract price due to currency devaluations or fluctuations in exchange rates.

C. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.
