SECTION 1 - THE SCHEDULE

Continuation/Addendum to SF-1449 RFQ Number SDR860-15-Q-0007 PRICES, BLOCK 23

3. DESCRIPTION

The Embassy of the United States in Santo Domingo, Dominican Republic requires services to maintain generators in safe, reliable and efficient operating condition. The generators must be in operation seven days a week, 24 hours a day, 365 days a year. The contract will be for a one-year base period.

The contract type is a firm fixed price contract for routine maintenance services paid at the monthly rate below. These rates include all costs associated with providing generator maintenance services in accordance with manufacturer's specifications including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. This work shall be performed by Contractor trained employees, and shall not be subcontracted.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date on which performance shall start.

1.1 Definitions

- i. **"Government"** means the Government of the United States of America unless specifically stated otherwise.
- ii. **"USG"** means the Government of the United States of America.
- iii. **"Calendar Day"** means the twenty-four hour period from midnight to midnight. Saturdays, Sundays, and all holidays are considered calendar days.
- iv. **"Weekday"** means Monday through Friday.
- v. **"CO"** means Contracting Officer, a USG employee appointed as the sole individual with broad authority to enter into, administer and modify contracts as well as approve payments.
- vi. **"COR"** means Contracting Officer's Representative.
- vii. **"NEC"** refers to the New Embassy Compound located at Ave. República de Colombia #57, Altos de Arroyo Hondo; Santo Domingo, DN 10605.
- viii. **"M.S.D.S."** means a product manufacturer's Material Safety Data Sheet
- ix. **"Manufacturer's Specifications"** means the specifications in the manufacturer's manual for the equipment

4. PRICING

Offerors shall provide bids in U.S. dollars.

VALUE ADDED TAX. Value Added Tax (ITBIS) is not applicable to this contract and shall not be included in the contract line item rates or invoices because the U.S. Embassy has tax exemption status with the host government.

2.1 Base Year - The Contractor shall provide the services shown below for the base period of the contract, starting on the date stated in the Notice to Proceed and continuing for a period of 12 months. The fixed unit prices, estimated quantities, and ceiling for each category are:

6. CONTRACT TERM

The initial contract term shall be for a period of one year effective from date of award. The Government reserves the right to extend the contract term for four additional periods of one year. The Government will notify the Contractor of its intention to extend no later than 60 days from the anniversary date of the original notice to proceed.

The notice to proceed will indicate the contract start date, which will coincide with the Embassy's move to the New Embassy Compound.

SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20
DESCRIPTION/SPECIFICATION/WORK STATEMENT

1. SCOPE OF WORK

The Embassy of the United States in Santo Domingo, Dominican Republic requires the Contractor to maintain the generators identified in Attachment 1 in safe, reliable and efficient operating condition. The Contractor shall provide all necessary managerial, administrative and direct labor personnel, and as well as all necessary transportation, equipment, tools, repair parts, supplies and materials required to perform inspection, maintenance, repair, and component replacement as required to maintain the generators in accordance with the manufacturer's specifications. Under this contract the Contractor shall provide the services of a trained generator mechanic on a monthly basis to check and repair equipment operation and perform scheduled and preventive maintenance.

Emergency repair services are not included in this contract.

2. HOURS OF PERFORMANCE

The Contractor shall schedule periodic routine maintenance and repair visits for weekdays starting at 8:00am (see Section 2 for a list of official holidays when the Embassy will be closed.) The Contractor and the Contracting Officer's Representative (COR) will work together at least seven calendar days in advance to schedule the visit.

3. ACCESS TO GOVERNMENT SITE AND STANDARDS OF CONDUCT

3.1 General. The Contractor shall designate a representative who shall supervise the Contractor's generator mechanics and be the Contractor's liaison with the Embassy. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purposes.

3.2 Personnel security. The awarded Contractor shall subject its personnel to the Government's approval. All Contractor employees that will support the performance of this contract must pass the U.S. Government's background check. The Contractor must provide the full name, place of birth, date of birth and cédula number of all personnel scheduled to perform work on U.S. Government properties, 60 days before the date of the contract start date stated in the Notice to Proceed. The Government reserves the right to deny access to U.S.-owned or U.S.-operated facilities to any individual. The Government shall issue identity cards to approved Contractor personnel, each of whom shall display his/her card(s) on the uniform at all times while on Government property. These identity cards are the property of the Government. The Contractor shall return all identity cards when the contract is completed, when a Contractor's employee leaves this contract, or at the request of the Government.

3.3 Standards of conduct

3.3.1 General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

3.3.2 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR). The Contractor shall provide, to each employee and supervisor, uniforms and personal equipment. The Contractor shall be responsible for the cost of purchasing, cleaning, pressing, and repair of the uniforms.

3.3.3 Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

3.3.4 The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

3.3.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

3.3.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include but are not limited to the following infractions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and misuse of weapons.

3.3.7 Key Control. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, or other areas, for the purposes of this contract. Keys shall not be duplicated without the COR's approval. Where the Government determines that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from performing work under the contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system so compromised.

3.3.8 Access Control. The Contractor shall ensure that all doors and gates are secure at all times.

4. WORK REQUIREMENTS

4.1 SCHEDULED ROUTINE MAINTENANCE

4.1.1 General

The Contractor shall provide all management, supervision, labor, materials, supplies and equipment to perform monthly, semi-annual and annual maintenance on four DQCC 800 KW Cummins generators, one 350DFEG 350 KW generator and related peripheral equipment.

The objective of scheduled routine maintenance is to eliminate or minimize generator malfunction, breakdown and deterioration. Contract maintenance must ensure continuous, safe, and satisfactory operation of all generators, their parts and components. The Contractor shall schedule routine maintenance to include all tasks herein described.

The list of equipment to be serviced is in Attachment 1.

The Contractor shall inventory, supply, repair and replace all parts that have become unsafe due to wear and tear. The Contractor shall use genuine manufacturer's parts or approved or equal (to be approved by COR) for all replacements. The Contractor shall maintain a sufficient and easily accessible supply of spare parts. The Contractor shall only use new fluids recommended by the generator manufacturer.

Checklist Approval - The Contractor shall submit to the COR a schedule and description of the scheduled routine maintenance tasks that the Contractor plans to provide. The Contractor shall prepare this schedule and task description in a checklist format similar to the one provided in Attachment 2. The COR must approve the proposed "Scheduled Routine Maintenance Task Checklist" prior to contract work commencement.

Minimum Requirements - The Contractor shall provide a trained mechanic to inspect and service every generator and related peripheral equipment once a month, every month of the year to maintain the equipment to manufacturer's specifications. Following the manufacturer's recommendations, the Contractor shall also perform more involved maintenance at different intervals. The mechanic shall sign off on every item of the checklist. The mechanic shall leave a copy of this signed checklist with the COR following that period's routine maintenance visit.

In general, the inspection and servicing shall include, but not be limited to, the following tasks:

Generators:

- Inspections
- Cleaning
- Repairs
- Replacement of fluids as needed
- Completion of the generator maintenance log

Fuel Tank:

- Gauging of the underground diesel fuel tank for fuel levels and the presence of water
- Reading of the automatic fuel tank level gauge
- Testing of the leak detector alarm
- Completion of the associated reporting

Fuel Supply:

- Inspection of the diesel fuel supply
- Inspection of the return and overflow pumps located in adjacent enclosures for proper operation.
- Sampling of fuel once every three months to ensure it is not contaminated.
- Completion of the associated reporting

Other Peripheral Equipment:

- Coordination of any repairs needed for other peripheral equipment, including the diesel driven water pump, Cummings paralleling gear and automatic transfer switches.
- Completion of the associated reporting

Refer to “Details” below for further detail

4.1.2 Details

Monthly, quarterly, semi-annual and annual maintenance shall include at a minimum, but not be limited to, the following:

MONTHLY

- Check for leaks, foreign objects, loose fittings and guards.
- Check coolant levels and top up.
- Check filler cap gaskets and sealing surfaces.
- Check condition and tension of fan belts.
- Visually inspect water pump for leaks or unusual noises.
- Inspect air filter service indicator for proper operation.
- Inspect air filter.
- Inspect piping and filter housing.
- Inspect exhaust manifold for damage, leaks or loose hardware.
- Inspect silencer and piping for damage, corrosion or leaks.
- Check lubrication system for leaks – front and rear seals, oil pan and oil filters.

- Check crankcase oil levels.
- Check oil pressure.
- Operational & visual inspection of pre-lube pump.
- Inspect breather for proper operation. Note excessive blowby.
- Check fuel system for leaks.
- Inspect and clean fuel control linkages.
- Clean fuel filter.
- Check fuel pressure.
- Inspect fuel tank for leaks. Drain water and sediments.
- Visual inspection of power generator. Check for loose connections.
- Inspect connections for Starting Motor. Inspect oil jar and feeder open-air starters.
- Inspect batteries for damage or leaks. Clean terminals. Top up electrolyte levels if required.
- Inspect Alternator for proper operation. Check for loose connections.
- Check belts for alternator, pulley & voltage output.
- Checking voltage and frequency for proper settings and stability.
- Checking change over switch operation.

QUARTERLY

This service includes all of the Monthly tasks, plus the following tasks and activities:

- Lubricate and check fan drive bearing operation and clearance.
- Replace primary air cleaner.
- Replace secondary air cleaner.
- Change engine oil and filter(s).
- Clean crankcase breather.

- Obtain S.O.S sample for engine crankcase oil (after stopping the engine).
- Obtain S.O.S. cooling system coolant sample.
- Change primary fuel filter/water separator.
- Change secondary fuel filter.
- Inspect safety controls for loose connections and wiring deterioration.
- Clean contaminants for windings (dirt, grease, salt or oil films).
- Vacuum clean dirt & debris for voltage regulator.
- Inspect circuit breakers for free movement and tight connections.
- Inspect and testing automatic transfer switch for proper operation.
- Vacuum clean control panel.
- Start the engine and check all gauges.
- Stop the engine and record charging amperage reading.
- Change breather canister filters.

SEMI-ANNUALLY

This service includes all of the monthly and quarterly tasks, plus the following tasks and activities:

- Replace thermostat.
- Drain and refill coolant.
- Perform engine valve lash adjustment.
- Check engine valve rotators.
- Check turbocharger.
- Change primary fuel filter.
- Lubricate governor actuator and replace governor oil.
- Check crankshaft vibration damper.

- Check engine mounting.
- Test alarms and shutdown devices.
- Perform test of generator windings.
- Lubricate rear and front bearings.

ANNUALLY

On an annual basis the Contractor shall perform a full load test.

4.1.1 Work Sequence

During routine maintenance, only one of the four DQCC 800 KW generators shall be taken offline at any one time. At all times, the Contractor shall ensure at least three of the DQCC 800 KW generators are running in order to support the full load of the Embassy.

4.1.2 Disposal of Removed Materials and Equipment

The Contractor shall be responsible for the off-site disposal of all removed materials and equipment except those items specifically designated to be retained by the Government. The Contractor shall not allow debris to accumulate. The Contractor shall ensure the work place is cleaned at the end of each day. No materials or debris shall be burned on the site. The Contractor shall follow all applicable local environmental disposal laws and regulations.

4.1.3 Safety

The Contractor shall observe all normal rules governing safety and shall comply with all local regulations, and official requests and directives of the COR. The Contractor shall provide to the Government the Material Safety Data Sheets for all chemicals used prior to those compounds being brought into the facility. The Contractor shall obtain a “Hot Work Permit” from the COR prior to performing welding, soldering, torch or an open flame. The Hot Work Permit shall be kept at the site where work is being performed for the period granted.

4.1.4 Tests and Reports

- A. Inspections. The Contractor shall provide written reports of any discrepancies or concerns found during the inspections (in addition to filling out the generator maintenance logs) within two calendar days of the inspection.
- B. Contractor reports – Operation problems. The Contractor shall immediately communicate verbally, and additionally in writing within two calendar days, to the COR the discovery, cause and corrective actions to be taken for all potential operational problems of an unusual or potentially hazardous nature of which the Contractor becomes aware.

- C. Fuel and fluids checks. The Contractor shall provide written reports within seven calendar days of all tests/analyses conducted.
- D. Contractor operation records. The Contractor shall maintain schedules, operations logbooks, inventory lists, equipment specifications and drawings that describe the generators covered by these specifications and the services performed. These documents shall be made available to the COR upon request. Contractor records must be furnished in both paper and electronic format.
- E. Annual safety inspection and report. The Contractor shall conduct annually a full-load test. The result of each test shall be delivered to the COR in writing within fourteen (14) days of date of test.

4.1.5 Availability of Utility Services

Normal and conservative use of utilities for project work will be made available to the Contractor to complete the work. The Contractor shall make all required connections and restore affected utilities to their original condition at no cost to the Government. The Government reserves the right to curtail this privilege at any time deemed necessary by the COR.

4.1.6 Warranty

The Contractor shall warranty all materials and labor for a period of 12 months from the signed date indicating satisfactory completion of the work.

4.2 Quality Control

The Government shall have the right, at any stage of the operation, to inspect and/or reject any and all work, which, in its opinion, does not meet with the requirements of this contract. Such rejected work shall be corrected to the satisfaction of the Government at no additional cost to the Government

4.3 Information Library

The Contractor shall have and maintain, for the duration of the contract period, a reference library consisting of manufacturer's equipment maintenance schedules, equipment schematics, layouts, parts list, etc., and other basic information needed to properly maintain the included systems. Upon termination of the contract, the Government shall become sole owners of these records.

5. Working Hours

The Contractor shall schedule each month's routine maintenance and repair visit for a weekday starting at 8:00am. The Contractor and the COR will work together starting at least seven calendar days in advance to schedule the work.

6. PERSONNEL, MANAGEMENT AND SUPERVISION, TOOLS, REPAIR PARTS, MATERIALS AND SUPPLIES

6.1 Personnel

6.1.1 Only trained and licensed service technicians shall be used to perform repairs and maintenance services stipulated in this contract. Service technicians assigned by the Contractor must have five years of experience in all aspects of maintenance to be performed, including repairs that may become necessary during the term(s) of this contract. The primary technician assigned to the account must be certified by Cummins in generator maintenance. The COR may require the Contractor to provide the qualifications of any employee assigned to this contract.

6.1.2 The Contractor shall have backup technicians who are qualified in all respects of equipment repair and services requirements to assume the responsibilities for the maintenance of the included systems.

6.1.3 Personnel. The awarded Contractor shall subject its personnel to the Government's approval. All Contractor employees that will support the performance of this contract must pass the U.S. Government's background check. The Government reserves the right to deny access to U.S.-owned or U.S.-operated facilities to any individual.

6.2 Supervision and Administration

6.2.1 The Contractor agrees to maintain complete accurate records of ALL maintenance services performed, repairs made, and replacement parts used and billed for during the period of this contract. Maximum use shall be made of the preventive maintenance program to identify and forecast routine generator and generator equipment maintenance requirements. All equipment defects and deviations from normal operating characteristic and specifications shall be recorded on the preventive maintenance services.

6.2.2 The Contractor agrees to furnish the COR with a copy of each completed work log. That work log shall be annotated with a description of the problem, the corrective actions taken by the Contractor personnel and the name of the Contractor personnel that performed the work.

6.3 Parts, Materials and Supplies

The Contractor shall provide the appropriate tools and testing equipment for scheduled maintenance as required by this contract. The Contractor shall provide all of the necessary repair parts, materials and supplies to maintain, service, inspect and test the generators as required by this contract. The Contractor shall be responsible for all parts related to preventive maintenance as described in the equipment logs.

7. EXCLUSIONS

Major Repairs: Any individual unit or incident of repair with a total estimated cost (labor and direct material costs) exceeding \$3,000.00 which is not covered under routine maintenance, is not covered by this contract. The Government reserves the right to determine how these repairs are to be handled. Such repairs will normally be accomplished by separate purchase order or contract. This exclusion does not apply if the repair is to correct damage caused by Contractor negligence.

8. INSURANCE REQUIREMENTS

8.1 Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract

The Contractor's assumption of absolute liability is independent of any insurance policies.

8.2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, whatever insurance is legally necessary. The Contractor shall carry the following minimum insurance:

Comprehensive General Liability

Bodily Injury As required by Dominican Republic law

Property Damage As required by Dominican Republic law

Workers' Compensation and Employer's Liability

Workers' Compensation and Occupational Disease As required by Dominican Republic law

Employer's Liability As required by Dominican Republic law

8.3 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

8.4 Worker's Compensation Insurance. The Contractor agrees to provide all employees with worker's compensation benefits as required by the laws of either the country in which the employees are working or the employee's native country, whichever offers greater benefits, following FAR 52.228-4 "Worker's Compensation and War-Hazard Insurance Overseas".

9. ACCIDENTS AND INJURY

9.1 The Contractor and his employees shall comply with all OSHA regulations and the Dominican Republic's local safety regulations.

9.2 The treatment of injuries sustained by the Contractor's employees shall be the responsibility of the Contractor.

9.3 At those United States Embassy locations that have a medical department, the medical department can be contacted for initial assistance in a medical emergency (during the medical department's normally scheduled hours.)

9.4 All OSHA recordable injuries sustained on United States Embassy premises must be reported, in writing, to the United States Embassy representative.

10. PERMITS

The Contractor shall maintain in full force and effect all permits, licenses, and appointments required for the prosecution of work under this contract at no additional cost to the Government. The Contractor shall obtain these permits, licenses, and appointments in compliance with host country laws.

11. LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to ensure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the contract shall be payable by the Contractor without Government reimbursement.

12. GOVERNMENT FURNISHED PROPERTY

None.

13. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

13.1 Plan. This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

13.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

13.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month and that the Contractor does not deviate from the response time limits more than once per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

13.4. Procedures.

13.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

13.4.2 The COR will complete appropriate documentation to record the complaint.

13.4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

13.4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

13.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

13.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

13.4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

13.4.8 Repeated customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

“Inverted domestic corporation”, as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), *i.e.*, a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at [26 U.S.C. 7874](#).

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.

Note to bidder/offeror: If the bidder/offeror has indicated “yes” in blocks (a)(1), (2), or (3) of the following provision, the bidder/offeror shall include Defense Base Act insurance costs covering those employees in their proposed prices.
