SECTION 1 - THE SCHEDULE

CONTINUATION TO SF-1449 RFQ NUMBER **SEG30016Q0016** PRICES, BLOCK 23

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price contract is to acquire the service of an experienced firm to perform the repair and maintenance services for the Xerox photocopiers in accordance with Attachment 1.
- B. The contract will be for eleven months period starting January 01, 2016 through November 30, 2016.

II. MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of **10,000 Egyptian Pounds**. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed **1,000,000 Egyptian Pounds**. This reflects the contract maximum for this period of performance.

III. PAYMENT

The contractor shall submit proper invoices on a quarterly basis after services have been performed. The invoice shall include, but not limited to, the contract number, the copier model and serial number, the current meter reading, and the related office in accordance with Attachment 2. Each invoice will include copy of the maintenance card signed by the receiving officer of that office proofing that the maintenance have been made. All invoices will be gathered by a cover sheet with all the invoice numbers.

Payment will be done in Egyptian pounds by the Financial Management office upon submission a proper invoice approved by the COR.

IV. PRICING

Local companies are to submit proposal in local currency; however, interested firms located in the U.S. will be paid in dollars.

Standard Service

The contractor firm fixed monthly price for maintenance and repair for each type of Xerox copier shall include costs of labor, equipment, spare parts, consumables, lubricants, transportation, administration contract overhead and profit. Prices will not include taxes.

V. VALUE ADDED TAX

Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

Attachment 1 Performance Work Statement

Summary

The Contractor shall provide all necessary labor, transportation, equipment and supervision required to perform inspection, maintenance, repair and component replacement as required to maintain all copiers listed under Attachment 2 at optimal performance level. Repair and maintenance services shall be in accordance with manufacturers specifications. Services also shall include a full time on-site service engineer as back-up maintenance and supervisory assistance for all copiers covered under this contract at no additional cost to the U.S. Government. Maintenance and repair services shall be performed in accordance with Xerox's world-wide maintenance and repair program (which includes all spare parts necessary for repair, consumables, except paper, with exception of repairs for repeated mishandling of equipment and damage due to lack of adequate voltage stabilizer protection of equipment). The full-time on-site service engineer must be trained in the repair and maintenance of all copiers listed in attachment 2 under RODUCT heading. In the event that a new product copier is purchased by the Government, the Contractor shall as soon as practical, schedule the full-time on-site service engineer for the training on the new product.

Maintenance and Repair Records

The Contractor's full-time on-site service engineer shall establish a maintenance record card for each copier covered under this contract. This card shall include the serial number, Embassy inventory (NEPA) number, location of copier, service record, replacement parts and other pertinent information as required by the Contracting Officer Representative (COR) for this contract.

Repair Referral

The full-time on-site service engineer shall report immediately to the COR any problems beyond his ability to repair and will notify the COR of any machine that is not suitable for use in an office due to the following factors, and will follow-up with recommendation:

1. Capacity of machine: According to repair records, copier does not have sufficient capacity for the average number of monthly copies.
2. Abuse of copier: According to maintenance records, copiers are suffering an unusual number of repairs due to mishandling by operators.
3. Location of Copier: Location is not suitable due to dust, moisture, etc.
4. Age of copier: Copier is obsolete and continued usage is not economical or efficient due to frequent repairs and non-availability of spare parts.

Consumables

The Contractor shall maintain an adequate supply of consumables (exclusive of paper), such as a toner, required to keep all copiers in good operating condition during the duration of this contract at no additional cost to the Government. The full-time on-site service engineer shall be solely responsible for all supplies kept at the American Embassy.

Working Hours

The full-time on-site service engineer(s) shall be present at the Embassy between the hours of 9:00 AM through 4:00 PM, Sunday through Thursday, except on holidays. The Contractor must provide the Embassy with a replacement service engineer when the full-time on-site service engineer is unable to perform (i.e. leave).

Record of Copiers

Space inspection: The full-time on-site service engineer shall inspect all copiers which have been relocated to ensure their sufficient operation. In the event that a copier has been damaged during a move or relocation, the full-time on-site service engineer shall be responsible for notifying the COR in writing detailing actual damage. The COR is responsible for notifying the Contracting Officer and the full-time on-site service engineer of any anticipated movement or relocation of Government-owned copiers. The full-time on-site service engineer must inspect the machine(s) before operation in the new location.

Inventory of Copiers under Maintenance Contract

The full-time on-site service engineer shall coordinate with the COR to ensure that any changes to the list of copiers under this contract are acknowledged and documented, and both shall notify the Contracting Officer. On a quarterly basis, the full-time on-site service engineer shall provide the COR with an up-to-date list of copiers and their locations as determined by the maintenance card of each machine.

Spare Parts

The Contractor is responsible for ensuring that spare parts for all copiers covered under this contract are readily available. In the event that a copier under this contract becomes obsolete and spare parts are not available, the Contractor shall notify the COR, in writing, at least ninety days in advance.

Major Repairs

In the event major repairs for any copiers covered under this contract become necessary and the repairs are due to exclusions as stated in Xerox's worldwide maintenance agreement, the Contractor's full-time on-site service engineer shall be responsible for obtaining advance approval from the COR for the purchase of any spare parts needed. Any repairs with a value that exceeds L.E. 100.00 must have advance written approval by the COR before installation may begin. Failure to obtain this approval may result in a delay or rejection of payment.

Staff Conduct

The Contractor's full-time on-site service engineer shall be courteous to all Government employees during performance of duties under this contract. In the event that a problem arises with any Government employee, the full-time on-site service engineer shall report the problem to the COR immediately. If the Contracting Officer or the COR receive repeated complaints on the full-time on-site service engineer conduct, the Contracting Officer will notify the Contractor's Field Service Manager in writing. If the problem cannot be resolved within a 30-day period, the Contractor shall replace the full-time on-site service engineer. The replacement engineer should be equally qualified and will be subject to all the security procedures required for clearance of personnel working inside U.S. Embassy.

Routine Maintenance

The Contractor full-time on-site service engineer is responsible for routine and preventive maintenance, repair and service calls for of all copiers covered under this contract. Routine maintenance shall include, but not be limited to the following:

1. Check toner levels and replace toner as necessary.
2. Check the resolution of copies, making adjustments as necessary.
3. Clean the cleanliness of the photocopier glass to improve the quality of copies (for example, unclear, blurry, blotchy, smudged or smeared copies).
4. Check the machine for any broken attachments (i.e. paper tray, feeder).
5. Check to insure that the copier is properly connected to electrical outlets with adequate supplies, and that a working voltage stabilizer is connected and in use with each copier.
6. Confirm copiers covered under this contract are positioned or placed in appropriate locations (for example, away from windows, construction, possible water damage)
7. Check for signs of obvious mishandling of equipment (for example, if the copy cover or door has been repeatedly forced).
8. Check and verify if the paper used in the machine is of the proper size and type.
9. Check the copy usage for copiers covered under this contract in order to determine if there is an unusually high usage for each machine's capacity. Any problems noted during the routine maintenance check shall be communicated to the COR, in writing, by the full-time on-site service engineer, with recommended solutions.

Key Operator Training

The Contractor shall provide a key operator training schedule to the COR within one week of delivery of each new copier. The COR shall provide the schedule to the Contracting Officer for approval before training commences.

Meter Reading

The Contractor's full-time on-site service engineer will be given access to office in Embassy compound in order to take meter readings for the purpose of calculating charges due. The COR or his designated representative will accompany the full-time on-site service engineer and verify each reading. The Contractor's employees are subject to Embassy Security Requirements.

Access to Government Building

The full-time on-site service engineer assigned to provide services at the U.S. Embassy shall be on site only for contractual duties and not for any other business or purposes. Access to the Cairo I and Cairo II, either with or without security escort, shall be allowed only with specific permission by either the Contracting Officer or the COR.

Standard of Conduct

- a) In general the Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity as required. Each Contractor employee is expected to adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government shall be responsible for taking such disciplinary action with respect to employees and reserves the right to direct

the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

- b) Uniforms. The Contractor's employees shall wear clean, neat and identifiable uniforms, although not necessarily identical uniforms. All employees shall wear accreditation at all times.
- c) Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also prohibited is participation in disruptive activities that interfere with normal and efficient Government operations.
- d) Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or any substances that produce similar effects.
- e) Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:
 - Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct;
 - Unethical or improper use of official authority or credentials; security violations; or, organizing or participating in gambling in any form.

Security

General. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Government will run background checks on all proposed Contractor employees. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall be used on this contract to the COR in advance of any access request.

Identity Cards. The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall visibly display identity card(s) on their uniforms at all times while providing services under this contract. These identity cards are the property of the Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government.

LAWFUL OPERATION, PERMITS, AND INDEMNIFICATION

- a) Bonds. The Government imposes no bonding requirement on this contract. The Contractor shall provide any official bonds required, pay any fees or costs involved or related to the authorization for the equipping of any employees engaged in providing services specified under this contract if such bonds or payments are legally required by the local government or local practice.
- b) Employee Salary Benefits. The Contractor shall be responsible for payment of all employee wages and benefits required by host country law or agreements with its employees. The Government, its agencies, agents, and employees shall not be part of any legal action or obligation regarding these benefits which may subsequently arise. Where local law requires bonuses, specific minimum wage levels, premium pay for holidays,

payments for social security, pensions, sick or health benefits, severance payments, child care or any other benefit, the Contractor is responsible for payments of these costs and must include them in the fixed prices in this contract.

- c) Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract. The Contractor's assumption of absolute liability is independent of any insurance policies.

QUALITY ASSURANCE PLAN (QAP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. STANDARD. The performance standard is that the Government receives no more than three (3) customer complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. PROCEDURES.
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

**ATTACHMENT 2
GOVERNMENT-FURNISHED PROPERTY**

The Government shall make the following property available to the Contractor as Government-Furnished Property (GFP) for performance under the contract.
