DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

General

The Embassy of the United States of America in Cairo, Egypt requires greeting services for the Information Resource Center (IRC). The contractor will provide the IRC with 2 (two) skilled and trained resources as onsite support agents, commonly known as “Greeters” to perform the following tasks:

- Greeters will be available at the Embassy’s West Gate (Visa Gate) at address 5 Tawfik Diab Street, Garden City, Cairo or North Gate at address 8 Kamal EL Din Salah, Garden City, Cairo, as needed.
- All work shall be performed during Sunday through Thursday from 08:00 to 16:30 except for the holidays identified below in Section 2 (Clause 652.237-72) and off days observed by the IRC.
- Greeters will receive IRC visitors at the entrance, as the first point of contact, before the go through the security check.
- Greeters duties, work allocations, etc. are assigned at the discretion of the IRC management, within the scope of service detailed herein, responsibilities and deliverables, and in alignment with the contractor’s management.

Greeters’ responsibilities

- Greeters are responsible for providing professional, informed, courteous and friendly greetings to the visitors.
- Greeters are responsible for organizing IRC queues in front of the entrance where they will be located, and they will work with IRC staff and security to organize entry of IRC visitors, members, and attendees of the different IRC programs, as they will be instructed by IRC management.
- Greeters are responsible for answering any questions from IRC visitors.
- Greeters are responsible for helping IRC visitors orient themselves with the IRC processes, offerings, schedules, etc.
- Greeters will disseminate information to IRC visitors, in a professional, courteous and cheerful fashion to ensure that the IRC patrons have a comfortable, enjoyable and memorable visit at the IRC.
- Greeters are responsible for presenting the rules and regulations of the IRC, pertaining to membership, rules of conduct, security, etc.

- Distribute printed materials about the IRC and its programs, at the gates, when needed.
- Ensure that visitors to the IRC meet all the requirements for their visit before directing them to the IRC.
 - For new members: Verify that applicants are 18 years of age or older, have a valid ID, and carry a photocopy of their ID
 - For program participants: Confirm registration for the program and that they have a printed copy of the program enrolment confirmation email.
- Handle the confirmed registered list for IRC programs and organize entry of program participants.
- Receive returned IRC materials from members and place them inside the designated box at the west gate.
- Inside the IRC premises, greeters will support IRC team with data entry of new IRC members.
- Contractor will ensure availability of 2 (two) greeters with the required skills to perform duties listed herein during all working times specified herein, and will provide backup for any of the greeters during their leave of absence.

Qualifications and Skill Requirements

- Outstanding customer care service and ability to handle huge crowds
- Ability to handle visitors from different backgrounds and resolve issues that might occur outside the IRC entrance
- The ability to assist individuals with special needs
- The ability to identify needs according to the situation and respond appropriately and independently (with reference to the IRC)
- Fluent in Arabic and good command of English
- Self-confident, reliable, and flexible
- Good interpersonal communication and emotional awareness
- Presentable and abides by the IRC professional attire and grooming guidelines
- Keeps abreast of the IRC activities and programs (as will be trained by IRC staff)
- The ability to manage multiple tasks

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. **PROCEDURES.**
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
 - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
 - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
 - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

- The Government reserves the right to reject proposals that are unreasonably low or high in price.
- The lowest price will be determined by multiplying the offered prices times the estimated quantities in “Prices - Continuation of SF-1449, block 23”, and arriving at a grand total, including all options.
- The Government will determine acceptability by assessing the offeror's compliance with the terms of the RFQ **to include the technical information required by Section 3.**
- The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:
 - Adequate financial resources or the ability to obtain them;
 - Ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
 - Satisfactory record of integrity and business ethics;
 - Necessary organization, experience, and skills or the ability to obtain them;
 - Necessary equipment and facilities or the ability to obtain them; and
 - Be otherwise qualified and eligible to receive an award under applicable laws and regulations.
