- OPEN TO:** All Interested Candidates.
- POSITION:** Appliance Technician, LES-4<sup>(1)</sup>; FP-AA<sup>(2)</sup>
- OPENING DATE:** September 30, 2012
- CLOSING DATE:** October 14, 2012
- WORK HOURS:** Full-time; 40 hours/week.
- SALARY:** (1) Mission Policy is to hire LES employees at step 1 of the grade. The current annual salary for an LES-4, step 1 is L.E. 27,921.
- (2) Actual FP grade and salary will be determined by the US Department of State.

Notes: All ordinarily resident applicants must have the required work and/or residency permits to be eligible for consideration.

Best qualified displaced/RIFed employees will receive priority *consideration* if no US Citizens, family members or veterans apply.

The U.S. Embassy in Cairo is seeking an individual for the position of Appliance Technician in the Supply and Property Management Office.

**BASIC FUNCTION OF POSITION**

The incumbent works directly for the LES-5 Storekeeper (Maintenance Man). Responsible for modification, minor repair, adjustment, general appearance, and cleanliness to ensure the integrity and dependability of a

variety of small and large appliances for use in Embassy residences and offices. Appliances could include, but are not limited to: major household appliances (Refrigerators, Freezers, Washers, Dryers, Dishwashers, Microwave Ovens, Vacuums, etc.), small appliances (Lamp, Toasters, Coffee Pots, Hot Pots, Fans, Transformers, Voltage Regulators, etc.), and a variety of electrical items. Working independently or assisting the LES-5 Maintenance Man, perform preventive maintenance and corrective repairs as required in order to extend the live of appliances and selected electrical items.

### **QUALIFICATIONS REQUIRED**

NOTE: All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.

1. Completion of secondary school/technical school and vocational training in the field of electronic construction or electrical maintenance is required.
2. Two years of experience in one of the following fields – electrical construction, electrical repair, or electronics repair is required.
3. Level III (good working knowledge) in Arabic and level II (limited knowledge) in English is required.

### **SELECTION PROCESS**

When equally qualified, US Citizen Eligible Family Members (EFMs) and U.S. veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

### **ADDITIONAL SELECTION CRITERIA**

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply for advertised positions.

3. Currently employed US Citizen EFMs who hold an FMA appointment are ineligible to apply for advertised positions within the first 90 calendar days of their employment.

4. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.

2. Candidates must provide in the application or (DS-174) names of family members working in the Mission.

3. Candidates who claim US Veterans preference must provide a copy of their Form DD-214 with their application or the preference will not be applied.

4. (Optional): Any other documentation (e.g., essays, certificates, awards, copies of degrees earned) that addresses the qualification requirements of the position as listed above.

### DEFINITIONS

1. AEFM: A type of EFM that is eligible for direct hire employment on either a Family Member Appointment (FMA) or Temporary Appointment (TEMP) provided s/he meets all of the following criteria:

--US citizen;

--Spouse or dependent who is at least age 18;

--Listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad with a USG agency that is under COM authority;

--Is resident at the sponsoring employee's or uniform service member's post of assignment abroad, approved safehaven abroad, or alternate safehaven abroad;

and

--Does not receive a USG annuity or pension based on a career in the US Civil, Foreign, or uniform services.

2. EFM: Family Members at least age 18 listed on the travel orders of a Foreign of Civil Service or uniformed service member permanently assigned to or stationed to a US Foreign Service post or establishment abroad with a USG agency that is under COM authority who do not meet the definition of AEFM above.

3. Member of Household: A MOH is a person who: 1) Has accompanied, but is not/not on the travel orders of a U.S. citizen Foreign or Civil Service employee or uniform service member permanently assigned to or stationed at a U.S. Foreign service post or establishment abroad; 2) Has been declared by the sponsoring employee to the Chief of Mission as part of his/her household; and 3) Resides at post with the sponsoring employee.

4. Ordinarily Resident (OR): A citizen of the host country or a citizen of another country who has shifted the main residency focus to the host country and has the required work and/or residency permits for employment in country.

5. Not-Ordinarily Resident (NOR): Typically NORs are US Citizen EFMs and EFMs of FS, GS, and uniformed service members who are eligible for employment under an American USG pay plan, on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
