The Contractor shall provide Hotel conference room for 45 participants in support of the INL "Intelligence Led Policing" Course, from March 31 to April 4, 2014, from 8:00 a.m. to 5:00 p.m. The following services are required:

1. Room shall be no smaller than 200 m² to comfortably accommodate 45 participants in Classroom set up.
 2. Lodging for 42 participants in double room accommodations for a total of 4 nights. Check-in Monday March 31 and check-out April 4, 2014. Rate must include breakfast and dinner for 42 guests.
 3. Lunches for 45 persons for 5 days.
 4. Buffet dinners for 36 persons during 3 days. Dinner must be served at a reserved restaurant or meeting room, including two soft drinks.
 5. Internet must be available for 45 participants at the Business Center or if they have their own PC.
 6. Five parking slots with security for five days.
 7. Hotel security and dedicated staff for this account.
- a) Cancellation Policy: The Contractor shall provide cancellation policy.
- Hotel shall not charge penalty for total group cancellation if notified in writing before 7 calendar days; and one night penalty after the 7th day if the entire group reservation is cancelled.
