## ATTACHMENT A

### **FALL PROTECTION SYSTEM FOR WAREHOUSES**

#### **I. PROJECT DESCRIPTION:**

The project involves the installation of a fall protection system to prevent falls by employees working at elevated heights within two warehouses on the U.S Embassy grounds. The system should be installed in both warehouses. Warehouse 1 has 18 racks (17 racks from East to West and 1 rack from South to North). Seventeen racks are have a length 116 feet in length, and 1 is 180 feet in length. Warehouse 2 has 6 racks (1 rack from East to West and 5 racks from South to North). Five racks are 118 feet in length and 1 rack is 66 feet in length. This is an OBO/SHEM safety requirement from the last synergy visit in October 2010.

#### **II. PROJECT GENERAL REQUIREMENTS:**

The contractor has to comply with all the requirements outlined in the specifications, in the plans. The work performed in this project has to conform to the requirements of premium quality and high standards outlined in the specifications. It is necessary to have at the site a qualified professional that will represent the contractor and will manage the job accordingly, complying with the proper quality control requirements. The contractor's representative has to be fluent in written and spoken English and Spanish.

The project requires the application of the U.S. Army Corps of Engineers and OSHA safety regulations. All personnel shall comply with the proper industrial safety requirements; such as the use of, hard hats at all times, protective shoes and clothing, glasses, harnesses, safety lines, etc. A scaffold will be needed to install the system. A first aid kit and 2 fire extinguishers (10 pounds) shall be maintained at all times, and emergency accident contingencies shall be presented to the COR in a safety plan. The contractor shall provide at least three weeks before starting the job a list of the personnel that will be working inside the embassy for a security check. Inside the Embassy the contractors' personnel has to comply with all the security requirements.

The Contractor must show technical capacity, experience and equipment necessary for the system installation. The system has to comply with safety standards regulation

A weekly progress meeting is required between the contractors' field superintendent, the Embassy COR and Warehouse supervisor. The contractors' representatives at these meetings shall have the power from the contractor to make decisions and participate in negotiations with the Embassy. The time and days of the meeting will be set by the Embassy and the duration of the meeting will average two hours.

### **III. SPECIFICATIONS:**

#### **1. FALL PROTECTION SYSTEM.**

Anchoring points which must support at least 5,000 pounds (2,270 kilograms) tensile stress and the system (anchoring points, lanyards, and body harness) must limit the possible free-fall to a maximum of 6 feet (1.8 meters). System, devices and equipment should comply safety standards (OSHA, ANSI, NIOHS).

#### **2. INSTALLATION.**

The contractor has to use a scaffold to install the fall protection system; contractor personnel should use the safety gear equipment at all times. The Property personnel will clear work spaces of furniture and other items when necessary. The contractor will not drill, puncture or otherwise alter existing building structures without consulting the Embassy Facilities Manager.

#### **3. SAFETY GEAR**

Include in the quote safety gear /equipments such as: slider overhead (2 unit), retractile line (9 meters) (6 units), hard hats (16 units) and 3 points harnesses (6 units).

#### **4. TRAINING.**

The contractor will provide training on the fall protections system and safety gear/equipment.

#### **5. CLEAN UP.**

1. The contractor will clean the site after the completion of the project. All provisional facilities will be dismantled and all previously disturbed areas will be rehabilitated

## **EVALUATION CRITERIA**

Award will be made to the lowest priced, acceptable, responsible quoter. The Government reserves the right to reject quotations that are unreasonably low or high in price.

The Government will determine acceptability by assessing the offeror's compliance with the terms of the RFQ. The Government will determine responsibility by analyzing whether the apparent successful quoter complies with the requirements of FAR 9.1, including:

- ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
- satisfactory record of integrity and business ethics;
- necessary organization, experience, and skills or the ability to obtain them;
- necessary equipment and facilities or the ability to obtain them; and
- otherwise qualified and eligible to receive an award under applicable laws
