This is an Indefinite-delivery indefinite-quantity type contract.

### I. SCOPE OF SERVICES

The Contractor shall provide passenger transportation services, vehicles without drivers for the official use of CSL Staff located in the Comalapa Air Force Base, Comalapa, La Paz, El Salvador.

This is an indefinite-delivery, indefinite-quantity, type contract with firm-fixed daily rates.

The contract will be for a period between May 1<sup>st</sup>, 2015 through April 30, 2016 and individual delivery orders shall be issued for specified services within the rates designated.

### II. PRICES

#### III. Daily Rate Pricing - See Article III. Below

\* This estimated amount is based on total estimated Government requirements for this period of performance. If more than one award is made, the estimated amount of work awarded under task order(s) to any single Contractor will be less than the amount shown.

### III. HOURLY RATE PRICING

The hourly rate shall be charged for any consecutive 16-hour period within a calendar day. For services beyond 16-hour period the contractor is entitled to the Overtime Hourly Rate Pricing.

\*The above daily rates without driver shall include all the costs necessary to accomplish the work as required by this contract, including all managerial cost, administrative cost, vehicles, and all vehicle operation expenses, including but not limited to fuel, oil and other maintenance of such vehicles. If the specified number of SUV's is not available, larger vehicles may replace them. If the Contractor makes substitutions, billing and payment shall be at the contract rate for type of vehicle ordered by the Government.

V. MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of one (1) vehicle per month. This reflects the contract minimum for this period of performance. 1. GENERAL

The Contractor shall provide passenger transportation services, vehicles without drivers for the official use of CSL Staff located in the Comalapa Air Force Base, Comalapa, La Paz, El Salvador. The Contractor shall provide all managerial, administrative, direct labor personnel, vehicles, all running expenses (i.e., oil, etc) including all servicing and insurance of such vehicles that are necessary to accomplish all work required by this contract.

The Government requires the Offeror to have flexibility and sufficient inventory to return vehicles and/or ask for more from four (4) to max twelve (12) at one time.

The Government cannot provide a list of users/drivers or identify personnel driving each vehicle.

The Government requires Zero (0) deductible for rental vehicle. It is required a full insurance coverage and Government is not responsible for any damages.

2. DEFINITIONS

“Calendar Day” means the twenty-four hour period from midnight to midnight. Saturdays, Sundays and all holidays are considered calendar days.

"COR" means the Contracting Officer's Representative, appointed in accordance with Section G of this contract.

"Government" means the Government of the United States of America unless specifically stated otherwise.

"Ordering Officer" means the Contracting Officer of the U.S. Embassy, San Salvador.

“Services” means the services performed, workmanship, and equipment furnished or utilized in the performance of the services.

3. MANAGEMENT

3.1. Contracting Officer’s Representative. The Contracting Officer’s Representative (COR) is responsible for validating requests from vehicle users, and providing instructions for vehicle use to the Contractor on a daily or less frequent basis. The COR does not have authority to issue task orders under this contract. See Article 9 for task order issuance.

3.2 Authorized Service Requesters. Each task order will list the names and phone numbers of all authorized service requester(s). Service requesters are only authorized to order service within the boundaries established in the task order and are not authorized to order services from vehicles that were not included in that task order.

3.4 Documentation of Usage. Each driver shall obtain a certifying signature from the vehicle user on Daily Vehicle Use Record at the end of service each day. The Contractor shall attach this form to the invoice as a supporting document to verify the hours of service.

## 4. VEHICLES

### 4.1. Types of Vehicles

The Government requires SUV's type; automatic transmission; and four-door; capable of carrying 5 to 7 passengers; Gasoline Motor V-6 Engine; Window tinted as specified: 35% front windshield; 5% rear; 15% front passenger and driver side; 5% passenger window if ordered under this contract. All vehicles shall be of the latest model no older than 3 years and in excellent condition with air-conditioning. The Contractor shall provide registration numbers before the vehicles are used.

#### \*Maintenance:

The Government requires maintenance to be provided on a weekly inspection basis, all tires replaced must be brand new, and all vehicles must be returned from the maintenance service with a full tank.

The Government requires the response time for any routine repairs to be within two (2) hours.

The Government requires the maintenance to be previously coordinated by four vehicles at a time and Offeror must have enough vehicles to replace existing rentals.

The Government requires that all requests for maintenance and reports of incidents can be accomplished by phone call(s), and it is also required to have written communication via email to record all incidents to follow up pending actions or to provide feedback to vehicle users.

4.2 Replacement/Serviceing. The Contractor shall provide a replacement vehicle equivalent to the type that requires replacement, due to accident, breakdown, maintenance service or any other reason, within two (2) hours of notice by the driver or by the COR.

## 6. DISPATCH POINTS

6.1 Dispatch points will be stated in each individual task order.

6.2 Level of Service. Vehicles shall be delivered to the dispatch point listed in the individual task order within 2 hours of a request being made by the authorized requester.

## 7. PAYMENT

Payment will be paid by The U.S. Embassy in San Salvador, Financial Management Office. Payee will be noted on the individual task order.

The Government requires the contractor to keep a record of all reported incidents and attach it to the monthly invoice.

## 8. TASK ORDERS

Task Orders under this contract shall contain the following information:

- (a) Name of contractor
- (b) Contract number
- (c) Date of purchase
- (d) Purchase number

- (e) Number of vehicles
- (f) Unit price, and
- (g) Total price
- (h) Payee

The Contracting Officer may place orders orally, telephonically, by facsimile, by electronic mail or in writing. Oral orders shall be confirmed in writing within three calendar days.

If more than one contractor has received an award, the following procedures shall govern regarding issuance of individual task orders. The contractor shall provide no rooms without an order issued by the Contracting Officer.

- (1) The Government will develop a price estimate. If the estimate does not exceed US\$3000, the Government will follow the procedures in paragraph (2) below. If the estimate exceeds US\$3000, the Government will follow the procedures in paragraph (3) below.
- (2) Orders not exceeding US\$3000 - The Government will select a contractor for issuance of the order on a rotating basis. This decision will be based on the Government's best interest, which may include factors such as price, past performance, and unique qualifications which meet the level of quality required.
- (3) Orders exceeding US\$3000 - Unless one of the exceptions in paragraph (4) below applies, the Government will:
  - (a) Make its award based on comparisons of price, past performance, and unique qualifications which meet the level of quality required to meet the Government's security and logistical requirements. Award will be made to the lowest priced, technically acceptable hotel.
  - (b) Regardless of whether the procedures in paragraph (1) or (2) above were followed, selection of contractors shall not be protestable to GAO under Subpart 33.1 of the Federal Acquisition Regulation, except on the grounds that the order increases the scope, period, or maximum value of the contract. However, the Department of State does have an Acquisition Ombudsman who will review complaints by contractors to ensure that all contractors are afforded a fair opportunity to be considered for these task orders, pursuant to the procedures for award of task orders established herein.
- (4) Exceptions to the procedures in paragraph (3) above:
  - (a) The agency need for the required services is of such urgency that providing such competitive opportunity would result in unacceptable delays;
  - (b) The order should be issued on a sole-source basis in the interest of economy and efficiency as a logical follow-on to an order already issued under the contract, provided that all awardees were given a fair opportunity to be considered for the original order; or
  - (c) It is necessary to place an order to satisfy a minimum guarantee.

(2) The **SAM** registration shall be for the same name and address identified on the contract, with its associated CAGE code and DUNS or DUNS+4.

(3) If indicated by the Government during performance, registration in an alternate system may be required in lieu of **SAM**.

Assignees shall be separately registered in the **SAM** database. Information provided to the Contractor's **SAM** record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the EFT clause of this contract.

652.225-71 SECTION 8(A) OF THE EXPORT ADMINISTRATION ACT OF 1979, AS AMENDED (AUG 1999)

(a) Section 8(a) of the U.S. Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)), prohibits compliance by U.S. persons with any boycott fostered by a foreign country against a country which is friendly to the United States and which is not itself the object of any form of boycott pursuant to United States law or regulation. (3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person; (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

ADDENDUM TO REPRESENTATIONS AND CERTIFICATIONS

The following DOSAR provision is provided in full text:

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.

QUALITY ASSURANCE PLAN (QAP).

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

- 1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
- 2. STANDARD. The performance standard is that the Government receives no more than one (2) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that

the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

### 3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
