I.

GENERAL REQUIREMENT

The International Narcotics and Law Enforcement Section (INL) of the U.S. Embassy in San Salvador, has a requirement for the purchase of a Closed Circuit TV (CCTV) Surveillance System to be installed in the Ciudad Delgado MPP. The system's monitoring base will be installed in the Ciudad Delgado PNC Delegation and the individual cameras will be installed in strategic places designated by the Police.

ITEM DESCRIPTION

The specific items to be included in this project (as a minimum) are detailed above. After inspection, vendors may consider modifying quantities, including additional equipment, and materials that are required for proper installation and operation of the surveillance system.

WORK LOCATION

The monitoring base equipment will be installed at the PNC Delegation in Ciudad Delgado: Kilometro 10 ½ Carretera Troncal del Norte, Colonia Aurora, San Salvador, El Salvador.

not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

(1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,

(2) Discriminating in the award of subcontracts on the basis of religion.

652.209-79 REPRESENTATION BY CORPORATION REGARDING AN UNPAID DELINQUENT TAX LIABILITY OR A FELONY CRIMINAL CONVICTION UNDER ANY FEDERAL LAW (SEPT 2014) (DEVIATION per PIB 2014-21)

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
