The U.S. Embassy in San Salvador is seeking one individual for the Dispatcher position in the Motor Pool Section of the General Services Office.

## **BASIC FUNCTION OF THE POSITION**

Incumbent serves as the Motor Pool dispatcher and performs general clerical/administrative duties in a large motor pool of 14 drivers; is fully responsible for the scheduling and planning of all vehicle trips, including dispatching all ICASS vehicles and drivers; which during business hours must be responded to within two hours; responsible for updating the computer software and keeping track of all administrative paper work, official forms (OF-108), trip tickets and reports

## **QUALIFICATIONS REQUIRED**

NOTE: All applicants must address each selection criteria detailed below with specific and comprehensive information supporting each item.

- 1. EDUCATION:** Completion of secondary school is required.

2. **EXPERIENCE:** Minimum of one year of experience in clerical, dispatcher, or transportation related experience is required.
3. **LANGUAGE:**  
English: Level III (Good working knowledge) Speaking/Reading is required.  
Spanish: Level IV (Fluent knowledge) Speaking/Reading is required.  
*(Applicants will be tested at the level of language proficiency required in order to be eligible to move on to the interview stage) These are not FSI levels.*
4. **KNOWLEDGE:** Must have a good knowledge of automotive operation and safety practices.
5. **OTHER KNOWLEDGE:** Must have good knowledge of Microsoft Office (Excel, Word, and Outlook).
6. **SKILLS and ABILITIES:** Must have a valid local driver's license. Must have the ability to make minor repairs or determine a possible cause for vehicle problem.

## SELECTION PROCESS

When fully qualified, US Citizen Eligible Family Members (USEFMs) and US Veterans are given preference. It is essential that the candidate specifically address the required qualifications above in the application.

## ADDITIONAL SELECTION CRITERIA:

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
3. Current Ordinarily Resident employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. Currently employed US Citizen EFMs who hold a Family Member Appointment (FMA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
5. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment unless currently hired into a position with a When Actually Employed (WAE) work schedule.

## DEFINITION

1. US Citizen Eligible Family Member (USEFM) – **for purposes of receiving preference, a USEFM is one** who meets the following criteria:

- US Citizen; and,
- EFM (see below) at least 18 years old; and,
- Listed on the travel orders of a direct-hire Foreign, Civil, or uniformed service member assigned to or stationed abroad with a USG agency that is under COM authority, or at an office of the American Institute in Taiwan; and either:
  1. Resides at the sponsoring employee's or uniformed service member's post of assignment abroad or at an office of the American Institute in Taiwan; or
  2. Resides at an Involuntary Separate Maintenance Allowance (ISMA) location authorized under 3 FAM 3232.2.

2. EFM: An individual related to a US Government employee in one of the following ways:

- Spouse;
- Child, who is unmarried and under 21 years of age or, regardless of age, is incapable of self-support. The term shall include, in addition to natural offspring, stepchildren and adopted children and those under legal guardianship of the employee or the spouse when such children are expected to be under such legal guardianship until they reach 21 years of age and when dependent upon and normally residing with the guardian
