The U.S. Embassy in San Salvador is seeking for one individual for the Shipment Supervisor position in the General Services Office.

BASIC FUNCTION OF THE POSITION

Incumbent directs and supervises all aspects of the daily activities and operations of the Customs & Shipping Unit of the U.S. Embassy El Salvador; ensures that all incoming and outgoing official and personal shipments and their related paperwork are processed accurately and on-time; supervises two Shipment Assistants and two Customs Expeditors. This position trains and ensures that all personnel receive the training needed to stay current with Salvadoran laws and regulations.

QUALIFICATIONS REQUIRED

NOTE: All applicants must address each selection criteria detailed below with specific and comprehensive information supporting each item.

- 1. EDUCATION:** Completion of secondary school is required.
- 2. EXPERIENCE:** At least five year's experience in the field of shipping and customs, two of which have been in a supervisory capacity.
- 3. LANGUAGE: English:** Level IV (Fluent knowledge) Speaking/Reading/Writing is required.
Spanish: Level IV (Fluent knowledge) Speaking/Reading/Writing is required.
(Applicants will be tested at the level of language proficiency required in order to be eligible to move on to the interview stage) These are not FSI levels.
- 4. KNOWLEDGE:** Must have knowledge of the functioning of the Government of El Salvador Ministry of Foreign Affairs and the Customs Office. Must know the general procedures and quality of work of local steamship lines, airlines and packing companies that service El Salvador.
- 5. OTHER CRITERIA:** Must be able to deal with and effectively communicate in writing and orally with mission personnel at all levels, GOES mid-level officials, and contractors in a sometimes firm but courteous and understanding manner. Must know how to use Microsoft Office applications.

SELECTION PROCESS

When fully qualified, US Citizen Eligible Family Members (USEFMs) and US Veterans are given preference. Therefore, it is essential that the candidate specifically address the required qualifications above in the application.

ADDITIONAL SELECTION CRITERIA:

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
- 3 Current Ordinarily Resident employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. Currently employed US Citizen EFMs who hold a Family Member Appointment (FMA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
5. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment unless currently hired into a position with a When Actually Employed (WAE) work schedule.

Interested applicants for this position must submit the following or the application will not be considered:

2. Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application.
3. Any other documentation (e.g. essays, certificates, awards, copies of degrees earned) that addresses the qualification requirements of the positions as listed above.

DEFINITION

U.S. Citizen Eligible Family Member (USEFM): For purposes of receiving a preference in hiring for a qualified position, a USEFM is an individual who meets the following criteria:

- (1) U.S. citizen; and
- (2) EFM (see definition below)
- (3) Listed on the travel orders *or approved Form OF-126, Foreign Service Residence and Dependency Report*, of a sponsoring employee, i.e., a direct-hire Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad at a U.S. mission, or at an office of the American Institute in Taiwan; and who is under chief of mission authority, and either:
 - (a) Resides at the sponsoring employee's post of assignment abroad or, as appropriate, at an office of the American Institute in Taiwan; or
 - (b) Resides at an involuntary separate maintenance allowance (ISMA) location authorized under 3 FAM 3232.2. If residing at an ISMA location, the individual will not be listed on the sponsoring officer's travel orders, but will have a Form SF-1190, *Foreign Allowances Application, Grant and Report*, processed authorizing ISMA.

Other family members or dependents on direct-hire Foreign Service, Civil Service, or uniformed *service* member's travel orders *who do not meet all of these criteria* are not USEFMs or AEFMs for purposes of 3 FAM 8200.

DEFINITION: (2) EFM: An individual related to a US Government employee in one of the following ways:

- Spouse; *or domestic partner (as defined in 3 FAM 1610)* of the sponsoring employee,
- Child of the sponsoring employee, who is an unmarried *child* at least 18 years old and under 21 years of age or, regardless of age, is incapable of self-support. The term shall include, in addition to natural offspring, stepchildren and adopted children and

those under legal guardianship of the employee or the spouse when such children are expected to be under such legal guardianship until they reach 21 years of age and when dependent upon and normally residing with the guardian

NOTE: Non-US EFMs, MOHs, EFMs not under COM authority, US dependents of contractors, and US Citizen ORs do not receive a hiring preference.
