

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. Product Requirements:

1. Bed frame

- a. Single bed frame of commercial grade construction.
- b. The bed shall be sized for a 91 cm x 191 cm twin mattress. Bed platform shall be solid surface, preferably with at least 35 cm vertical clearance between frame and floor.
- c. Bed and frame may be metal and/or wood, provided bed and frame is solidly constructed of high quality materials.
- d. Bed frame shall be platform style, such that no box spring mattress is needed.

2. Nightstand:

- a. Commercial quality, constructed of wood or high-quality particle board
- b. Nightstand to have at least one drawer
- c. Top dimensions are to be at least 44 cm wide x 39 cm deep x 49 cm high
- d. Color: brown wood grain

3. Clothing Wardrobe

- a. Commercial quality
- b. Minimum dimensions: 177cm height, 55cm depth, and 90 cm width, with one side for hanging clothes and other side with at least three adjustable shelves and at least one drawer.
- c. Provide lock and keys for wardrobe doors.
- d. Color: brown wood grain

4. Desks

- a. Commercial quality, with drawers
- b. Approximate dimensions: Length 140 cm x Width 80 cm x Height 75 cm
- c. Desk shall be made of wood, metal, or high-quality particle board
- d. Desk shall have at least three storage drawers, with at least one locking drawer

- e. Finish: Brown wood grain. Grey, black, or brown (if metal).

5. Desk Chair

- a. High-back chair, upholstery made from high-quality synthetic leather material
- b. Chair shall be of high quality with adjustable settings, gas lift, armrests and 5-point base with casters

The Vendor is responsible to dispose of debris outside of the EDSC Compound. Includes, but not limited to packing materials and all associated debris.

The Vendor is responsible to properly assemble, layout and install furniture in the locations shown on an approved drawing provided by the OBO COR or his designee.

When pursuing the work, the Vendor is to take extra care as not to damage existing structure.

**WARRANTY:** Warranty for all materials and workmanship shall be one year from the date of installation.

II. Delivery Location and Time

A. The contractor shall deliver all ordered items to the **Erbil Diplomatic Support Center,(EDSC) Consulate General Erbil, Iraq.**

B. The contractor shall deliver all items not later *than* 30 days after date of contract award. The contractor shall deliver optional quantities not later than 10 days after date of modification exercising the option for the increased quantity.

C. Any contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice will not be required.

D. If delivery will be to Erbil Diplomatic Support Center (EDSC), delivery shall be made between the hours of 08:00 a.m. to 5:00 p.m. Sunday thru Saturday with prior notifications in advance.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

(i) This solicitation includes a trade agreements certification (*e.g.*, [52.212-3\(g\)](#)) or a comparable agency provision); and

(ii) The offeror has certified that all the offered products to be supplied are designated country end products.

(End of provision)
