1. BPA Number SFJ600-16-A-0001

The American Embassy Suva invites you to enter into this BPA that establishes the terms and conditions applicable to the future purchase of diesel and petrol fuel only. The service to be provided is strictly for the supply of diesel and petrol fuel, limited only to official USG vehicles and USG authorized fuel containers. Once the BPA is setup, a list of the authorized vehicles along with driver details and license plates will be provided to the vendor.

Firms must have some sort of mechanism for fuel management and a tracking application for the US Embassy to use in order to monitor fuel purchase and usage. For example, an online system that the USG can access to view fuel purchase/usage or a fuel card specific to each USG vehicle/container. Fuel cards would need to be limited only to fuel usage and not any other service provided by the vendor.

The USG intends to award BPAs to those firms that are technically acceptable, responsible, and clearly intend to supply fuel to the U.S. Government at market prices or below. Firms also need to know that while we may award multiple BPAs, we will only award the number of BPAs we believe sufficient to meet our needs and regulatory competition requirements. In other words, even if we have three firms that are technically acceptable and responsible with fair and reasonable prices, we may award less than three BPAs if we have no need for three sources of this service.

2. Expiration Date

BPA expires on April 30th 2019

3. Embassy Estimate

The Embassy estimates that the volume of purchases through this agreement is estimated to be around 110 fuel refills per month.

4. Terms and Conditions

- The Embassy is **not** obligated to purchase any definite amount under this agreement.
- No single purchase will exceed USD 3500.00 or the equivalent in local currency.
- The total amount ordered under this agreement will not exceed USD 150,000 or the equivalent in local currency.
- The prices to the Government shall be as low or lower than those charged your most favored customers for comparable quantities under similar terms and conditions, in addition to any discount for prompt payment.

No other employee may place an order against this BPA unless authorized in writing by the Contracting Officer.

6. Delivery Tickets

All shipments/deliveries shall be accompanied by a delivery ticket or sales slip including the following information:

- Name of supplier

- Date of purchase
- Purchase number
- Itemized list of supplies or services furnished
- Quantity, unit price, and extension of each item, less applicable discounts
- Date of delivery or shipment
- Name of the authorized employee who placed the order

We would prefer that delivery tickets are emailed once the service has been provided. Email addresses will be provided to you once the BPA has been setup.

7. Invoices

The BPA holder shall submit a summary invoice at least monthly or upon expiration of this BPA, whichever occurs first, for all deliveries made during a billing period. The invoice shall identify the delivery tickets covered therein, stating the total dollar value, and supported by recent copies of the delivery tickets.

8. FAR and DOSAR Clauses

The FAR and DOSAR clauses attached to this BPA shall apply to all purchases made under this BPA. In the event of an inconsistency between the provisions of this BPA and your invoice, the provisions of the BPA shall take precedence.

- 1) Use an e-mail signature block that shows name, the office being supported and company affiliation (e.g. "John Smith, Office of Human Resources, ACME Corporation Support Contractor");
- 2) Clearly identify themselves and their contractor affiliation in meetings;
- 3) Identify their contractor affiliation in Departmental e-mail and phone listings whenever contractor personnel are included in those listings; and
- 4) Contractor personnel may not utilize Department of State logos or indicia on business cards.

652.209-79 REPRESENTATION BY CORPORATIONS REGARDING AN UNPAID DELINQUENT TAX LIABILITY OR A FELONY CRIMINAL CONVICTION UNDER ANY FEDERAL LAW (SEPT 2014) (DEVIATION, per PIB 2014-21)

(a) In accordance with section 7073 of Division K of the Consolidated Appropriations Act, 2014 (Public Law 113-76) none of the funds made available by that Act may be used to enter into a contract with any corporation that –

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government; or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be

made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.

(b) Offeror represents that—

(1) It is is not a corporation that was convicted of a felony criminal violation under a Federal law within the preceding 24 months.

(2) It is is not a corporation that has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.
