

U.S. Department of State Pinterest Terms of Service Template

1. Acceptance of Terms

Welcome to the U.S. Embassy Tbilisi Consular Corner Pinterest site! The U.S. Department of State provides this service to you, subject to the following Terms of Use ("TOU"), which may be updated by the Department of State from time to time without notice to you. You can review the current version of the TOU at any time on the U.S. Embassy Tbilisi Consular Corner Pinterest site.

2. Purpose

The purpose of U.S. Embassy Tbilisi Consular Corner Pinterest site is to improve visibility of information for applicants seeking U.S. visas and to U.S. Citizens seeking assistance in Georgia.

3. Description of service

U.S. Embassy Tbilisi Consular Section operates on the Pinterest platform. It provides its members with a variety of features, including but not limited to sharing of previously posted public information. The U.S. Department of State reserves the right to alter the types of features that U.S. Embassy Tbilisi Consular Corner Pinterest site provides at any time with no notice to network members. Pinterest users must adhere to the Pinterest's [TOU](#) and [Terms of Service](#).

4. U.S. Embassy Tbilisi Consular Corner Pinterest site Platform's Privacy Policy

By using or accessing the [U.S. Embassy Tbilisi Consular Corner Pinterest site, and this site, you are accepting the practices described in the Pinterest Privacy Policy. For more information on Pinterest's privacy policy, go to <http://about.pinterest.com/privacy/>.

The Information Pinterest Site Collects:

Participation in U.S. Embassy Tbilisi Consular Corner Pinterest site is voluntary. You are responsible for maintaining the confidentiality of your login, and are fully responsible for all activities that occur under your login. You agree to (a) immediately notify the U.S. Embassy Tbilisi Consular Corner Pinterest site community manager of any unauthorized use of your login or account or any other breach of security, and

(b) ensure that you exit from your account at the end of each session. The U.S. Department of State cannot and will not be liable for any loss or damage arising from your failure to comply with this Section.

6. Member conduct

You understand that all information, data, messages or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from which such Content originated. This means that you, and not the U.S. Department of State, are entirely responsible for all Content that you post, email, transmit or otherwise make available via the site. The U.S. Department of State does not control the Content posted except as described below and, as such, does not guarantee the accuracy, integrity or quality of such Content. You understand that by using the Service, you may be exposed to Content that is offensive, indecent or objectionable. Under no circumstances will the U.S. Department of State be liable in any way for any Content, including, but not limited to, for any errors or omissions in any Content, or for any loss or damage of any kind incurred as a result of the use of any Content posted, emailed, transmitted or otherwise made available via the site.

You agree to not use the site to:

- collect or store personal data about other users.

You acknowledge that the U.S. Department of State does not pre-screen all Content, but that the U.S. Department of State and its designees shall have the right (but not the obligation) in their sole discretion to edit, delete, refuse or move any Content that is available via the site. Without limiting the foregoing, the U.S. Department of State and its designees shall have the right to remove any Content that violates the TOU or is otherwise objectionable. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy, completeness, copyright legality, or usefulness of such Content.

You acknowledge and agree that the U.S. Department of State may preserve Content and may also disclose Content if required to do so by law or in the good faith belief that such preservation or disclosure is reasonably necessary to: (a) comply with legal process; (b) enforce the TOU; (c) respond to claims that any Content violates the rights of third-parties; or (d) protect the rights, property, or personal safety of the U.S. Department of State, its users and the public.

You understand that the technical processing and transmission of the site, including your Content, may involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices.

You agree that if you post content that contains statements or depictions of violence against a person, group of people, or country, that the Department of State will report this incident and its content to the appropriate law enforcement agency.

7. Special admonitions for international use

Recognizing the global nature of the Internet, you agree to comply with all local rules regarding online conduct and acceptable Content. Specifically, you agree to comply with all applicable laws regarding the transmission of technical data exported from the United States or the country in which you reside.

8. Content submitted or made available for inclusion on the site

The U.S. Department of State does not claim ownership of Content you submit or make available for inclusion on the site. The Department only claims ownership over self generated content created by the Department of State for inclusion on this site. It does not take responsibility for the inclusion of third party links or other third party content such as articles.

9. Indemnity

You agree to indemnify and hold the U.S. Department of State, and its affiliates, officers, agents, grantees or other partners, and employees, harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of Content you submit, post, transmit or make available through the site, your use of the site, your connection to the site, your violation of the TOU, or your violation of any rights of another.

10. No resale of service

You agree not to reproduce, duplicate, copy, sell, resell or exploit for any commercial purposes, any portion of the site, use of the site, or access to the site.

11. General practices regarding use and storage

You acknowledge that the U.S. Department of State may establish general practices and limits concerning use of the site, including without limitation the maximum number of days that message board postings or other uploaded Content will be retained by the site, and the maximum number of times (and the maximum duration for which) you may access the site in a given period of time. 12. Modifications to service
