## VI. DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

**Graphic design:** The vendor shall develop a unique graphic design corresponding to the content of the web-site.

### **Coding and programming**

The vendor shall create:

- A web-site compatible with a cross-browser cross-platform using modern (x)html and CSS standards;
- Geolocation redirect (Determination of the web-site language according to the country IP address);
- Google Analytics - integration;
- Web-site back-up;
- Protection of the web-site server and database security ;
  - ✓ Protection from „SQL injection“ ;
  - ✓ Protection from „Remote file injection“;
  - ✓ Creation of a password and restrictions for concrete directories on the sever;
  - ✓ SSL certificate integration;
  - ✓ “Firewall” – systems integration.
- Search Engine Optimization shall be used for the improvement of the web-site rating;
- The web-site shall be created in PHP script an on the MySQL relational databases;
- The web-site shall be built on the CMS engine developed by the company;

### **Web-site creation:**

- Three language versions - Georgian/Englian and Russian versions should be created;
- A management system of the comfortable and easy to use content for the user (CMS unique) shall be developed;
- The web-site shall be provided with web-hosting for the period of 5 years (with the perspective of prolongation of the validity period);
- The web-site shall be provided with a web domain (www.exportcontrol.gov.ge) for the period of 5 (five) years (with the perspective of prolongation of the validity period);
- The web-site shall be tested and run;

**Technical maintenance:**

- The vendor shall provide training for the persons chosen by the Ministry of Defense of Georgia for providing the operation of the web-site and in the process of updating;
- The contractor shall provide technical support for the web-site for the period of 3 months from the start of its operation in order to provide its full operation. The technical service provided with no additional costs includes insignificant modification of the script and defect removal.

**The process of creating the web-site:** The detailed content of the web-site shall be agreed in consultation with the representatives of the US Embassy.
