I. Scope of Services

The Contractor shall provide automotive fuel to US Embassy Tbilisi. The contract type will be a fixed price with economic price adjustment indefinite quantity/indefinite delivery under which may be placed firm fixed-price delivery orders. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, and transportation necessary to supply and deliver the automotive fuel to the American Embassy Tbilisi. In consideration of satisfactory performance of all scheduled services required under this contract, the Contractor shall be paid a firm fixed-price for each delivery. The Contractor shall be compensated monthly upon receipt of a proper invoice for all deliveries made under delivery orders during the month.

This is a Fixed-Price (with EPA) Indefinite Quantity/Indefinite Delivery (IDIQ) type contract with a fixed discount off of the commercial list price for all types of fuel requested.

The contractor shall deduct the VAT and provide discounts off the VAT free list price.

The fixed price for each item is based on a set percentage off of the vendor's commercial price list named or provided at time of award. This price must be a commercial price being used by all customers of the contractor.

I. Scope of Work

For each year of the contract, the U.S. Government guarantees a minimum order of fuel totaling 5,000.00 liters. The maximum amount of fuel ordered under each year of the contract shall not exceed **400,000 liters**, approximately for 150 Vehicles and other equipment (e.g. forklifts, golf carts, lawnmowers)

The Contracting Officer may issue oral orders that will be confirmed in writing.

The fuel provided will

- Regular - RON Octane number no less than 92,
- Premium - RON Octane number no less than 95,
- Diesel PPM10 -Cetane number no less than 51, Freezing temperature no more than -25°C

1. Delivery:

Contractor shall make ordered fuel available from its fuel stations within 5 business days from receipt of delivery orders.

0. Issuance / distribution:

Ordered fuel shall be issued to the Embassy vehicles from contractor's fuel stations.

At no additional cost to the Embassy, contractor shall provide electronic pay and inventory system. At Embassy request, contractor shall provide individually marked fuel cards. Minimum required features of the electronic system are:

- Refueling vehicles using electronic pay system provided to each vehicle;
- Online record keeping system
 - Daily reporting (fuel type, card, quantity, date, time, location) of all fuel purchases and all other account transactions
 - Maintain records of all transactions for a three year period
 - Online accessibility of reports anytime
 - Ability to create queries based on card account, date, or fuel type.
- Ability to manage cards online
 - Assign fuel types and daily purchase limits for each card anytime
 - Block cards anytime
 - Charge or charge-off fuel credits from a card anytime

- Ability to assign individually identifying information to each card (e.g. license plate number)
- Telephonic technical/account manager support or assistance during normal business hours
- Ability to transfer to non-card technologies (e.g. Radio Frequency ID / RFID) as it becomes available, at no cost.

1. Payment:

For supply and delivery of the fuel the contractor shall be paid at the fixed unit rates.

The contractor shall be compensated monthly upon receipt of a proper invoice for all fuel issued to the Embassy official vehicles during the invoice period.

Payment terms: Net 30 days. Payment will be processed in local currency by Electronic Fund Transfer (EFT) within 30 calendar days from the receipt and acceptance of proper invoice by the American Embassy Tbilisi.

Monthly Invoice submitted by the contractor from the first date and time of month till first date and time of next month should be directly sent to the VoucheringWebPASSTbilisi@state.gov . date of invoice submitted, date and times of billing cycle, delivery order number, contract number, description and quantity of item(s) provided, price per unit, total price, vendor's information (name, company's name, address, and telephone number), and banking information for EFT in local currency.

2. Special Requirements:

The contractor shall have fuel station network covering the major cities Tbilisi, Kutaisi, Batumi, Telavi, Marneuli, Bolnisi, Rustavi, Lagodekhi, Poti, Akhalkalaki, Akhaltsikhe, Zugdidi, Stepantsminda, Mestia and Ambrolauri, excluding regions of Abkhazia and South Ossetia.

3. Price Adjustment:

(a) The unit price per liter of gasoline and diesel may be adjusted based on increases or decreases in the official price of heating oil.

(b) To request an adjustment in price, the Contractor must provide written notification of the price change to the Contracting Officer at least one week before the new price is to be effective. This notification must be accompanied by a copy of the official announcement of the price change, showing the new price and its effective date. The officer or general partner of the Contractor having overall responsibility for the Contractor's affairs shall certify the submission by written signature.

(c) The U.S. Government will make no adjustment to the contract price that relates to any wages, overhead, fixed costs, general and administrative expenses, materials, or profit. Only the amount which is a direct result of an increase or decrease in the price of oil to be delivered under

this contract shall be considered by the U.S. Government as the basis for contract price adjustments.

(d) The Contractor may not request an adjustment under this clause after final payment has been made under this contract.

4. Ordering:

Fixed price delivery orders are estimated to be issued on monthly basis under Ordering Clause (FAR 52.216-18). Price for each delivery order may be adjusted under price Adjustment clause, however shall not change for the entire period of delivery order until ordered fuel is fully consumed.

(f) QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State’s policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
