1.0 DESCRIPTION

The U.S. Embassy Tbilisi requires preventive routine maintenance services for CDC Office, located at 9 Asatiani Street. The contract type is a firm fixed price contract for routine maintenance services paid at the monthly rate below. These rates include all costs associated with providing routine preventive maintenance and emergency repair services including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit and VAT (if applicable). The contract will be for a one-year period, with four one-year optional periods of performance.

2.0 PRICING

2.1 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

DESCRIPTION/SPECIFICATION/WORK STATEMENT

1.0 SCOPE OF WORK

The U.S. Embassy Tbilisi requires the Contractor to execute preventive routine monthly maintenance services for CDC Office building, located at 9 Asatiani street. The Contractor shall provide all necessary managerial, administrative and direct labor personnel, and as well as all necessary transportation, equipment, tools, repair parts, supplies and materials required to perform inspection, maintenance, repair, and component replacement as required to execute preventive routine maintenance. Under this contract the Contractor shall provide:

- the services of a trained mechanic on a monthly basis to check and repair equipment operation and perform scheduled and preventive maintenance;
- 24 hours/day, 7 days/week emergency response service;

2.0 HOURS OF PERFORMANCE

The Contractor shall schedule all routine maintenance and repair work during normal building hours which are defined as 9:00 to 18:00 Monday to Friday, excluding local and bank holidays, unless approved in advance by the Contracting Officer's Representative (COR).

3.0 ACCESS TO GOVERNMENT BUILDINGS AND STANDARDS OF CONDUCT

3.1 General. The Contractor shall designate a representative who shall supervise the Contractor's mechanics and be the Contractor's liaison with the U.S. Embassy Tbilisi. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purposes.

3.2 Personnel Security. The Government reserves the right to deny access to U.S owned and U.S.-operated facilities to any individual. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall be used on this contract prior to their utilization.

3.3 Standards of Conduct

3.3.1 General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

3.3.2 Uniforms. The Contractor's employees shall wear clean and neat and complete uniforms when on duty. The Contractor shall provide, to each employee and supervisor, uniforms and personal equipment. The Contractor shall be responsible for the cost of purchasing, cleaning, pressing, and repair of the uniforms.

3.3.3 Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

3.3.4 The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

3.3.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances which produce similar effects.

3.3.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include but are not limited to the following actions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and misuse of weapons.

3.3.7 Key Control. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, or other areas, for the purposes of this contract. Keys shall not be duplicated without the COR's approval. Where the Government determines that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from performing work under the contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system so compromised.

4.0 WORK REQUIREMENTS

4.1 General. The Contractor shall provide full service to meet preventive routine and emergency maintenance and repair requirements. The Contractor shall maintain CDC office in a safe and efficient operating condition at all times. In the event of a break down or any malfunction, the Contractor shall make every effort to immediately return office space to an operating condition.

5.0 SCHEDULED PREVENTIVE ROUTINE MAINTENANCE

5.1 General

5.1.1 The objective of scheduled preventive routine maintenance is to eliminate or minimize any malfunction, breakdown and deterioration. Contract maintenance of the office space and equipment, listed in the SOW, must assure continuous, safe and satisfactory operation of the equipment, its parts and components. The Contractor shall schedule routine maintenance to include all tasks herein described.

5.1.2 The Contractor shall inventory, supply, repair and replace all parts that have become unsafe due to wear and tear. The Contractor shall use genuine manufacturer's parts or approved or equal (to be approved by COR) for all replacements. The Contractor shall maintain an easily accessible supply of spare parts sufficient for normal maintenance and expedient emergency repairs. All repair parts shall be provided by the contractor.

5.2 Reserved

5.3 Minimum Requirements - The Contractor shall provide a trained mechanic to inspect and service office space a minimum of once a month. The mechanic shall sign off on every item of the checklist. The mechanic shall leave a copy of this signed checklist with the COR or the COR's designate following that month's routine maintenance visit. This monthly inspection and servicing shall include, but not be limited to, the following tasks:

5.3.1. Electrical

The contractor shall perform the following electrical services:

- (a) Evaluate the operating condition and safety of all systems and equipment, including:
 - electrical outlets, switches, wiring, installed appliances, doorbells, intercoms, ceiling fans, light fixtures, water heaters, circuit breakers, fuse boxes and feed line connections.
- (b) Make basic repairs, including:
 - resetting circuit breakers or replacing fuses, fixing loose connections, replacing switches, replacing light bulbs etc.

The contractor shall provide all materials and supplies for maintenance and repair services. Neither purchase nor installation of any replacement or additional el fixtures are not covered under this contract.

5.3.2. HVAC (12 A/C split units and 1 heating system)

- (1) Operating the Heating/Ventilation/Air Conditioning(HVAC) systems according to the pertinent seasonal cooling/heating requirements as prescribed by the COR.
- (2) Providing seasonal (i.e. off-, pre-, and post-season) servicing on the heating and air-conditioning plant equipment.
- (3) Making insulation tests, adjusting relays, resetting circuit breakers, cleaning contact surfaces.
- (4) Making minor repairs to the systems and their equipment in accordance with scheduled and unscheduled work orders.
- (5) Inspecting pumps for abnormal temperature, vibration, noise, and other trouble symptoms, and adjusting as necessary.
- (6) Inspecting valves for restriction, leaks and other trouble symptoms, and adjusting as necessary.
- (7) Inspecting cooling towers, checking condition of cooling water, if dirty replacing with clean water. Cleaning strainers when replacing cooling water. Insuring that the water treatment equipment is properly working and that the water is being treated in accordance with manufacturer's recommendations.
- (8) Performing periodic cleaning, washing and/or replacing of all air filters for A/C, air handling and fan coil units at all properties. The terms "cleaning" means "dusting" where unwashable filters are used, "washing", where washable filters are used and "replacing" where unwashable/throwaway filters are used.
- (9) Inspecting all HVAC work including pipes, ducts, valves, dampers, fittings, waste water and sewer lines, traps, catch basins, toilet fixtures, downspouts, and gutters for clogging and loose joints, restrictions, leaks, and other faulty conditions; providing routine servicing such as retightening, caulking, lubricating, and performing first echelon maintenance. All supplies and equipment needed for the repairs shall be furnished by the Contractor.

All parts and supplies for maintenance and repair services shall be provided by the contractor. Neither purchase or installation of any additional equipment or main parts of equipment is not covered under this contract.

5.3.3. Generator Maintenance (1 generator)

1. If applicable, check oil heater for proper operation.
2. If applicable, check operation of engine block water heater.

3. Inspect all fuel, oil, and water piping for secure mounting, signs of leakage.
4. Check battery specific gravity and water level. Add distilled water as required.
5. Inspect battery trickle charger for proper operation.
6. Clean battery terminals and lugs, apply grease on connection points to prevent corrosion.
7. Check engine oil level.
8. Inspect condition of "V" belts and radiator hoses.
9. Inspect air filter service indicator. Green indicates OK, red indicates time to replace.
10. Replace fuel filters per manufacturer's recommended intervals.
11. Check fuel level in storage and day tank. Add as required.
12. Check water level in radiator. Add coolant as necessary.
13. Open fuel day tank drain valve. Drain off water and sediment.
14. Drain water and sediment from fuel line and filters. Re-prime the lines.
15. Drain water and sediment from water separator.
16. Automatically start unit and run under load for one hour. Follow manufacturer's recommendations for detailed procedures. Record results and gauge readings in logbook during test. Inspect all gauges and meters for proper operation. Recalibrate gauges and meters as required.
17. Check exhaust for excessive black or white smoke.
18. Check turbo charger for abnormal or excessive noise or vibration.
19. Inspect exhaust manifolds, mufflers and piping for leaks.
20. If applicable, insure that louvers on radiator and parent room ventilation grills are open, and that they are clean and free of obstructions.
21. Shut engine down. Return unit to service

All lubricants, antifreeze, filters, belts and any other routing maintenance parts and supplies shall be provided by the contractor.

Neither purchase nor installation of replacement or additional generator or main replacement parts are covered under this contract.

5.3.4. Plumbing:

Inspecting all plumbing work including pipes, ducts, valves, dampers, fittings, waste water and sewer lines, traps, catch basins, toilet fixtures, down-spouts, and gutters for clogging and loose joints, restrictions, leaks, and other faulty conditions; providing routine servicing such as retightening, caulking, lubricating, and performing first echelon maintenance.

Contractor shall furnish all parts and supplies for maintenance and repair services, including but not limited to valves, filters, gaskets, shower hoses etc.

Purchase and installation of any replacement or additional fixtures, water mixers etc. are not covered under this contract.

5.3.5. SAFETY EQUIPMENT SERVICES :

Inspecting all fire extinguishers and fire extinguishing systems (including halon gas), smoke and heat detectors in all communal areas once a month for proper operation and reporting the results

to the COR. The date of each inspection shall be stamped on the tag attached to each piece of equipment.

Replacement batteries shall be furnished by the contractor.

Replacement or additional equipment are not covered under this contract.

5.3.6 GENERAL MECHANICAL SERVICES

The contractor shall:

(a) Inspect and repair all doors, fences, grilles, gates, windows, sliding doors, doorstops, and interior fixtures, including door knockers, and pull cords, locks, hinges etc.

(b) Inspect and clean all vents, including kitchen, bathroom, and dryer vents.

All replacement parts except new locks shall be furnished by the contractor.

5.3.7 CARPENTRY SERVICES

(a) The Contractor shall inspect all:

- cabinets, closets, doors, moldings, panels, fixtures, furniture pieces, railings, risers in the office. Also, inspect all toilet paper holders, soap trays, towel racks, shower curtain rods, toilet seats, medicine cabinets, blinds, clothing rails, curtain rods, and any other like items.

(b) All necessary minor repairs shall be made to all items listed above, including:

- repairing, adjusting and/or replacing hinges, latches, closet rods, shelves, moldings and panels, cracks and chips, bathroom fixtures, curtain rods and blinds, and caulking and staining repaired areas to match the color.

All replacement parts and supplied for this repair shall be furnished by the contractor.

Cost of replacement or additional cabinets, blinds, drapes, fixtures is not covered under this contract.

5.3.8 MAJOR REPAIRS

The Contractor shall immediately inform the COR of any major safety problems and the need for major and/or specialized repairs to any part of the serviced area of the office space. The Contractor shall also inform the COR of a major problem in the office in a system or area that is not being serviced as well. The Contractor shall be liable for the costs for any damage that occurs as a result of the Contractor's negligence in its duty to inform the COR. The Contractor shall make efforts to minimize such trouble or damage in systems or areas being serviced until proper corrective action can be taken.

Major and specialized repairs shall be carried out by the Government, independent of this contract.

5.3.9 CONTRACTOR PERSONNEL

All personnel assigned by the Contractor for the performance of the respective services shall be regular employees of the Contractor, and shall be supervised by the Contractor. There shall be no employer-employee relationship between the Government and the personnel. Subcontractors may only be employed with the express written consent of the Contracting Officer.

5.3.10 QUALITY ASSURANCE

The Contractor shall institute an appropriate inspection system including:

- (a) Develop and maintain checklists of duties to be carried out,
- (b) Ensure these duties are carried out by the supervisory staff and senior employees, and
- (c) Perform inspections at all work locations to determine whether the various services are being performed according to the contract requirements.

The Contractor shall provide copies of all inspection reports to the COR.

The Contractor shall promptly correct and improve any shortcomings and/or substandard conditions noted in such inspections. The Contractor shall bring to the attention of the Contracting Officer or COR, for disposition, any conditions beyond the responsibility of the Contractor.

5.3.11 INSPECTION BY GOVERNMENT

The services performed and the supplies furnished for this contract will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

6.0 TROUBLE CALL RESPONSE SERVICE

6.1 General. The Contractor shall provide "around-the-clock" service coverage for trouble calls as described below

6.2 Emergency Response Service - The Contractor shall provide, at no extra cost, a 24 hours/day, 7 days/week, 52 weeks/year coverage for emergency trouble calls. A trained mechanic shall be "on call" and shall be on site within a four-hour time period of the placement of an emergency trouble call by the Contracting Officer or COR.

6.3 Non-Emergency Response Service - The Contractor shall provide, at no extra cost, a non-emergency response service. A trained mechanic will be on site, within one working day, to trouble shoot and repair any malfunction.

7.0 PERSONNEL, TOOLS, REPAIR PARTS, MATERIALS AND SUPPLIES

The Contractor shall provide trained mechanics with the appropriate tools and testing equipment for preventive scheduled maintenance, , emergency repairs/assistance, safety inspection, and safety testing as required by this contract. The Contractor shall provide all of the necessary repair parts, materials and supplies to maintain, service, inspect and test all equipment as required by this contract.

8.0 Reserved.

9.0 INSURANCE REQUIREMENTS

9.1 Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract

The Contractor's assumption of absolute liability is independent of any insurance policies.

9.2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, whatever insurance is legally necessary. The Contractor shall carry the following minimum insurance:

Comprehensive General Liability

Bodily Injury	5,000 USD per occurrence
Property Damage	20,000 USD per occurrence

10.0 Permits.

The Contractor shall maintain in full force and affect all permits, licenses, and appointments required for the prosecution of work under this contract at no additional cost to the Government. The Contractor shall obtain these permits, licenses, and appointments in compliance with host country laws.

11.0 LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to insure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the contract shall be payable by the Contractor without Government reimbursement.

12.0 Reserved

13.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP).

13.1 This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

13.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

13.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

13.4. Procedures.

13.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

13.4.2 The COR will complete appropriate documentation to record the complaint.

13.4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

13.4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

13.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

13.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

13.4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

13.4.8 Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.
