1.0 BACKGROUND

The first Georgia Compact was completed in April 2011. The \$395 million Compact focused on infrastructure (roads, water networks and energy rehabilitation) and rural private enterprise development through a grant program and an investment fund. One of the projects under the Compact, the Regional Infrastructure Development Project (RID), aimed at the water supply and wastewater systems in partial or full rehabilitation in five cities of Georgia (Poti, Kutaisi, Borjomi, Bakuriani and Kobuleti). These were complex projects funded by different donors like EBRD, World Bank, Swiss Development Corporation, Georgian Government, and others.

Planned investments by Millennium Challenge Corporation were mostly complete before April 2011, but the activities funded by other donors were still going on by the end of the first Compact. These activities were documented in an Interim Activity Review report, in February 2011. Subsequent to this report and after Compact completion, the Georgia United Water Company (UWC) completed many of the activities outlined in this report, such as the service connections to the newly renovated water supply and wastewater collection lines. In late September to early October 2013, an MCC international consultant will visit Georgia to assess and document the current status of RID projects relative to planned outcomes.

The Millennium Challenge Corporation requires consulting services to provide the following specific tasks as described below. All work under this contract will be prepared in English and all consultants proposed for the work must be fluent in both English and Georgian.

1.1. OBJECTIVE/SCOPE

The objective of this assignment is to perform the rapid performance assessment of RID projects (Kobuleti, Borjomi and Bakuriani) in close collaboration and under the guidance of MCC international consultant.

The Consultant can be based in Tbilisi, with frequent travel to the regions. Assignment should be performed in August-September, 2013 and will include desk-review of documents, meetings and interviews in Tbilisi, and travel to Kobuleti, Borjomi and Bakuriani.

1.2. TASKS

Task 1: Assessment Planning

Assist MCC consultant to collect and assess data for the rapid assessment.
(6 work-days)

Obtain and review current operational data and statistics from the United Water Company and the municipalities on Kobuleti, Borjomi and Bakuriani; including production data relative to quantity and quality of water supplied and quantity of wastewater collected. Data should be from the preceding year and include: general statistics listed below and be disaggregated based on tourist/high-season versus off-season where relevant. Information sources are to be documented including persons/title/date retrieved. Consultant should collect information on: Current population served by municipal source(s), with number of households and firms served; Continuity of service: average hours of service per day and number of days per week water is delivered; if service continuity is not uniform throughout the municipality, data should be broken out by zones; Residential and commercial tariffs; Tariff collection rates in the preceding year; Number of installed household meters; commercial meters; Operating cost coverage; Volume of

water produced, disaggregated per head-works; Residential water consumption; Industrial/Commercial water consumption; Non-revenue water; Water quality testing frequency, parameters tested, and summary stats on failure rates per parameter; Descriptive statistics on repairs and breakages for the water and wastewater networks; Quantity of wastewater collected.

Identify all projects started or completed for these water supply or wastewater systems after MCC Compact completion in these cities.

Deliverable 1: Data Collection Synthesis Report Prior to Field Inspection Mission

Task 2: Assistance During Site Visits and Report Preparation

(Field Visit, 7 days; Draft Report, 3 days; Final Report, 2 days; Total Task, 12 days)

Accompany MCC consultant on site visits to validate information received from UWC and to assess physical operating conditions of the RID water and sanitation infrastructure. Followup data collection as required.

1. Kobuleti Municipal Water Project

- A. Based on the information provided and subsequent field visits assess if water service connections has been made; old distribution system abandoned and some final project cleanup was done at the reservoir.
Get data on the production from the improved infiltration gallery; on the ability of the water supply system to meet peak summer demands; Information on current water supply production rates and water quality, as well as the number of services supplied by the system.
- B. Obtain information of the wastewater system, including completion and testing of three wastewater pump stations; Verify if proper types of wastewater pumps installed at PS2. Were plans implemented for proper handling and disposal of screenings at all 2 pump stations; Public health warning signs installed at all existing and potential raw sewage discharge locations.
- C. Obtain information on the wastewater treatment facility, including completion, provision of backup electrical power to the wastewater pump stations; assess if wastewater collection improvements have been planned or installed south of Kintrisha River.

2. Borjomi Municipal Water Project

- A. Based on the information provided and subsequent field visits assess operations and production rates of the new surface water supply intake and the Sadgeri infiltration gallery. Has the surface water supply intake been able to operate properly during cold winter months without freezing problems? Was shed and fencing installed at Gujareti intake for the headworks staff?
Verify overall water supply production rates and water quality and ability of the combined systems to meet peak demands.
Validate completion of all water supply service connections. Assess if water meters installed during service connections and are they operational.

Describe the current situation relative to the “upstream” village users of the old transmission pipeline, the new transmission pipeline, the KfW treatment works, and other issues along the supply route.

Describe operational plans for using surface water versus infiltration supplies.

- B. Provide current water treatment plant production rate and water quality data from new EBRD funded water treatment works. Check if public health warning signs been installed at all raw sewage discharge locations.
- C. On wastewater side, verify that all service connections have been completed and that old sewerage lines have been abandoned. This would include removing the old raw sewage discharge locations.

3. Bakuriani Municipal Water Project

- A. Based on the information provided and subsequent field visits verify operations and production rates of the new Kumiski surface water supply intake and the other existing springs. Has the surface water supply intake been able to operate properly during cold winter months without freezing problems? Was shed and fencing installed at surface water intake for the headworks staff? Verify overall water supply production rates and water quality and ability of the combined systems to meet peak demands. Validate completion of all water supply service connections. Were water meters installed during service connections and are they operational?

Describe operational plans for using surface water versus other spring water supplies.

- B. Provide current water treatment plant production rate and water quality data from new EBRD funded water treatment works.
- C. On wastewater side, verify that all service connections have been completed and that old sewerage lines have been abandoned. This would include removing the old raw sewage discharge locations.

- D. Provide report on all the above in the agreed format to the consultant.

The consultant will work in close coordination and consultation with MCC Consultant and with the MCC Resident Country Mission.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. (o) *Sanctioned activities relating to Iran.*

(1) The offeror shall e-mail questions concerning sensitive technology to the Department of State at CISADA106@state.gov.

(2) *Representation and Certification.* Unless a waiver is granted or an exception applies as provided in paragraph (o)(3) of this provision, by submission of its offer, the offeror—

- (i) Represents, to the best of its knowledge and belief, that the offeror does not export any sensitive technology to the government of Iran or any entities or individuals owned or controlled by, or acting on behalf or at the direction of, the government of Iran; and
- (ii) Certifies that the offeror, or any person owned or controlled by the offeror, does not engage in any activities for which sanctions may be imposed under section 5 of the Iran Sanctions Act.

(3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

- (i) This solicitation includes a trade agreements certification (*e.g.*, [52.212-3\(g\)](#) or a comparable agency provision); and
- (ii) The offeror has certified that all the offered products to be supplied are designated country end products.

The technical NRW results from leakages in the water distribution network. Commercial NRW could be due to reasons such as illegal water connections, insufficient household affordability to pay the received bills, and lack of an efficient database system by the utility.

Calculation: $NRW = 1 - (P/S)$ where:

NRW = Non Revenue Water

P = Paid Billed Volume by all customers

S = Supplied Volume

(WS-10) Operating cost coverage²

Units: Percentage

Definition: Total annual operational revenues divided by total annual operating costs.
