I. Scope of Services

- A. The Contractor shall provide and deliver high grade heating oil to the U.S. Embassy Government installations in Athens and Thessaloniki, as described in this solicitation. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, and transportation necessary to supply and deliver the heating oil to the U.S. Embassy Government installations in Athens and Thessaloniki. In consideration of satisfactory performance of all scheduled services required under this contract, the Contractor shall be paid a firm fixed-price for each delivery. The Contractor shall be compensated monthly upon receipt of a proper invoice for all deliveries made under delivery orders during the month.
- B. The contract type will be a fixed price with economic price adjustment indefinite-quantity/indefinite-delivery under which may be placed firm-fixed price delivery orders.
- C. The contract shall be for one year from the effective date of the contract, including two one-year options to renew.
- D. All prices are in Euros.

VI. Price Adjustment

a. The contract unit price per liter of heating oil will consist of two components – the current index rate and a margin inclusive of all contractor markups. The unit price is expressed as follows:

$$\text{Unit Price Per Liter} = \text{Current Index Rate} + \text{Contractor Margin (per 1000 liters)}$$

Index Rate: Contractor shall propose the current index rate(s) to be used for this contract and provide supporting documentation and website to verify the current index rate. This index rate shall be based on the current rate 1 day prior to the proposal due date. This rate will be used for purposes of calculating the total evaluate price.

The total unit price per liter of fuel will depend upon the individual delivery date, as the index rate fluctuates. The applicable index rate will be the rate in effect on the delivery date.

Contractor Margin: The Contractor Margin is fixed and includes all markups above the index rate. This includes, but is not limited to: delivery charge (including labor and transportation), overhead, profit, etc. The margin is fixed and will not fluctuate with changes to the index rate.

b. The Contractor may not request an adjustment under this clause after final payment has been made under this contract.

c. The U.S. Government will make no adjustments in contract price due to currency devaluations or fluctuations in exchange rates.

VII. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

VIII. DEFINITION:

Hellenic Petroleum price for G.O. 0.2%: The daily issued Hellenic Petroleum price is derived from:

(1) Past 4 day's avg PLATT's HI FOB MED Basis ITALY published in \$/MT for Gasoil 0.2% (including the invoicing/delivery date)

(2) Plus (+) 22.5\$/MT which represent the refinery premium

The sum of (1) + (2) times (x) USD-EUR past 4 days daily fixing parity (floating), times (x) 0.852 Gasoil 0.2% MT/M3 density factor (stable)

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

I. Scope of Work

For each year of the contract, the U.S. Government guarantees a minimum order of 5,000 liters of heating oil. The maximum amount of fuel ordered under each year of the contract shall not exceed 120,000 liters.

The minimum quantity of heating oil per delivery is 1,000 liters. It should be noted however, that there may be an occasion where the tank capacity of a residence is less than 1,000 liters. In such a case, the contractor will use a smaller truck to cover our requirements.

The Contracting Officer may issue oral orders that will be confirmed in writing.

The fuel provided will be high grade heating oil, sulfur 0.2% for the Greek territory. For supply and delivery of the fuel, the contractor shall be paid the fixed price per unit as listed above. This price is not to exceed any official rate, as set by laws enacted by the government of Greece.

II. Ordering:

The Embassy representative is responsible for calling the Contractor from 0900 am to 1500 pm Monday through Friday and from 0900 am to 1300 on Saturdays, and for placing order(s) mentioning the Building ID Number assigned by the U.S. Government, required quantity, date and time. The U.S. Government's representative will combine orders if possible, around the same directional route and hand them collectively to the Contractor.

The Contracting Officer is responsible for:

Orders

All requests for performance of individual jobs under this contract shall be issued via an order placed by the Contracting Officer. This task order will contain the following information:

- a. Supplier's Name
- b. Date of Delivery
- c. Task Order Number
- d. Property Address, Building Id Number (BIN), Resident's name or authorized person to accept delivery
- e. Quantity

Orders may be placed orally initially, but must be followed up in writing within 48 hours via issuance of a task order. Only a Contracting Officer may place an order, either orally or in writing.

III. Delivery:

The contractor shall deliver heating fuel by tanker truck. Delivery must be executed within 48 hours from the date placing the order, between the hours of 08.00 to 14.00 or between 14.00 to 20.00 hours, Monday through Saturday, except Sunday and all Greek holidays. In case of emergencies, the contractor shall deliver heating fuel within 24-hour advance notification, if requested.

The contractor agrees to schedule the specific time of delivery and notify the ordering office one day prior to actual delivery, so that a U.S. Government employee is present during delivery. No oil delivery will be accepted, if made 30 minutes before or 60 minutes after the scheduled time.

The contractor will have all equipment necessary to deal with any special circumstances, i.e., long hose, special wrenches, etc. Deliveries should always be performed according to mutually agreed safety standards.

Any contractor personnel involved with the delivery of the oil shall comply with the U.S. Government regulations for receiving supplies and should be courteous, and trained to communicate in English. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made and shall have the right to inspect the product at the time of delivery and to refuse to accept the product which is not properly marked. The driver of the tanker truck must provide a delivery ticket specifying quantity, location and date, at the time any delivery is made to the person receiving the product(s). The person receiving the product(s) will then write his/her full name, sign the delivery ticket, and retain one copy. If the driver attempts to short a delivery, the contractor agrees to remove him from any deliveries to Embassy housing, if requested. **In case of quantity discrepancy the U.S. Government's representative shall make a remark on the delivery ticket stating the actual quantity of heating fuel delivered (see also Invoicing).**

Damage to U.S. Government property caused by the contractor due to the fault or negligence during the life of this contract shall result in the contractor being held liable for repair or replacement thereof at the option of the U.S. Government.

In the event the contractor's personnel encounter any problems during deliveries, they must immediately contact the Embassy Representative at phone 210-720-2266.

IV. Guarantee and Environmental compliance:

- a. The contractor guarantees to furnish adequate protection from damage to U.S. Government property, grounds and/or equipment occurring on account of, or in connection with, or occasioned by, or resulting from the furnishing and delivery of fuel oil under this contract and shall be liable for any damages for which its employees are responsible.
- b. This liability includes but is not limited to oil spills occurring during delivery. The contractor shall provide constant surveillance during delivery by having a person in attendance at all times at the point of transfer.
- c. The contractor will have spill kits on hand upon all deliveries and take immediate spill recovery and containment actions required to protect the environment. All shall be done in accordance with all applicable Greek government laws and regulations.
- d. Contractor shall be liable for all oil/fuel spill recovery costs and all required reparations.

V. Invoicing:

The Embassy Accounting Department is responsible for:

- Ensuring that all transactions are properly authorized
- Processing payments for invoices on a timely basis to avoid late payment charges.

The electronic invoicing is the preferred means of submitting invoices. The contractor is encouraged to create and submit electronic invoices for this contract, in lieu of paper copies, to ATHFMCVOUCHER@state.gov. Electronic invoices shall be submitted to the designated billing office specified below.

The FMO will log in receipt of the invoice and forward to the COR for approval

Payment shall be made in local currency by Electronic Funds Transfer (EFT) within 30 days after receipt of the proper statement. Payments may be made directly to any bank account established by the Contractor to receive payments.

VI. COR Responsibilities:

In case of inaccuracies it shall be the COR who will interact with the Contractor on any invoice problems.

Invoices will be checked, matched with respective delivery tickets and order letter, and processed for payment to the Embassy's Finance Office. If delivery ticket is missing, the Contractor agrees to provide a copy, when requested. If the Embassy is unable to verify or electronically trace that a heating oil delivery has been ordered, the Contractor agrees that payment will not be processed and the invoiced quantity will be credited and added back to the heating oil held in the Embassy's name.

In case of quantity discrepancy the Government reserves the right to reject it as improper and return it to the Contractor within 15 calendars days. The Contractor must then issue a credit note for the quantity discrepancy and the U.S. Government will reimburse the Contractor **only** for the quantity received and noted in the remark.

VII. Key Personnel:

The Project Manager must be able to converse in English and Greek. The Contractor shall assign to this contract the following key person:

The Project Manager will be responsible for addressing broad contract issues and requests brought to them by the COR. The Project Manager must have the authority and competence to address and correct any issues related to the implementation and operation of the contract. The contractor shall notify the COR in writing fifteen (15) business days prior to the assignment of a new Project Manager.

VIII. Customs Duties, Taxes and Fees:

A. General

- a) The contract rates include all expenses incidental to delivery of the specified products (transit prices), exclusive of Greek Government customs duties and fees. The U.S Government will furnish to the contractor all documents required for clearance as soon as possible, free of customs duties, taxes and fees, of petroleum products under this contract. However, customs clearance formalities will be the contractor's responsibility.
- b) In the event the contractor experiences difficulties affecting such clearance, he should refer the matter promptly to the COR for resolution. However, should for any reason the contractor be required to pay such customs duties, taxes, or fees on any products to be delivered under this contract, an equitable adjustment in the contract price will be made to include the relevant charges.
- c) The U.S. Government is exempt from the payment of any taxes and duties and agrees to furnish to the contractor the relevant tax exemption clearance issued by the Ministry of Foreign Affairs for the bulk quantity to be needed during the performance period of the contract. Should, however, no exemption be granted or the exemption issued be curtailed, the U.S. Government agrees to reimburse the contractor with the amount of taxes and duties pertaining to the orders for which the exemption does not apply.

B. Procedures

Upon approval from the Ministry of Foreign Affairs, the U.S. Embassy will forward the duty exemption document to the contractor's customs broker along with the list of vehicles that the Embassy requests gasoline for and the undersigned protocol for duty free receipt/delivery.

An Embassy letter or e-mail is to follow placing an order with the delivery date and time to the Contractor for the quantity referenced on the Ministry of Foreign Affairs duty exemption document.

Upon delivery of products the Contractor must provide the U.S. Embassy with a copy of the "Declaration of Excise Tax & Other Taxation" form signed by the customs authorities stating the quantity for delivery and any remaining quantities cleared through Customs that are credited and available for future deliveries.

At no time should the Embassy run out of duty-free oil.

At the end of each contract year, the contractor shall provide the U.S. Government with a detailed list of the heating oil quantities delivered throughout the year, sorted by building ID.

IX. Price Adjustment:

- a) The unit price per liter of heating fuel may be adjusted based on increases or decreases in the official price of heating oil, mandated by the government of Greece.
- b) To request an adjustment in price, the Contractor must provide written notification of the price change(s) to the Contracting Officer at least once a week stating the price(s) that were effective during past week. The price changes are based on Hellenic Petroleum G.O. issued on a daily basis (see also Page 2). This notification must be accompanied by a copy of the official announcement of the price change, showing the new price and its effective date. The officer or general partner of the Contractor having overall responsibility for the Contractor's affairs shall certify the submission by written signature.

c) The U.S. Government will make no adjustment to the contract price that relates to any wages, overhead, fixed costs, general and administrative expenses, materials, or profit. Only the amount which is a direct result of an increase or decrease in the price of oil to be delivered under this contract shall be considered by the U.S. Government as the basis for contract price adjustments.

d) The Contractor may not request an adjustment under this clause after final payment has been made under this contract.

e) This clause shall only apply to laws enacted by the government of Greece which meet the criteria set forth above. The U.S. Government will make no adjustments in contract price due to currency devaluations or fluctuations in exchange rates.

(f) **QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(a) In accordance with section 7073 of Division K of the Consolidated Appropriations Act, 2014 (Public Law 113-76) none of the funds made available by that Act may be used to enter into a contract with any corporation that –

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government; or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
