## 特许豁免申请程序说明

### Notice for Waiver Application Procedure

1. 根据移民法的规定你不具备获取移民签证的资格，但是你可以通过提交特许豁免申请表格（I-601 表）申请获得豁免。I-601 表可以通过我们的网站获取，网址为：[http://guangzhou.usembassy-china.org.cn/waiver\\_of\\_grounds\\_of\\_inadmissibility.html](http://guangzhou.usembassy-china.org.cn/waiver_of_grounds_of_inadmissibility.html)。

**注意：**所有特许豁免的申请人必须同时提交“特许豁免申请表第二部分”，此表格也可通过以上网址获取。

You have been found ineligible for an immigrant visa under the Immigration and Nationality Act (INA), but you may apply for a waiver by submitting an Application for Waiver of Ground of Inadmissibility (Form I-601). Form I-601 may be accessed through the Consulate website at:

All individuals applying for waivers in Guangzhou also need to submit an “Application for Waiver Part II,” which may be accessed through the Consulate website at the address above.

（此项仅在选中时才适用）由于你曾被拒绝入境，驱逐或递解出境，你在提交 I-601 表以及“特许豁免申请表第二部分”的同时还要提交一份 I-212 表“驱逐或递解出境返美许可申请表”。I-212 表可以通过上述的网站获取。(only applies if the box is marked) In addition to the I-601 and the “Application for Waiver Part II,” you need to submit an Application for Permission to Reapply for Admission into the United States after Deportation or Removal (Form I-212), as you previously have been excluded, deported or removed from the United States. Form I-212 may be accessed through the Consulate website at the address given above.

2. 在您填好表格及准备好相关材料后，请带同您的护照于任何一个周五上午 8:30-10:30 (节假日除外)前往美国公民移民事务处驻广州办公室（地址为：广州市天河区林和中路 136-142 号天誉花园二期五楼）办理特许申请并缴纳 585 美金/人/份的特许申请费。When you have completed all the forms and gathered the relevant materials, please take them with your passport to the **U.S. Citizenship and Immigration Services (USCIS) Guangzhou office** (5<sup>th</sup> floor, 2<sup>nd</sup> annex of Tianyu Garden, 136-142, Linhe Zhong Road, Guangzhou) any Friday (except holidays) from 8:30 to 10:30 am. You must pay the waiver application fee of USD585 per person/application at the USCIS office.

3. 您到达美国公民移民事务处的等候大厅后，请按照工作人员的指引办理相关手续。When you arrive, please proceed to the USCIS waiting room, where USCIS personnel will provide you with further instructions.

4. 手续完毕后工作人员会告诉您回家等候。待美国公民及移民事务处驻广州办公室对您的特许申请作出答复后，本馆会去信与您再联系。请注意，离开美国公民及移民事务处时，请务必带走您的护照。After completing these procedures at the USCIS office, you may return home and wait for further notice. Our office will contact you by mail and provide you with instructions once we receive a response from the USCIS Guangzhou office regarding your waiver application. **Note:** Remember to take your passport when you leave the USCIS office.
