SUBJECT: Scope of Work of Carport at SCO HQ

1. Scope of Work:

The Contractor shall provide the minimum specifications of the work desired.

2. Project Concept:

Construction of carport extension at SCO/MILGP facilities, (Av Reforma 7a Calle "A" 7-01, Zona 10, next to guard booth and next to SCO HQ using the same materials of existing carport. New carport area must include lighting.

3. Project Specification:

The contractor shall provide all resources and personnel necessary to include but not limited to equipment, supplies, transportation, tools, materials, supervision, and other items, personnel and non-personnel services necessary to perform fabrication of roof with metal structures 10x5.60 mts next to guard booth and 3.20x5 mts next to SCO HQ, able to withstand strong wind, rain, sun damage. The construction will include vertical and horizontal beams that hold the roof in place. These beams will be painted with glossy black anticorrosive paint. The roof will consist of Duralita sheets. New carport area will include water channel and lighting in the same way of the existing roof (see enclosure 1).

4. The contractor shall accomplish all phases of this project and finish the final construction within sixty (60) days of the contract being awarded.

5. The contractor will be fully responsible for any damages to any property in the area to include vehicles and personnel due to negligence during the construction of the carport.

6. The Contractor shall handle, package, and dispose of any hazardous materials and trash in accordance with the laws of Guatemala.

7. The contractor shall allow for the thorough inspection of the carport and will be considered finished only when deemed satisfactory by SCO personnel.
