SUBJECT: MODIFICATION TO MILITARY GROUP PERIMETER WALL

1. Scope of work: The Contractor shall provide the minimum specifications of the work desired.
2. Project concept: Improve security on south wall, fence between the Security Cooperation Office (SCO) and Hotel Residencial Casa Grande.
3. Project specification:
  - a. Remove current razor wire and rebar support currently attached on the inside of the chain link fence (refer to attachment A).
  - b. Remove current chain link fence located on top of the perimeter wall.
  - c. Install new privacy screen chain link fence; Color: Grey. Sample of privacy chain link fence (attachment C).
  - d. Install two rows of razor wire (on top of each other – attachment B) with rebar supports on top of the new privacy screen chain link fence.
4. Trash and Disposal: The Contractor shall be responsible for the disposal of all the materials produced by this project. Contractor shall provide all resources and personnel necessary to include but not limited to equipment, supplies, transportation, tools, materials, supervision, and other items, personnel and non-personnel services necessary to perform the above.
5. The contractor will be fully responsible for any damages to any property in the area to include equipment, furniture and personnel due to negligence during the project.
6. Work schedule will be coordinated weekly with MILGP Duty Officer. Complete project will be completed in phases.
7. The contractor shall allow for the thorough inspection at completion of service and will be considered finished only when deemed satisfactory by SCO personnel.
