I. Scope of Work - The Contractor shall furnish **Replacement of 33 windows frames** in accordance with the terms and conditions set forth herein. The contract type will be firm-fixed price. The price listed below shall include all labor, materials, overhead, profit, and transportation.

II. Pricing - The Contractor shall provide the windows and installation package, including packaging and shipping to the destination set forth below in this Section 1. The prices listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, packaging and all local or federal taxes, if applicable.

I. SPECIFICATIONS

The purpose of this firm-fixed price contract is to obtain and install 33 Windows frames for the CMR, as per SOW (Scope Of Work).

Contractor Selection Criteria: Most technically feasible offer at the best price.

Period of Performance: To be determined

Place of Performance: Official Residence.

Architectural/Engineering Support: Contractor

Contracting Office's Representative: Facility Manager (COR)

Project Concept: The project involves the replacement of: 13 window frames in First Floor; 20 window frames in Second Floor.

The window frames shall comply with the following standards:

1. The framing shall have an external shape of white PVC reinforced with galvanized steel pipe inside.
2. Each frame will have locking latches to secure it. White handler and silver hinges.
3. Perfect seal between the frame and walls is required.
4. The frames will have outward movement for maintenance reasons.
5. The glass on each window will be clear and double pain to avoid noise pollution inside the house. Distribution 33.1 x 10 x 6
6. Each window shall include sill under like the ones showed on attached pictures (average wall thickness is 20 centimeters).
7. Each window shall have fix screen, using the same kind of PVC quality shapes, easy to remove for maintenance.
8. Contractor shall provide a written warranty of 5 years, including the warranty to provide spare parts for each window.
9. Provider shall have more than 10 years to be working in local market.
10. List with measures and comments are attached.
11. Embassy personnel will install Shatter resistant film before the glass is installed in the frames. Labor and film will be provided by the Embassy.

Deliverable Product:

The deliverable product for this project shall be 33 brand new PVC window frames as per specifications. COR inspection for fully SOW completion will be done prior to final acceptance and sign off.

Government furnished materials:

The Embassy won't provide any material for this project.

Contractor furnished materials:

The Contractor will provide labor, materials and equipment to finish this project successfully.

Trash and Disposal:

The Contractor shall be responsible for the disposal of all the materials produced by this project.

Test Plan and Acceptance:

Acceptance for completion of all tasks under this delivery order shall be based on the successful completion of tests, quality inspection, and Government sign-off by the COR on all items successfully completed as described in detail on all sections of this document.

Quality Control and Warrantee:

1. The Contractor shall perform quality work in accordance with this SOW and keep the COR informed at all times on all pertinent issues on progress and quality.
2. The COR reserves the right to inspect, propose, and rectify any quality issues on all work being performed.
3. While a quality control inspection can identify many obvious and immediate problems due to poor quality, it may be possible that some hidden or less obvious problems will manifest themselves only after a certain period of time. Therefore, the Contractor shall provide for a warrantee of their finished work that the Contractor performed for a period not less than one year from date of acceptance.
4. Any damages to U.S. property by the Contractor shall be replaced, repaired, or paid at Contractor's expense or deducted from their fees.

It is anticipated that Government review and comment/approval will be completed within two weeks of receipt of the drawings.

instructions required in Exhibit 2, Section 08667, paragraph \_\_\_\_ and Exhibit 3, Section 08318, paragraph 1.3.A.5. of this contract not later than 120 calendar days from Government approval of the submittals addressed in paragraph (a) above.
